PROPOSED DECISION

Claimants, JOHN CATHERINES, MARY CATHERINES and PERSA MOSKOS, who owned stock interests in Guantanamo Sugar Company, assert a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company.

In our decision entitled the <u>Claim of Henrietta Mae Siegel</u> (Claim No. CU-3478 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$49.7856.

On the basis of evidence in the record in the instant case, the Commission finds that these claimants come within the terms of the <u>Siegel</u> decision and that they were American nationals at the requisite times. Further, the Commission finds that JOHN CATHERINES and MARY CATHERINES have been the joint owners of 25 shares of Guantanamo stock and that MARY CATHERINES and PERSA MOSKOS have been the joint owners of 50 shares of Guantanamo stock, all since prior to August 6, 1960; and that JOHN CATHERINES and MARY CATHERINES suffered a loss in the amount of \$1,244.64; and MARY CATHERINES and PERSA MOSKOS a loss in the amount of \$2,489.28, within the meaning of Title V of the Act. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon ar the rate of 6% per annum from August 6, 1960, the date of - 2 -

CERTIFICATIONS OF LOSS

The Commission certifies that JOHN CATHERINES and MARY CATHERINES jointly suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of One Thousand Two Hundred Forty-four Dollars and Sixty-four Cents (\$1,244.64) with interest at 6% per annum from August 6, 1960 to the date of settlement; and

The Commission certifies that MARY CATHERINES and PERSA MOSKOS jointly suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of Two Thousand Four Hundred Eighty-nine Dollars and Twenty-eight Cents (\$2,489.28) with interest at 6% per annum from August 6, 1960 to the date of settlement.
