PROPOSED DECISION

HENRY M. HUNTER (now deceased), who owned a stock interest in Guantanamo Sugar Company, asserted a claim under Title V of the International Claims Settlement Act of 1949, as amended, against the Government of Cuba because of its nationalization of said Company. Subsequent to his death, EVELYN MERRIAM HUNTER was appointed Executrix of his Estate and is substituted as claimant herein.

In our decision entitled the Claim of Henrietta Mae Siegel (Claim No. CU-3478 which we incorporate herein by reference), we held that the properties owned by the Company were nationalized or otherwise taken by the Government of Cuba on August 6, 1960, and that this type of claim is compensable to an American national under the facts and conditions set forth therein. We need not again detail here the reasons or the method used in determining the value per share of \$49.7856.


On the basis of evidence in the record in the instant case, the Commission finds that this decedent came within the terms of the Siegel decision; that he was an American national at the requisite times; that he had been the owner of 25 shares of stock in the Guantanamo Sugar Company since prior to August 6, 1960; and that he suffered a loss in the amount of \$1,244.64 within the meaning of Title V of the Act; and that the Executrix of his Estate has succeeded thereto. Further, the Commission finds that the amount of loss sustained shall be increased by interest thereon at the rate of 6% per annum from August 6, 1960, the date of loss, to the date on which provisions are made for the settlement thereof. (See Siegel, supra.)


CERTIFICATION OF LOSS

The Commission certifies that EVELYN MERRIAM HUNTER, Executrix of the Estate of HENRY M. HUNTER, Deceased, succeeded to and suffered a loss, as a result of actions of the Government of Cuba, within the scope of Title V of the International Claims Settlement Act of 1949, as amended, in the amount of One Thousand Two Hundred Forty-four Dollars and Sixty-four Cents (\$1,244.64) with interest at 6% per annum from August 6, 1960 to the date of settlement.

NOTICE TO TREASURY: The above-referenced securities may not have been submitted to the Commission or if submitted, may have been returned; accordingly, no payment should be made until claimant establishes retention of the securities or the loss here certified.

The statute does not provide for the payment of claims against the Government of Cuba. Provision is only made for the determination by the Commission of the validity and amounts of such claims. Section 501 of the statute specifically precludes any authorization for appropriations for payment of these claims. The Commission is required to certify its findings to the Secretary of State for possible use in future negotiations with the Government of Cuba.
