

Executive Grant of Clemency

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS **SHOLOM RUBASHKIN** was convicted, in the United States District Court for the Northern District of Iowa on an indictment (Docket No. CR 08-1324-2-LRR) of multiple violations of Sections 193 and 195 (Counts 145 – 152, Counts 156 – 161, and Count 163), Title 7, and Sections 1014 (Counts 87 – 110), 1341 (Counts 125 – 133), 1343 (Counts 111 – 124), 1344 (Counts 73 – 86), and 1956 (Counts 134 – 143), Title 18, United States Code, for which a total sentence of 324 months' imprisonment; five years' supervised release; twenty-six million, eight hundred fifty-two thousand, one hundred fifty-two dollars, and fifty-one cents (\$26,852,152.51) restitution; and a special assessment of eight thousand six hundred dollars (\$8,600.00) was imposed on June 22, 2010; and

WHEREAS the said **SHOLOM RUBASHKIN** has been confined continuously since the pronouncement of sentence by the United States District Court for the Northern District of Iowa on June 22, 2010, and is presently incarcerated at the Federal Correctional Institution - Otisville in Otisville, New York; and

WHEREAS it has been made to appear that the ends of justice do not require the said **SHOLOM RUBASHKIN** to remain confined until his currently projected release date of March 5, 2033, and the safety of the community will not be compromised if he is released;

NOW, THEREFORE, BE IT KNOWN that I, **DONALD J. TRUMP**, President of the United States of America, in consideration of the premises, divers other good and sufficient reasons me thereunto moving, do hereby grant clemency to the said **SHOLOM RUBASHKIN**: I commute the prison sentence imposed upon the said **SHOLOM RUBASHKIN** to time served. I leave intact and in effect the remaining unpaid balance of the \$26,852,152.51 restitution, the special assessment of eight thousand six hundred dollars (\$8,600.00), the five-year term of supervised release with all its conditions, and all other components of the sentence.

I HEREBY DESIGNATE, direct, and empower, the Acting Pardon Attorney, as my representative, to deliver to the Bureau of Prisons, to the United States District Court for the Northern District of Iowa, and to the said **SHOLOM RUBASHKIN** a certified copy of this document as evidence of my action in order to carry into effect the terms of this grant.

I ALSO DIRECT the Bureau of Prisons, upon receipt of this warrant, to effect the immediate release of the said **SHOLOM RUBASHKIN** with all possible speed.
