## Deployments

### Kootenai Tribe of Idaho Completes TAP LIGHT Deployment

On June 5 and 6, Kootenai Chief of Police Minor and his force received training from TAP's Jose Primera and Michael LeMieux on how to access and enter information using TAP Light.

### Nez Perce Tribe Completes TAP LIGHT Deployment

On June 7, 22 representatives from Nez Perce courts, probation and prosecutor's office attended the TAP deployment. Twelve of those individuals received training on Open Fox Messenger (OFM). One misdemeanor arrest warrant was successfully entered into the National Crime Information Center system.

### The Choctaw Nation of Oklahoma Completes TAP FULL Deployment

The rollout began on June 19, when TAP personnel arrived onsite to complete system setup. June 20 began with a presentation to over 50 people representing Choctaw tribal leadership, law enforcement and civilian services. The mid-day session gave additional detail on how TAP could be used by the Tribe, including access to other law enforcement systems. The officers assigned to conduct fingerprint-based checks for civilian agencies were trained in afternoon sessions. Introductory OFM training was provided to the on-duty dispatchers. Additional OFM training was presented to a core group of dispatch personnel and court personnel, who will be responsible for entering and querying OFM.



## **COPS Corner**

### **COPS Releases New Publication on Cross-Deputization in Indian Country**

Jurisdiction in Indian country is complicated by laws, policies, and court decisions, making it difficult for law enforcement to address many criminal offenses. Recent changes in tribal, federal, and state law have enabled tribal law enforcement to enforce a broader array of state and federal crimes by cross-commissioning and cross-deputizing their officers. This report, based on the work of the National Sheriffs' Association (and their cross-deputization advisory panel) examines the jurisdictional and legal limits of cross-deputization and how it has been implemented by law enforcement agencies in Indian country. ## **SMART Sense**

### **Sex Offenders and Reentry into Tribal Communities Webinar**

Focus of training: Title I of the Adam Walsh Child Protection and Safety Act of 2006, the Sex Offender Registration and Notification Act (SORNA), created the first opportunity for federally recognized Indian tribes to be included in a nationwide sex offender registration and notification system. Hosted by the American Probation and Parole Association, SMART Senior Policy Advisor Marnie Dollinger and Michelle Rivard Parks, Associate Director, Tribal Judicial Institute, University of North Dakota School of Law present on the following:

- A brief introduction to SORNA;
- Implications of including Tribes under the Act;
- Impact of SORNA on tribal reentry efforts;
- Fundamentals of reentry programming;
- Factors to consider when a convicted sex offender is released from incarceration and returns to a tribal community;
- How SORNA has affected the need for multi-jurisdictional collaboration and coordination of reentry initiatives, especially when individuals are being released from non-tribal facilities and returning to tribal communities; and
- A view from the field on the success and challenges of implementing SORNA.

## National Missing & Unidentified Persons System -Improved and Available to Registered Law Enforcement Agencies

Did you know the Office of Justice Program's National Institute of Justice, the Department of Justice's research, development and evaluation agency, has an online, centralized set of databases to help identify missing and unidentified persons? The [National Missing and Unidentified Persons System](#) – or “NamUs” – makes connections between records of unidentified human remains and missing persons reports.

Free and available to the public, NamUs helps investigators resolve cases that have remained unsolved for decades. A recent upgrade to NamUs includes enhancements that allow investigators to collect, search and analyze entries from tribal law enforcement agencies registered for and using the system.

### Violence Reduction Response Center

The Bureau of Justice Assistance launched the Violence Reduction Response Center (VRRRC), giving you direct access to expert staff who can connect you to the most relevant training and technical assistance from the Department of Justice. VRRRC helps state, local, and tribal law enforcement, U.S. attorneys, and criminal justice practitioners respond to agency- and situation-specific crime reduction needs. ### Project Safe Neighborhoods

Project Safe Neighborhoods (PSN) is designed to create and foster safer neighborhoods through a sustained reduction in violent crime, including, but not limited to, addressing criminal gangs and the felonious possession and use of firearms. The program's effectiveness depends upon the ongoing coordination, cooperation, and partnerships of local, state, tribal, and federal law enforcement agencies—and the communities they serve—engaged in a unified approach led by the U.S. Attorney (USA) in all 94 districts. Acting decisively in a coordinated manner at all levels—federal, state, local, and tribal—will help reverse a rise in violent crime and keep American citizens safe. PSN provides the critical funding, resources, and training for law enforcement, prosecutors, and their PSN teams to combat violent crime and make their communities safer through a comprehensive approach to public safety that marries targeted law enforcement efforts with community engagement, prevention, and reentry efforts. **Applications are due July 19, 2018.** For more information, visit <https://www.bja.gov/PSNFormula18>.

### Student, Teachers and Officers Preventing (STOP)

The Student, Teachers, and Officers Preventing School Violence Act of 2018 authorized BJA to manage a grant program that would support efforts by state and local units of government and federally recognized Indian tribes to prevent and reduce school violence. Specifically, the BJA program will address: (1) training school personnel and educating students to prevent student violence; (2) development and operation of anonymous reporting systems concerning threats of school violence, including mobile telephone applications, hotlines, and websites; and (3) development and operation of school threat assessment and crisis intervention teams that may include coordination with law enforcement agencies and school personnel. In addition, the program may fund specialized training for school officials in intervening and responding to individuals with mental health issues which may impact school safety. This solicitation specifically seeks applications that address training school personnel and educating students to prevent student violence and training school officials in responding to related mental health crises. **Applications are due July 23, 2018.** For more information, visit <https://www.bja.gov/SSVtraining18>.

### Global Justice Information Sharing Initiative (Global)

DOJ's Global Justice Information Sharing Initiative is designed to engage the full range of criminal justice policymakers and practitioners in the development of innovative strategies to improve the justice information sharing (JIS) and technology capabilities of state, local and tribal agencies. In order to be effective, Global's approach requires training and technical assistance (TTA) to adequately engage stakeholders; facilitate working groups and task teams; develop products and publications; and offer implementation support to the field. The FY 2018 Global solicitation is designed to enhance Global's ability to achieve its goals through the provision of TTA support. ### FY 2018 National Officer Safety Initiatives Program

Law enforcement officer safety is a Department of Justice priority. In support of the President's Feb. 9, 2017, officer safety-focused Executive Order, this BJA National Officer Safety Initiatives Program is soliciting innovative approaches to augment law enforcement safety in three key areas: law enforcement suicide, traffic safety, and a national public awareness and education campaign. **Applications are due July 2, 2018.** For more information, visit <https://www.bja.gov/NOSI18>.

## Tribal Civil and Criminal Legal Assistance Grants, Training, and Technical Assistance (TCCLA)

The TCCLA Program provides civil and criminal legal assistance to low-income individuals, Indian tribes, and tribal justice systems, and provides quality training and technical assistance (TTA) to TCCLA grantees and Indian tribes to support the development and enhancement of tribal justice systems and access to those systems. TCCLA resources are important as tribes begin to implement new authorities such as enhanced sentencing authority (referred to as “felony sentencing authority”) (25 U.S.C. §1302, et seq.) or opt into exercising the “special domestic violence criminal jurisdiction” (referred to as “extended jurisdiction”) (25 U.S.C. §1304, et seq.) for the protection of due process rights, such as the right to counsel for indigent defendants.

### Officer Sanctioned for Illegal Use of Information

New Jersey Trooper Eric Richardson pleaded guilty to illegally using an FBI database to obtain personal information about a motorist. A friend of Richardson's asked him to do a "driver inquiry" on a woman the friend employed to see if her driver history revealed any warrants or drug activity. Prosecutors will recommend that Richardson receive a probation term when he's sentenced in August.
