Dear Commissioners:

We again want to express our appreciation for your tireless work and many important contributions to the work of the Commission.

As you know, the Commission is tasked with delivering a report for the Attorney General and the President. Each of you and your Working Groups and staff have worked to draft portions of that report, including recommendations. I have attached the final group of draft chapter submissions for your review. You previously received the first two sets of chapters with instructions on completing your review in the email thread below. **We are asking to receive feedback and comments for all 15 chapters by COB Thursday, July 9.** The vast majority of working groups have completed their work for the time being, but stand ready to respond to your comments and feedback on each chapter.

As you read these chapters, please keep in mind that these chapters are still in draft form, and will be updated as we continue to receive testimony. I would ask that you read these documents with an eye for content and substance to ensure there are no gaps in the material covered, that recommendations are included, and that important topics aren't omitted. Some editing steps (grammar and style checks, fact and citation checks and layout editing) have not been completed so you will not have to make those types of edits.

As you conduct your review, please use the track changes and comments functions (both are accessible from the Review tab in MS Word) so that the Commission staff can incorporate them. When you have finished, you can send your documents to LECommission@usdoj.gov.
