Macedonia: Treatment of members of the Internal Macedonian Revolutionary Organization-Democratic Party for Macedonian National Unity (Vnatrešna Makedonska Revolucionerna Organizacija - Demokratska Partija za Makedonsko Nacionalno Edinstvo, VMRO-DPMNE), including treatment of their families (January 2005 - December 2005)

Information on the general treatment of members of the Internal Macedonian Revolutionary Organization-Democratic Party for Macedonian National Unity (VMRO-DPMNE) was scarce among the sources consulted by the Research Directorate.

A mention of the VMRO-DPMNE relating explicitly to its members appeared in an uncorroborated 19 April 2005 article by Radio Free Europe/Radio Liberty (RFE/RL), in which it was reported that the party's chairman, Nikola Gruevski (*Political Parties of the World* 2005, 391; RFE/RL 19 Apr. 2005), had announced a review of membership lists (ibid.). The goal of the six-week long review was to "purge the VMRO-DPMNE of members who [were at the time] also members of other parties, especially of the rival VMRO-NP [VMRO-People's Party]" (ibid.). According to RFE/RL, when the VMRO-NP broke away from the VMRO-DPMNE, new members of the former did not want to give up their membership in the latter, since they wanted to retain their parliamentary seats (ibid.). However, further details on the outcome of Gruevski's review could not be found within time constraints.

In February 2005, the International Crisis Group (ICG) indicated that there remained only 10 Members of Parliament of the VMRO-DPMNE out of the party's original 28 parliamentary seats: on 18 January 2005, twelve members of the VMRO-DPMNE joined the VMRO-NP, another five became independents (ICG 25 Feb. 2005), and an additional member, Ljube Boskovski, was in detention in Croatia, having been charged with the 2002 killing of persons "falsely alleged" to be "Islamic terrorists" (ibid.; HRW 13 Jan. 2005). Boskovski, who had formerly been Macedonia's Interior Minister (ibid.; AFP 10 May 2005; Makfax 4 Oct. 2005), was later indicted for war crimes against ethnic Albanians and, in March 2005, transferred to The Hague where he is to be detained until his trial at the United Nations War Crimes Tribunal (AFP 10 May 2005; MIA 18 July 2005) in June 2006 (Reuters 12 Dec. 2005).

The VMRO-DPMNE is a "conservative" party (RFE/RL 19 Apr. 2005) and is the main opposition party in Macedonia (ibid.; ICG 25 Feb. 2005; ERWI 1 Aug. 2005). VMRO-DPMNE candidates won 21 out 84 mayoralty contests (RFE/RL 19 Apr.

2005). According to *Europe Review World of Information* (ERWI), the next parliamentary elections in Macedonia will take place in 2006 (1 Aug. 2005).


