UPDATED INVITATION—New Location for Juneau Consultation Session

Dear Tribal Leader:

We are writing to provide an updated location for the Tribal consultation session scheduled for September 22, 2026, in Juneau, Alaska (information below). This consultation will focus on the results of the Alaska Pilot Program authorized by the Violence Against Women Act Reauthorization Act of 2022 (VAWA 2022), including any modifications to law necessary to facilitate improved law enforcement in Alaska Native Villages. The Tribal views received during this consultation will be included in a report to Congress, as mandated by VAWA 2022. *See* 25 U.S.C. § 1305(h). A framing paper providing additional background information and outlining issues for discussion accompanies this letter.

Please note that the Tribal consultation will be closed to the press to protect confidential information that may be discussed during the sessions.
