### **2010 Performance Plan**

The Department continues to improve its key performance measures, which are displayed below, and track the progress of its long-term performance goals. The Department's long-term performance goals reflect results, not just workload or processes. For example, we have focused law enforcement efforts on disrupting and dismantling targeted criminal groups, such as major drug trafficking organizations. In areas such as litigation, where results-oriented measurement is particularly difficult, we continue to reevaluate our long-term targets to ensure that we are being aggressive enough in our goals for case resolutions for all of our litigating divisions.

Success for the Department is highlighted when justice is served fairly and impartially and the public is protected. In many cases, our efforts cannot be reduced to numerical counts of activities. Additionally, trying to isolate the effects of our work from other factors that affect outcomes over which the Department has little or no control presents a formidable challenge. Many factors contribute to the rise and fall of crime rates, including federal, state, local and tribal law enforcement activities and sociological, economic and other factors. As a result, we have focused on more targeted measures of programmatic performance.

In November 2007, *Executive Order 13450: Improving Government Performance* established the Interagency Performance Improvement Council. The Council meets monthly with Agency Performance Improvement Officers (PIO) to share best practices and ideas regarding performance measurement and improvement. The Department of Justice's (DOJ) Deputy Assistant Attorney General for Administration/Controller is the PIO for the Department. The DOJ PIO supervises and coordinates the performance management activities of the agency; works to improve program and agency goals; develops and improves agency strategic plans, annual performance plans and annual performance reports; and regularly convenes agency personnel to assess and improve program performance and efficiency.

In February 2008, the Department's PIO established the DOJ Performance Improvement Officer's Panel. The Panel is comprised of DOJ-wide senior level staff with the authority to review and recommend changes to performance measurement in their respective organizations. Panel membership consists of representatives from the Justice Management Division's (JMD) Budget Staff, Finance Staff, Management and Planning Staff, representatives from the Office of Boards and Divisions; and one representative from each DOJ component.

<u>FY 2008 Revised Actual</u>: This data was initially reported in the Department's FY 2008 Performance and Accountability Report November 15, 2008; however, it has been revised to accurately reflect final FY 2008 accomplishments.

<u>FY 2009 Revised Target</u>: Targets for FY 2009 were initially set with the submission of the FY 2009 President's Budget. Following the reporting of FY 2008 actual performance and the FY 2009 enacted budget, the Department is submitting its final (and in some cases revised) FY 2009 targets within this performance plan.

- 1 This new measure replaces the former measure: "Number of child pornography websites or web hosts shut down" due to an OMB-led program review in the Spring of 2008.
- 2 For DOJ's performance measure: DOJ's reduction in the supply of illegal drugs available for consumption in the U.S. (Establish Baseline by end of FY 2009) [OCDETF]: Measuring reduction in the drug supply is a complex process reflecting of a number of factors outside the control of drug enforcement. Moreover, the impact of enforcement efforts on drug supply and the estimated availability are currently not measurable in a single year. DOJ is working to develop a meaningful baseline for the supply of drugs available for consumption in the U.S. during FYs 2007-2009. Once a meaningful baseline is established, the Department expects to achieve a 6% reduction (2% each year) in the supply of illegal drugs from FYs 2010-2012.
