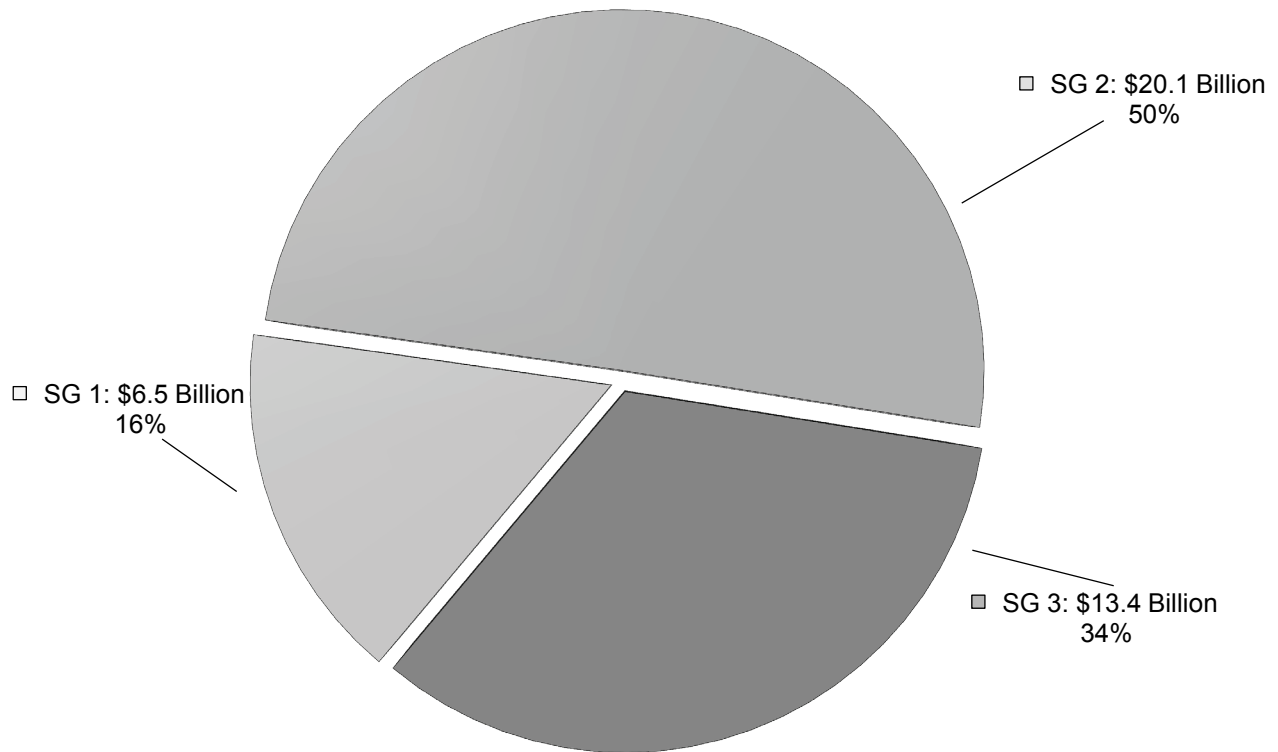


**FY 2017 BUDGET REQUEST BY STRATEGIC GOAL**
