FY 2017 Budget Request At A Glance

Mission:

DEA's mission is to enforce the controlled substances laws and regulations of the United States and bring to the criminal and civil justice system of the United States, or any other competent jurisdiction, those organizations and principal members of organizations involved in the growing, manufacture, or distribution of controlled substances appearing in or destined for illicit traffic in the United States; and to recommend and support non-enforcement programs aimed at reducing the availability of illicit controlled substances on the domestic and international markets.

Resources:

The FY 2017 budget request for DEA totals \$2,103 million, which is a 1.1% increase over the FY 2016 Enacted.

Organization:

DEA is headed by an Administrator and Deputy Administrator who are both appointed by the President with the advice and consent of the Senate. DEA operates 221 Domestic Offices, organized into 21 Domestic Field Divisions. DEA also operates 89 foreign offices in 68 countries.

Personnel:

DEA's direct positions for FY 2017 total 8,355 positions. DEA's FY 2017 request includes an increase of 53 positions over the FY 2016 Enacted of 8,302 direct positions.

FY 2017 Strategy:

DEA continues to prioritize its resources to disrupt and dismantle the "most wanted" drug trafficking and money laundering organizations believed to be primarily responsible for the nation's illicit drug supply. This includes the Consolidated Organizational Priority Targets (CPOTs) identified by DOJ, plus other Priority Target Organizations (PTOs) identified by DEA. DEA also places a high priority on its efforts to prevent drug proceeds from ending up in the hands of terrorist organizations.

Intelligence activities and information sharing will continue to play an important role in DEA's enforcement efforts in FY 2017, as will large-scale, multi-agency enforcement operations. The Special Operations Division (SOD) is the backbone of DEA's coordination efforts through its support of multi-jurisdiction, multi-nation, and multi-agency wire intercept investigations, which attack the command and control communications of drug trafficking organizations. Additionally, the El Paso Intelligence Center (EPIC) is a vital resource for federal, state, and local law enforcement.

DEA will continue to focus on the financial infrastructure of drug trafficking organizations. From FY 2005 through FY 2015, DEA denied drug traffickers a cumulative total of \$33.1 billion in revenue through the seizure of both assets and drugs which includes FY 2015 seizures worth \$3.5 billion.

Internationally, DEA's cooperative partnerships with foreign nations help these nations develop more self-sufficient and effective drug law enforcement programs within those partner nations. As part of this collaboration, DEA provides training to its foreign counterparts. DEA also works with foreign counterparts to stand up and train vetted units of foreign law enforcement officers with whom DEA works and shares information.

Although CPOTs and PTOs operate around the world, DEA has placed a special emphasis on Mexican drug trafficking organizations because they control the smuggling of drugs into the United States, as well as drug distribution in most U.S. cities. In addition to the significant drug trafficking threats in the Western Hemisphere, DEA is making efforts to address other international drug trafficking threats that affect U.S. interests. DEA is particularly concerned with emerging threats in Africa, which is used as a transshipment point by both South American and Southwest Asian organizations.

DEA's Diversion Control Program (DCP) is tasked with preventing, detecting, and investigating the diversion of controlled substances and listed chemicals. Through the DCP, DEA regulates more than 1.58 million registrants who handle, dispense, or prescribe controlled substances or listed chemicals (e.g., manufacturers, distributors, practitioners, researchers, importers, and exporters). This is a population of registrants that grows at an average rate of nearly three percent per year. DEA's Tactical Diversion Squads (TDS) are dedicated to investigating, disrupting, and dismantling individuals and organizations involved in drug diversion schemes. They combine the expertise of diversion investigators, special agents, and task force officers from various state and local law enforcement and regulatory agencies.

FY 2017 Program Changes:

SALARIES AND EXPENSES

Cyber Security and Insider threat: \$7.6 million and 11 positions (3 agents)

Requested funding will establish an insider threat program as mandated by Executive Order 13587, as well as to build and sustain additional capability and capacity to monitor DEA's increasingly large and complex classified and sensitive information system resources from threats that could degrade DEA operations. This initiative includes \$1.5 million for Continuous Evaluation per the Office of the Director of National Intelligence (ODNI) Director Decision Document (DDD). There are no current services for this initiative.

Heroin Enforcement: \$12.5 million and 42 positions (32 agents)

Requested funding will create four new enforcement groups, including support personnel and operational funding, to counteract growing heroin abuse and availability in the United States. There are no dedicated current services for heroin enforcement groups in FY 2017.

Program and/or Administrative Savings: -\$12.2 million and 0 positions

Reductions to existing operations and support functions to pay for increases in existing costs, including pay raises, FERS contributions, and GSA rent, among others. Program and administrative reductions to be identified once funds are appropriated.

Rescission – DEA S&E: -\$6.2 million and 0 positions Unobligated Balances Rescission.

DIVERSION CONTROL FEE ACCOUNT (DCFA)

Diversion Control Program (DCP): \$8.9 million and 55 positions (10 agents)

Requested funding will support the disruption and dismantlement of the individuals and organizations responsible for the illicit manufacture and distribution of pharmaceutical controlled substances in violation of the Controlled Substances Act (CSA). Current services for this program are 1,597 positions and \$373.8 million.
