Mission:

The Community Relations Service provides assistance to state and local communities in the prevention and resolution of tension, violence, and civil disorders relating to actual or perceived discrimination on the basis of race, color, national origin, gender, gender identity, sexual orientation, religion, or disability. In FY 2020, to improve efficiency, these activities will be transferred to the Civil Rights Division (CRT), which has responsibility for enforcing all civil rights matters and for conferring with individuals and groups who call upon the Department of Justice in connection to civil rights matters.



The FY 2020 budget request proposes eliminating funding for CRS and funding its functions within CRT.

Organization:

CRS is headed by a Director, who is appointed by the President and confirmed by the Senate. CRS has 10 regional offices and 4 field offices across the United States.

Personnel:

The CRS's direct positions for FY 2020 total 0 positions. CRS's FY 2020 request includes a decrease of -54 positions from the FY 2019 Continuing Resolution of 54 direct positions.
