FY 2022 Budget Request At A Glance

FY 2021 Enacted: \$734.0 million (3,761 positions; 1,611 attorneys)

Mission:

The primary mission of the Executive Office for Immigration Review (EOIR) is to adjudicate immigration cases by fairly, expeditiously, and uniformly interpreting and administering the Nation's immigration laws. Under delegated authority from the Attorney General, EOIR conducts immigration court proceedings, appellate reviews, and administrative hearings.

Organization:


EOIR administers the Nation's immigration court system. EOIR primarily decides whether foreign-born individuals charged by the Department of Homeland Security (DHS) with violating immigration law should be either ordered removed from the United States or granted relief or protection from removal and allowed to remain in the country. To make these critical determinations, EOIR's Office of the Chief **Immigration** Judge conducts administrative proceedings in 70 immigration courts and adjudication EOIR's appellate component, the centers nationwide. Board of Immigration Appeals (BIA), is the highest administrative body for interpreting and applying U.S. immigration law. EOIR's third adjudicative component, the Office of the Chief Administrative Hearing Officer, hears cases in employer sanctions and document fraud cases under the Immigration and Nationality Act of 1952. EOIR also has Headquarters offices that provide mission support functions.


Resources:

The FY 2022 budget request for EOIR totals \$891.2 million, which is a 21.4 percent increase over the FY 2021 Enacted.

Personnel:

EOIR's direct authorized positions for FY 2022 total 4,361 positions, including an increase of 600 positions over the FY 2021 Enacted of 3,761 direct authorized positions.





FY 2022 Strategy:

EOIR's immigration courts represent the Department's front-line presence in applying immigration law. Immigration cases typically begin when DHS files a Notice to Appear, which charges a potential undocumented noncitizen with a violation of Federal immigration law and seeks the removal of that individual from the United States. It remains critically important that EOIR have sufficient adjudicative resources to keep pace with DHS' enforcement efforts.

The largest challenge facing the immigration courts is the growing pending caseload. At the end of the FY 2020, there were over 1.3 million active cases pending in immigration courts nationwide. EOIR's FY 2022 strategic focus is to increase adjudicatory and case processing capacity in a fair, expeditious, and uniform manner to reduce the pending caseload. In addition to EOIR's continued focus on hiring all authorized positions to fill existing vacancies, EOIR is continuing ongoing efforts to maximize existing resources and eliminate agency inefficiencies. These ongoing efforts include making docket adjustments to reflect enforcement priorities, developing and implementing a workforce-staffing model, opening new courts, leveraging existing IT systems, emphasizing policy coordination and analysis, and making the Immigration Judge hiring process more efficient.

FY 2022 Program Changes:

Immigration Judges and Support: \$106.8 million and 600 positions (300 attorneys)

This increase will enable EOIR to add 100 additional immigration judges (IJs) and necessary support staff. This program increase includes funding for the necessary corresponding courtrooms, office space, and associated expenses (e.g. interpreter services, furniture, equipment, and funding for guard services). Each IJ is supported by one attorney position, one legal assistant, and up to two other FTE comprised of a combination of the following positions on an as-needed basis: additional legal assistant, interpreter, or other EOIR mission support staff. Some support positions may also go to headquarters to support the growth of immigration courts. EOIR is also requesting 100 additional attorney advisor positions, to support IJs or appellate IJs. Due to the robust IJ hiring process and the six- to twelvemonth timeline for new IJs to begin hearing cases at a rate as efficiently as experienced IJs, this program increase will not affect performance immediately but rather over the course of the next several years. However, with a sustained commitment to increasing the number of IJs and the number of IJ support staff including attorneys, EOIR will be able to decrease the pending caseload and reduce the amount of time respondents must wait until their case is heard. FY 2022 current services for this program are 3,761 positions (1,611 attorneys) and \$728.7 million.

Backlog Reduction Efficiencies: \$55.6 million and 0 positions

This increase provides several EOIR efficiency initiatives designed to help reduce the over one-million case backlog. Some examples include: funding for transcription services and contractor support at the Board of Immigration Appeals to enable it to address its pending appellate backlog; the start of a multi-year scanning project to begin scanning pending paper files into electronic Record of Proceeding providing for greater flexibility among IJs and support staff to adjudicate cases from any location; and other efficiency efforts designed to reduce the large and growing pending caseload. FY 2022 current services for this program are 3,761 positions (1,611 attorneys) and \$728.7 million.
