STIPULATION

WHEREAS, Plaintiffs, the United States of America and the State of Alabama, filed their Complaint, Asset Preservation Stipulation and Order, and other documents on March 31, 2021;

AND WHEREAS, the State of Tennessee would like to join as a plaintiff in this matter;

AND WHEREAS, the United States will bring an unopposed motion for leave to file an

Amended Complaint to join the State of Tennessee as a plaintiff in this matter;

NOW THEREFORE, the State of Tennessee hereby stipulates as follows:

The State of Tennessee stipulates that its joining as a plaintiff does not change the status of this matter, as it agrees to the settlement and is satisfied that the settlement will remedy the anticompetitive effects alleged in the Amended Complaint.

The State of Tennessee also stipulates that a Final Judgment in the form attached to the March 31 Asset Preservation Stipulation and Order as Exhibit A (Dkt. No. 2-2) may be filed with and entered by the Court, upon the motion of the United States or upon the Court's own motion, after compliance with the requirements of the Antitrust Procedures and Penalties Act (15 U.S.C. § 16), and without further notice to any party or other proceedings, provided that the United States has not withdrawn its consent, which it may do at any time before entry of the proposed Final Judgment by serving notice thereof on Defendants and by filing that notice with the Court.

The State of Tennessee further stipulates that entry of the proposed Final Judgment will terminate this action, except that the Court will retain jurisdiction to construe, modify, or enforce the provisions of the proposed Final Judgment and to punish violations thereof.
