SUPERSEDING INDICTMENT

The Grand Jury charges:

COUNT 1

(Possession with Intent to Distribute Methamphetamine (Mixture))

On or about April 27, 2023, in Calhoun County, in the Southern Division of the

Western District of Michigan, the defendant,

TRAVON DESHAUN-RODERICK MANSKER,

knowingly and intentionally possessed with intent to distribute 500 grams or more of

a mixture or substance containing a detectable amount of methamphetamine, a

Schedule II controlled substance.

COUNT 2

(Possession of Machineguns)

On or about April 27, 2023, in Calhoun County, in the Southern Division of the Western District of Michigan, the defendant,

TRAVON DESHAUN-RODERICK MANSKER,

knowingly possessed a loaded Glock Model 22 .40 caliber pistol and a Palmetto State Armory model PA-15 rifle, each with a conversion device installed, knowing each firearm was designed to shoot automatically more than one shot, without manual reloading, by a single function of the trigger.

COUNT 3

(Felon in Possession of Firearms)

On or about April 27, 2023, in Calhoun County, in the Southern Division of the Western District of Michigan, the defendant,

TRAVON DESHAUN-RODERICK MANSKER,

knowing that he had previously been convicted of a crime punishable by imprisonment for a term exceeding one year, knowingly possessed one or more of the following firearms which were in and affecting commerce:

- (i) a loaded Glock Model 22 .40 caliber pistol,
- (ii) a loaded Glock 17 9 mm pistol,
- (iii) a loaded Glock 43 9 mm pistol,
- (iv) a loaded Romarm model MiniDraco pistol,
- (v) a Ruger model AR-556 rifle,
- (vi) a Windham Weaponry model WW15 rifle,
- (vii) an American Tactical model Omni Hybrid rifle,
- (viii) a Savage Arms model MSR-15 rifle,
- (ix) a Palmetto State Armory model PA-15 rifle, and
- (x) a Griffin Armament, model RECCE 5, 5.56mm caliber silencer.

FORFEITURE ALLEGATION (Possession of Machineguns)

The allegations contained in Count 2 of this Superseding Indictment are hereby re-alleged and incorporated by reference for the purpose of alleging forfeiture pursuant to 18 U.S.C. § 924(d)(1) and 28 U.S.C. § 2461(c).

Upon conviction of the offense in violation of 18 U.S.C. § 922(o) set forth in Count 2 of this Superseding Indictment, defendant,

TRAVON DESHAUN-RODERICK MANSKER,

shall forfeit to the United States, pursuant to 18 U.S.C. § 924(d)(1) and 28 U.S.C. § 2461(c), any firearms and ammunition involved in or used in the knowing commission of the offense, including, but not limited to, (i) a loaded Glock Model 22 .40 caliber pistol and (ii) a Palmetto State Armory model PA-15 rifle and the associated ammunition.

FORFEITURE ALLEGATION

(Felon in Possession of Firearms)

The allegations contained in Count 3 of this Superseding Indictment are hereby re-alleged and incorporated by reference for the purpose of alleging forfeiture pursuant to 18 U.S.C. § 924(d)(1) and 28 U.S.C. § 2461(c).

Upon conviction of the offense in violation of 18 U.S.C. § 922(g)(1), set forth in Count 3 of this Superseding Indictment, defendant,

TRAVON DESHAUN-RODERICK MANSKER,

shall forfeit to the United States, pursuant to 18 U.S.C. § 924(d)(1) and 28 U.S.C. § 2461(c), any firearms and ammunition involved in or used in the knowing commission of the offense, including, but not limited to, i) a loaded Glock Model 22 .40 caliber pistol, (ii) a loaded Glock 17 9 mm pistol, (iii) a loaded Glock 43 9 mm pistol, (iv) a loaded Romarm model MiniDraco pistol, (v) a Ruger model AR-556 rifle, (vi) a Windham Weaponry model WW15 rifle, (vii) an American Tactical model Omni Hybrid rifle, (viii) a Savage Arms model MSR-15 rifle, (ix) a Palmetto State Armory model PA-15 rifle, and (x) a Griffin Armament, model RECCE 5, 5.56mm caliber silencer and the associated ammunition.
