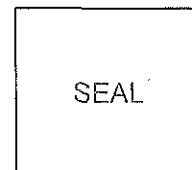

AFFIDAVIT of PROBABLE CAUSE

Your Affiant, Catherine Berner, Badge # 916, is a Special Agent with the Pennsylvania Office of Attorney General, Bureau of Criminal Investigations, Medicaid Fraud Control Section, located at 1000 Madison Avenue, Suite 310, Norristown, Pennsylvania 19403.

Your Affiant was assigned to investigate allegations of Medicaid Fraud committed by Tiffany Farris (Farris). The Pennsylvania Office of Attorney General received the initial referral from AmeriHealth Caritas (AmeriHealth) and the Pennsylvania Department of Human Services – Bureau of Program Integrity (BPI). AmeriHealth determined that Farris was potentially working for 22 hours per day as a Personal Care Attendant (PCA) for three consumers – Jonathan Banks (Banks), "C.F.L.", and "C.C." – while also maintaining outside employment. Further investigation revealed that consumer Banks also maintained outside employment during hours he was supposed to be receiving Personal Assistance Services (PAS) from Farris.

Banks was eligible to receive PAS services under the Community Health Choices (CHC) Waiver program. The CHC Waiver is a home and community based program that provides a variety of services to eligible individuals. One of the services available under this waiver is PAS to assist with daily living. The CHC Waiver requires Medicaid recipients to select a Managed Care Organization (MCO) to administer their medical and other benefits. PAS agencies submit claims to MCOs, where the claims are reviewed and payments are issued to agencies. Banks's MCO was AmeriHealth.

Banks received PAS through Silver Heart Healthcare Agency (Silver Heart), located at 2407 N Patton St, Philadelphia, PA 19132. Silver Heart utilized an Electronic Visit Verification (EVV) system for employees to document clock in and out information when providing services. Silver Heart used these electronic time records to generate Medicaid claims to receive payment from AmeriHealth, and to pay its PCAs based on their reported hours.

Your Affiant reviewed documents from Silver Heart, including Banks's consumer file, Farris's employee records, W2s, and EVV data. EVV calendars were used to identify Farris as Banks's assigned PCA and to verify which hours Farris was supposed to be providing PAS to Banks. Your Affiant reviewed records pertaining to Farris's outside employment with Wesley Enhanced Living at Stapeley Hall (Stapeley), located at 6300 Greene St, Philadelphia, PA 19144; Barclay Friends, located at 700 N Franklin St, West Chester, PA 19380; and The Terrace at Chestnut Hill (Terrace), located at 495 E Abington Ave, Philadelphia, PA 19118. Your Affiant also reviewed records pertaining to Banks's outside employment with Wellington at Hershey's Mill (Wellington), located at 1361 Boot Rd, West Chester, PA 19380, and from Terrace.

Your Affiant determined there were numerous PAS claims submitted to Silver Heart for Farris's services to Banks, which Farris could not have rendered due to either her or Banks's outside employment. The spreadsheet Exhibit "A", attached hereto and incorporated herein, details these instances, which amount to at least 1686.75 of services not rendered for which Medicaid, through AmeriHealth, paid \$34,272.06.

Your Affiant also reviewed records from the agency First Choice Care Services (First Choice), located at 4312 N 5th St, Philadelphia, PA 19140, which employed Farris as a PCA for consumer C.F.L., and from the agency Golden Age Home Care (Golden Age), located at 600 Washington Ave, Unit 18UB / UD, Philadelphia, PA 19107, which employed Farris as a PCA for consumer C.C. Like Banks, each of these consumers was eligible to receive PAS under the CHC Waiver, and each consumer's services similarly were administered by AmeriHealth.

Your Affiant compared records from Silver Heart, First Choice, and Golden Age, and found overlaps among the PAS hours Farris reported to Silver Heart and Golden Age. The spreadsheet below details these instances, amounting to at least 26.25 hours of overlapping services and \$575.40 in Medicaid claims paid out by AmeriHealth.

Your Affiant interviewed Banks at his residence on Friday, February 16, 2024. Banks confirmed that he received PAS services through Silver Heart and that Farris was his PCA. Banks stated that he was the one who clocked Farris in and out for her shifts and that Silver Heart only occasionally spoke to Farris to verify that she was there. Your Affiant interviewed Farris at her residence on Tuesday, February 27, 2024. Farris confirmed that she was employed as Banks's PCA through Silver Heart. She also confirmed that she had worked as a PCA for C.F.L. and C.C. She stated that Banks clocked her in and out for her shifts with Silver Heart, but she clocked herself in and out for her First Choice and Golden Age shifts.

In total, and as illustrated below, at least 2150.50 PAS hours were reported to Silver Heart, Golden Age, and First Choice for care that Farris could not have provided, for which the Medicaid system, through AmeriHealth, paid out at least \$44,433.15.

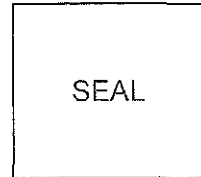
