AMENDMENT TO THE GOOGLE MOBILE REVENUE SHARE AGREEMENT

This amendment ("**Amendment**") is entered into by:

Google LLC, organized in the state of Delaware, whose principal place of business is at 1600 Amphitheatre Parkway, Mountain View, CA 94043, **Google Asia Pacific Pte. Ltd.**, organized in Singapore, whose principal place of business is at 70 Pasir Panjang Road, #03-71, Mapletree Business City II Singapore 117371, and **Google Ireland Limited**, organized in Ireland, whose principal place of business is at Gordon House, Barrow Street, Dublin 4, Ireland (In this Amendment, "**Google**" will mean Google LLC, Google Asia Pacific Pte. Ltd., and/or Google Ireland Limited, as the context requires.); and

Samsung Electronics Co., Ltd., a company existing under the laws of the Republic of Korea, whose principal place of business is at 129 Samsung-Ro, Yeongtong-gu, Suwon-si, Gyeonggi-do, 16677 Korea ("**Company**").

This Amendment is effective as of July 1, 2024 (the "**Amendment Effective Date**") between the parties. As of the Amendment Effective Date, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as described herein.

INTRODUCTION

- (A) Company and Google are parties to the Google Mobile Revenue Share Agreement with an effective date of July 1, 2020 (as amended, the "**Agreement**").
- (B) The parties wish to amend the Agreement.

AGREED TERMS

1. **Definitions.** Capitalized terms used but not defined in this Amendment have the same meaning as in the Agreement.
2. **Term Extension.** The definition of "Term" in the Agreement is hereby deleted in its entirety and replaced with the following:

Term: Starting on the Effective Date and continuing through March 31, 2025 (inclusive) ("**Term**").
3. **General.**
 - 3.1 The Agreement remains in full force and effect except as modified by this Amendment. To the extent the Agreement and this Amendment conflict, this Amendment governs.
 - 3.2 The Agreement's governing law and dispute resolution provisions also apply to this Amendment.
