This Amendment is effective as of July 1, 2024 (the "Amendment Effective Date") between the parties. As of the Amendment Effective Date, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as described herein.

Term: Starting on the Effective Date and continuing through March 31, 2025 (inclusive) ("Term").

- 3.1 The Agreement remains in full force and effect except as modified by this Amendment. To the extent the Agreement and this Amendment conflict, this Amendment governs.
- 3.2 The Agreement's governing law and dispute resolution provisions also apply to this Amendment.
