Reprogramming/Transfers

The total transfers/Reprogrammings/Reallocations of \$36.1 million include \$24.0 million in transfers of GLA's prior year unobligated balances to the ALS Account. Funding was reallocated from GLA's ALS account to: Criminal Division (\$7.9M), Civil Division (\$6.4M), Tax Division (\$1.2 million), ENRD (\$4.8 million), OSG (\$100,000), Pardon Attorney (\$1.8 million), and IPOL (\$1.755 million) for dues costs.

This also includes an \$11.7 transfer in from Office of Justice Programs SCAAP Program to Tax Division (\$5.0 million) and Civil Division (\$6.7 million).

In addition, there was a \$5.0 million reallocation from Civil Rights Division to Environment and Natural Resources.

Carryover:

Funds were carried forward into FY 2024 from GLA's FY 2023 no year account (\$71.2 million) and from the GLA FY 2023/2024 multi-year Health Care Fraud Account (\$24.1 million).

Recoveries/Refunds:

The FY 2024/2025 multi-year Health Care Fraud Account received \$81.7 million in direct collections funding.

As of FY 2021, Civil Division's Vaccine Injury Compensation Fund is now funded via direct collections from HHS as no-year funds, per bill language (\$22.7 million in FY 2024).

Reprogramming/Transfers

The total transfers/Reprogrammings/Reallocations of \$12.6 million include transfers of GLA's prior year unobligated balances to the ALS Account. Funding was reallocated from GLA's ALS account to: Criminal Division (\$2.6 million), Civil Division (\$5.9 million), Pardon Attorney (\$546,000), and IPOL (\$3.5 million) for dues costs and IT.

Carryover:

Funds were carried forward into FY 2025 from GLA's FY 2024 no year account (\$44.5 million) and from the GLA FY 2024/2025 multi-year Health Care Fraud Account (\$18.8 million).

Recoveries/Refunds:

The FY 2025/2026 multi-year Health Care Fraud Account received \$75.2 million in direct collections funding.

As of FY 2021, Civil Division's Vaccine Injury Compensation Fund is now funded via direct collections from HHS as no-year funds, per bill language (\$22.7 million in FY 2025).
