ORDER FOR CONTINUANCE

This matter having come before the Court on the joint application of Paul J. Fishman, United States Attorney for the District of New Jersey (Lee M. Cortes, Jr., Assistant U.S. Attorney, appearing), and defendants William E. Baroni, Jr. (Michael Baldassare, Esq., appearing) and Bridget Anne Kelly (Michael Critchley, Esq., appearing), for an order granting a continuance of the proceedings in the above-captioned matter, and the defendants being aware that they have the right to have this matter brought to trial within 70 days of the date of their appearance before a judicial officer of this court pursuant to Title 18, United States Code, Section 3161(c)(1), and the defendants having consented to such continuance, and it appearing that the defendants waive such rights, and for good and sufficient cause shown,

IT IS THE FINDING OF THIS COURT that this action should be continued for the following reasons:

- (1) The discovery in this matter involves numerous documents and materials that defense counsel require adequate time to review;
- (2) The grant of a continuance order will ensure that, taking into account the exercise of diligence, defense counsel have sufficient time to review and inspect discovery and further investigate the charges in this matter; and

As a result of the foregoing, pursuant to Title 18, United States Code, Section 3161(h)(7), the ends of justice served by granting the continuance outweigh the best interests of the public and the defendants in a speedy trial.

IT IS, therefore, on this day of May, 2015,

ORDERED that this action be, and hereby is, continued until November 16, 2015, and it is further

ORDERED that defense counsel and the Government shall have a status conference with the Court on August 12, 2015, at 9:00 a.m.; and it is further

ORDERED that:

- (1) The defendants shall file pretrial motions by September 18, 2015;
- (2) The Government shall respond to such motions by October 9, 2015;
- (3) The defendants shall file any reply papers by October 16, 2015;
- (4) The return date for pretrial motions shall be October 26, 2015, at 9:00 a.m.; and
- (5) Trial shall commence on November 16, 2015, at 9:00 a.m.; and it is further

ORDERED that the period from the date of this order through November 16, 2015 shall be excludable in computing time under the Speedy Trial Act of 1974.
