$\begin{array}{c} \underline{\text{COUNT ONE}} \\ \text{(Hobbs Act Conspiracy)} \end{array}$

From on or about September 20, 2012, through on or about October 3, 2012, in Union and Middlesex Counties, in the District of New Jersey, and elsewhere, defendants,

TERRELL MCQUEEN,
a/k/a "Rell,"
LEONARD ARRINGTON,
a/k/a "Koo,"
CARL WILLIAMS,
a/k/a "Andrew,"
a/k/a "Drew," and
ERIC WILLIAMS,
a/k/a "Long Boy,"

did knowingly and willfully conspire and agree with each other and others to obstruct, delay, and affect commerce and the movement of articles and commodities in commerce by robbery, and to commit and threaten physical violence to persons and property in furtherance of a plan and purpose to obstruct, delay, and affect commerce and the movement of articles and commodities in commerce by robbery.

In violation of Title 18, United States Code, Section 1951(a).

COUNT TWO (Hobbs Act Robbery)

- 1. At all times relevant to this Indictment, TMobile was a mobile communications company that owned and
 operated a retail store located at 1601 West Edgar Road, Linden,
 New Jersey, and engaged in the sale of cellular telephones and
 other merchandise that moved in and affected interstate
 commerce, and was engaged in an industry that affects interstate
 commerce.
- 2. On or about September 20, 2012, in Union County, in the District of New Jersey, and elsewhere, the defendants,

TERRELL MCQUEEN, a/k/a "Rell," and CARL WILLIAMS, a/k/a "Andrew," a/k/a "Drew,"

did knowingly and willfully obstruct, delay, and affect, and attempt to obstruct, delay, and affect, commerce, as that term is defined in Title 18, United States Code, Section 1951, and the movement of articles and commodities in such commerce, by robbery, as that term is defined in Title 18, United States Code, Section 1951, in that the defendants did unlawfully take and obtain personal property consisting of cellular telephones from the persons of and in the presence of employees of the T-Mobile store in Linden, New Jersey, against their will by means of actual and threatened force, violence, and fear of injury,

immediate and future, to their persons and property in their custody.

In violation of Title 18, United States Code, Section 1951(a) and Section 2.

(Use of a Firearm During a Crime of Violence)

 interstate commerce, and was engaged in an industry that
 affected interstate commerce.
- 2. On or about October 2, 2012, in Middlesex County, in the District of New Jersey, and elsewhere, the defendants,

LEONARD ARRINGTON,
a/k/a "Koo," and
ERIC WILLIAMS,

did knowingly and willfully obstruct, delay, and affect, and attempt to obstruct, delay, and affect, commerce, as that term is defined in Title 18, United States Code, Section 1951, and the movement of articles and commodities in such commerce, by robbery, as that term is defined in Title 18, United States Code, Section 1951, in that the defendants did unlawfully take and obtain personal property consisting of cellular telephones from the persons of and in the presence of employees of the T-Mobile store in Woodbridge, New Jersey, against their will by means of actual and threatened force, violence, and fear of
