**PROPOSED DECISION**

Claimant brings this claim against the Republic of Iraq (“Iraq”) alleging that Iraq held her hostage in violation of international law in August and September 1990. Because she has established that Iraq held her hostage for 38 days, she is entitled to an award of \$340,000.

**BACKGROUND AND BASIS OF THE PRESENT CLAIM**

Claimant alleges that she was an eight-year-old United States citizen, who together with her mother, brother and sister, was visiting her father in Kuwait, when Iraq invaded the country on August 2, 1990. Claimant asserts that, beginning with the invasion and for more than five weeks thereafter, she and her family were forced to hide and seek refuge in constant fear of being captured by Iraqi authorities. Claimant further asserts that during this entire period, the Iraqi government in effect forcibly prevented her and her family (and other U.S. nationals) from leaving Kuwait and/or Iraq and did so

with the express purpose of compelling the United States government to acquiesce to certain Iraqi government demands.

Although Claimant was not among them, many of the U.S. nationals in Iraq and Kuwait at the time of the 1990-91 Iraqi occupation of Kuwait sued Iraq (and others) in federal court for, among other things, hostage-taking.<sup>1</sup> Those cases were pending when, in September 2010, the United States and Iraq concluded an *en bloc* (lump-sum) settlement agreement.<sup>2</sup> The Agreement, which entered into force in May 2011, covered a number of personal injury claims of U.S. nationals arising from acts of the former Iraqi regime occurring prior to October 7, 2004, including claims of personal injury caused by hostage-taking.<sup>3</sup> Exercising its authority to distribute money from the settlement funds, the U.S. Department of State provided compensation to numerous individuals whose claims were covered by the Agreement, including some whom Iraq had allegedly taken hostage or unlawfully detained following Iraq's 1990 invasion of Kuwait.

Under the International Claims Settlement Act of 1949 ("ICSA"), the Secretary of State has statutory authority to refer "a category of claims against a foreign government" to this Commission.<sup>4</sup> The Secretary has delegated that authority to the State Department's Legal Adviser, who, by letter dated October 7, 2014, referred three

categories of claims to this Commission for adjudication and certification.<sup>5</sup> This was the State Department's second referral of claims to the Commission under the Claims Settlement Agreement, the first having been by letter dated November 14, 2012 ("2012 Referral" or "November 2012 Referral").<sup>6</sup>

One category of claims from the 2014 Referral is applicable here. That category, known as Category A, consists of

claims by U.S. nationals for hostage-taking<sup>1</sup> by Iraq<sup>2</sup> in violation of international law prior to October 7, 2004, provided that the claimant was not a plaintiff in pending litigation against Iraq for hostage taking<sup>3</sup> at the time of the entry into force of the Claims Settlement Agreement and has not received compensation under the Claims Settlement Agreement from the U.S. Department of State. . . .

On October 23, 2014, the Commission published notice in the *Federal Register* announcing the commencement of the second Iraq Claims Program pursuant to the ICSCA and the 2014 Referral.<sup>7</sup>

On October 7, 2015, the Commission received from Claimant a completed Statement of Claim seeking compensation under Category A of the 2014 Referral, together with exhibits supporting the elements of her claim.

## DISCUSSION

### Jurisdiction

This Commission's authority to hear claims is limited to the category of claims referred to it by the United States Department of State.<sup>8</sup> The Commission's jurisdiction under the "Category A" paragraph of the 2014 Referral is limited to claims for hostage-taking of (1) "U.S. nationals," provided that the claimant (2) was not a plaintiff in any litigation against Iraq for hostage taking pending on May 22, 2011 (the "Pending Litigation"), and (3) has not received compensation under the Claims Settlement Agreement from the Department of State. 2014 Referral ¶ 3.

### *Nationality*

This claims program is limited to claims of "U.S. nationals." Here, that means a claimant must have been a national of the United States when the claim arose and continuously thereafter until May 22, 2011, the date the Agreement entered into force.<sup>9</sup> Claimant satisfies the nationality requirement. She has provided a copy of her current

U.S. passport which states she was born in California. This substantiates her declaration that she was a U.S. national at the time of the alleged hostage-taking (August and September of 1990) and that she remained a U.S. national through the effective date of the Claims Settlement Agreement.

*No Pending Litigation*

Additionally, Category A states that the claimant may not have been a plaintiff in any of the so-called Pending Litigation cases at the time of the entry into force of the Claims Settlement Agreement.<sup>10</sup> Footnote 3 of the 2014 Referral specifically lists the Pending Litigation cases for purposes of the Referral. Claimant has averred under oath in her Statement of Claim, and the pleadings in the cases cited in footnote 3 confirm, that she was not a plaintiff in any of those Pending Litigation cases. The Commission thus finds that Claimant has also satisfied this element of her claim.

*No Compensation under the Claims Settlement Agreement  
from the Department of State*

The Claimant also satisfies the final jurisdictional requirement. Claimant has attested that she has not “received any compensation under the [Claims Settlement Agreement] from the Department of State.” Further, we have no evidence that the State Department has provided her any compensation under the Claims Settlement Agreement. Therefore, Claimant meets this element of her claim.

In summary, this claim is within the Commission’s jurisdiction pursuant to the 2014 Referral and is entitled to adjudication on the merits.

Merits

*Factual Allegations*

Claimant states that Iraq held her hostage from August 2, 1990 until September 8, 1990, a total of 38 days. Claimant states that, after Iraq invaded Kuwait on August 2, 1990, her family went to stay with friends of her father's in an area of Kuwait they thought would be safer. They returned to their house the next day and, a few days later, went to the Japanese Embassy, as Claimant's mother had Japanese citizenship. They stayed at the Japanese Embassy for the next two weeks. Claimant and her family then went home to get some belongings but were then stopped by Iraqi soldiers from returning to the Japanese Embassy. They therefore stayed with family friends until the end of August. Pursuant to Iraqi President Saddam Hussein's August 28, 1990 announcement that foreign national women and minors could leave the country, Claimant was formally permitted to go.<sup>11</sup> Claimant states that at some point around the end of August U.S. Embassy officials notified her father that the Iraqi authorities had announced the release of women and children who were U.S. citizens and that in order to leave they needed to get an Iraqi exit permit in Baghdad. In early September, they drove to Baghdad, but after crossing the border into Iraq, they were stopped by Iraqi security officers at a checkpoint in Basra and then taken to a police station, where they were detained for the day. Finally, the Iraqi authorities at the police station announced that they were to proceed together with approximately 15 other expatriate families in a convoy of vehicles to Baghdad under Iraqi military escort. Upon their arrival in Baghdad they were taken to the Al Monsour-Melia Hotel where they were kept for the next four days.

During this period, starting on September 1, 1990 and through September 23, 1990, the United States government organized several charter flights from Iraq and Kuwait to repatriate those released U.S. nationals wishing to return to the United States.<sup>12</sup> Claimant states that on or about September 7, 1990, Claimant's family received notice that Claimant, her mother, sister and brother could leave Iraq and return to the United States, but that they would have to leave Claimant's father behind. The family was subsequently moved to another hotel where they stayed until they went to the airport to board an evacuation flight on September 8, 1990. They flew first to Jordan, where they stayed for approximately 3 days and then on to London, where they stayed for approximately five days, before flying home to California.

#### *Supporting Evidence*

Claimant has supported her claim with her sworn Statement of Claim, and her declaration. Claimant has also provided two newspaper articles from September 1990 which both identify Claimant by name and describes her hostage experience. She has also provided a newspaper article from December 1990, which, although it does not identify Claimant by name, does identify her father and mother by name and notes that Claimant's mother and three children were allowed to leave Kuwait in September "after more than a month of captivity." She has further provided a copy of her sister's declaration stating that she traveled with Claimant at this time and a copy of her sister's former U.S. passport, which contains a September 8, 1990 stamp and a September 12, 1990 stamp.<sup>13</sup> While the dates in the stamps are clear, it is difficult to make out which countries issued these stamps. However, they comport with Claimant's declaration

regarding the date of her departure from Iraq, and the approximate dates of her departure from Jordan and arrival in England, as well as with the contemporaneous newspaper article she has submitted.

In addition, Claimant has submitted a number of documents that provide background about the broader geopolitical situation during the First Gulf War in 1990-91, including some that relate specifically to the circumstances faced by U.S. nationals in Iraq and Kuwait at the time. These documents include statements from U.S. and Iraqi officials, resolutions of the United Nations Security Council, newspaper articles, a report from Amnesty International on human rights violations committed by Iraq in 1990, unclassified cables and a memorandum from the U.S. Department of State, and affidavits submitted in two lawsuits brought by other U.S. nationals who were also in Kuwait or Iraq during the First Gulf War.

#### *Legal Standard*

To make out a substantive claim under Category A of the 2014 Referral, a claimant must show that (1) Iraq was engaged in an armed conflict and (2) during that conflict, Iraq took the claimant hostage.<sup>14</sup> The Commission has previously held that, to establish a hostage-taking claim, a claimant must show that Iraq (a) seized or detained the claimant and (b) threatened the claimant with death, injury or continued detention (c) in order to compel a third party, such as the United States government, to do or abstain from doing any act as an explicit or implicit condition for the claimant's release.<sup>15</sup> A claimant can establish the first element of this standard by showing that the Iraqi government

confined the claimant to a particular location or locations within Iraq or Kuwait, or prohibited the claimant from leaving Iraq and/or Kuwait.<sup>16</sup>

*Application of Standard to this Claim*

(1) Armed Conflict: Claimant alleges that Iraq took her hostage in Kuwait on August 2, 1990 and held her hostage for 38 days, until September 8, 1990, when Iraqi officials allowed her and her mother and siblings to leave. In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission held that during this entire period, Iraq was engaged in an armed conflict with Kuwait.<sup>17</sup> Thus, Claimant satisfies this element of the standard.

(2) Hostage-taking: To satisfy the hostage-taking requirement of Category A of the 2014 Referral, Claimant must show that Iraq (a) seized or detained her and (b) threatened her with death, injury or continued detention (c) in order to compel a third party, such as the United States government, to do or abstain from doing any act as an explicit or implicit condition for her release. Claimant satisfies this standard for the 38-day period from August 2, 1990 to September 8, 1990.

(a) Detention/deprivation of freedom: For purposes of analyzing Claimant's allegations of having been detained, her time in Kuwait following the Iraqi invasion can be divided into three periods: (i) between the Iraqi invasion on August 2, 1990 and the Iraqi government's formal closing of the borders on August 9, 1990; (ii) from that August 9th formal closing of the borders until the August 28, 1990

announcement that women and minors could leave Iraq and Kuwait; and (iii) from that August 28th announcement until Claimant's departure on September 8, 1990.<sup>18</sup>

From August 2, 1990 until Iraq formally closed its borders to foreign nationals on August 9, 1990, Iraq confined Claimant to her father's home, the home of friends of her father's, and the Japanese Embassy, by threatening all U.S. nationals with immediate seizure and forcible detention.<sup>19</sup> Although some foreign nationals did manage to leave Kuwait and/or Iraq during this period, Claimant could not reasonably be expected to have escaped.<sup>20</sup> Iraqi authorities were forcibly detaining foreign nationals (including U.S. nationals) in Kuwait, relocating many to Baghdad against their will.<sup>21</sup> Claimant and her family understandably had, as the United Nations Compensation Commission has put it, a "manifestly well-founded fear" of being killed or forcibly detained if they had left where they were hiding and seeking refuge.<sup>22</sup> The Commission has previously recognized that for the purposes of the legal standard applicable here, putting Claimant and her family in this situation in effect amounts to detaining them.<sup>23</sup> Iraq thus detained Claimant from August 2, 1990 to August 9, 1990.

From August 9, 1990 until the August 28, 1990 announcement that women and minors could leave Iraq and Kuwait, the Iraqi government confined Claimant to Kuwait and Iraq, preventing her from leaving by the threat of force. Starting on August 9, 1990,

the Iraqi government formally closed Kuwait's borders, forcibly prohibiting U.S. nationals from leaving.<sup>24</sup> As the Commission has previously held, as of that date, Iraq prohibited all U.S. nationals from leaving the country, effectively detaining Claimant within the borders of Kuwait and Iraq.<sup>25</sup> For Claimant, this formal policy of prohibiting U.S. nationals from leaving Iraq and Kuwait lasted until August 28, 1990, when the Iraqi government announced that all female and minor U.S. nationals could leave.<sup>26</sup>

Although Claimant may have been legally permitted to leave Kuwait on August 28, 1990, her detention did not end on that date. As the Commission has previously recognized, a claimant's detention ends only on the date that she is released from the control of the person or entity that detained her.<sup>27</sup> Any attempt "[by the perpetrator] to restrict [the] movements" of a claimant establishes control,<sup>28</sup> whereas a claimant who has a reasonable opportunity to leave the site of his or her captivity is deemed no longer to be under the perpetrator's control.<sup>29</sup>

Under this standard, Claimant remained under Iraq's control until September 8, 1990. The Commission has recognized that Iraq imposed conditions on air travel that limited the ability of foreign nationals, including U.S. nationals, to leave Iraq and/or Kuwait immediately after the August 28, 1990 release announcement. Indeed, as detailed above, the available evidence indicates that Claimant left Iraq at the first reasonable

opportunity, on the September 8, 1990 U.S. government-chartered flight that left Iraq. Because there is no evidence that Claimant remained voluntarily in Kuwait at any time during this period, and Claimant's attestation is that she in fact was restrained from leaving until September 8, 1990, we conclude that she was under Iraq's control and thus detained from August 28, 1990 to September 8, 1990.

In sum, Iraq thus detained Claimant from August 2, 1990 until September 8, 1990.

(b) Threat: In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission determined that the Iraqi government threatened U.S. nationals in Kuwait and Iraq numerous times with continued detention.<sup>30</sup> This included Claimant.<sup>31</sup> Both Iraqi President Saddam Hussein and the Speaker of Iraq's National Assembly Saadi Mahdi made clear that American nationals (as well as those from numerous other countries) would not be permitted to leave.<sup>32</sup>

In short, the Iraqi government made unequivocal threats to continue to detain U.S. nationals in Kuwait and Iraq. Claimant was a U.S. national in Kuwait at the time. Claimant has thus established that Iraq threatened to continue to detain her.

(c) Third party coercion: The Commission has previously held that Iraq detained all U.S. nationals in Kuwait or Iraq at the time and threatened them with continued detention in order to compel the United States government to act in certain

ways as an explicit and/or implicit condition for their release.<sup>33</sup> Iraq itself stated that it sought three things from the United States government before it would release the detained U.S. nationals; it wanted the United States (i) not to attack Iraq, (ii) to withdraw its troops from Saudi Arabia; and/or (iii) to end the economic embargo imposed on Iraq.<sup>34</sup> Indeed, at the time, the U.S. government itself understood Iraq's actions to be hostage-taking.<sup>35</sup>

In sum, this claim meets the standard for hostage-taking within the meaning of the 2014 Referral. Iraq held Claimant hostage in violation of international law for a period of 38 days, and Claimant is thus entitled to compensation.

#### COMPENSATION

Having concluded that the present claim is compensable, the Commission must next determine the appropriate amount of compensation.

In its first decision awarding compensation for hostage-taking under the 2014 Referral, the Commission held that successful claimants should be awarded compensation in the amount of \$150,000 plus an additional \$5,000 for each day the claimant was in captivity.<sup>36</sup> Therefore, for the 38 days Iraq held Claimant hostage, she is entitled to an award of \$340,000, which is \$150,000 plus (38 x \$5,000). This amount constitutes the entirety of the compensation to which Claimant is entitled under the Claims Settlement Agreement.

Claimant is entitled to an award in the amount of \$340,000.


