Dear Mr. Mucchetti,

I am writing today to highlight the positive benefits that CVS Health has brought to communities in New York and communities across America.

In New York, CVS Health provides an accessible, supportive and personalized health care experience through its over 570 stores, 19 MinuteClinics, 47 nurse practitioners and over 16,500 employees. These stores and MinuteClinics provide access to high-quality, affordable care and health advice for patients.
