# BARCC's Role in Forensics

*Individual:* Accompany about 425 survivors every year for the sexual assault forensic exam and provide a follow-up call with access to our other services.

State: Access to Forensic Information Project

*National:* OVC supported pilot project with National TeleNursing Center.

### Getting Information to Survivors

Statewide Toxicology Results Reporting Line toll-free at 1-866-269-4265

- Used only for UNREPORTED cases to allow survivors the option to consider these results in their reporting decisions.
- Crime lab results faxed to BARCC then given to the survivor through the ANONYMOUS kit number.

# Second case- Amelia





## 2009 Gap Study

To identify information gaps between what survivors want to know and what they are able to access.

Guiding Question: When survivors seek information online about forensics (DNA, rape kits, CODIS, etc...) what do they find?



# Key Online Findings

- 1. Information focused on a professional/technical audience.
- 2. Inaccurate/inflammatory sites such as commercialized law sites
- 3. News about specific cases

What was missing was accurate, survivor-centered information about forensic issues.

- (866) 463-3799
- Statewide program for Toxicology Kits
- Unreported to the police ONLY
- 12 weeks for results



# Toxicology Alert Line

Contact is survivor initiated

- About 7 calls per month to this line
- We offer perspective about the results in terms of what they do/do not mean
- Offer resources and possible next steps.




