Rich,

Thanks for your email and for your willingness to meet with my investigators today, who have already advised you that the OIG will be recording the interview. However, I cannot accommodate your request to make your own recording of the interview.

As for legal authority, in the context of unionized employees, federal courts have definitively addressed the authority of Inspectors General to determine the practicalities of investigations, ruling that “proposals which concern investigations conducted by the Inspector General...are not appropriately the subject of bargaining between an agency and a union.” *Department of Homeland Sec. Customs & Border Prot. v. Federal Labor Relations Auth.*, 751 F.3d 665, 672-73 (D.C. Cir. 2014) (citing *Nuclear Regulatory Comm’n, Washington, D.C. v. Federal Labor Relations Auth.*, 25 F.3d 229, 234 (4th Cir. 1994), as amended (June 21, 1994)). “Congress intended that the Inspector General’s investigatory authority include the power to determine when and how to investigate[,]” and bargaining about interview procedures in an OIG investigation is inconsistent with the Inspector General Act (IG Act). *Id.*

Moreover, as with other Department law enforcement and prosecutorial components, the OIG sets its own ground rules, pursuant to its authority under the IG Act, for how it conducts its interviews. No other Department investigative authority, including U.S. Attorneys, would permit a witness to make and maintain a separate video or audio recording of his or her interview. Moreover, the concern raised in your email that motivates your request – that your statements be recorded accurately – will be addressed through the audio recording by the OIG, which will be maintained as part of our investigative file. Further, even if you were allowed to make your own recording of the interview, that recording also would constitute a government record and Department property, so you would not be permitted to keep it personally or take it with you when you separate from the Department. Accordingly, I fail to see the value of you making a second recording of the interview.

In sum, the OIG’s practice of not allowing a witness to make their own audio or video recording is a long-standing one that is grounded in the IG Act, consistent with DOJ practice, and aligns with court decisions in other contexts. Further, our plan to audio tape the interview addresses the concern you’ve raised about ensuring that there is a full and complete record of the interview. Accordingly, I remain hopeful that you will still participate in the interview today at 2 pm. Although I think you know this already, I would be remiss if I did not mention that if you choose not to participate in the requested interview, we will have to note that fact, as is our practice, in our final report.

I will respond separately, likely later today, to the concerns you raised about answering questions related to t (b)(5), (b)(6), (b)(7)(C) per OIG We will not seek to ask you any questions at today’s interview at 2 pm about that matter. Lastly, Bill and I can discuss with you some of the items you raised in your email to me about the other, unrelated matter.

As for the expansion of the discussion, I cannot agree to that now. There are basically two reasons for that. First, and most important, th (b)(5), (b)(6), (b)(7)(C) per OIG relate to a discretionary personnel decision made by the President. As such, there are significant questions about whether DOJ-OIG even has the authority to investigate such a matter. Relatedly, there may well be Executive Privilege issues that would have to be navigated before I could be confident that it would be permissible for me to answer whatever questions may be asked. I will leave that analysis to lawyers expert in that field, but I assume that it would have to involve OLC and/or the White House Counsel's Office. I have briefly discussed your request that I answer questions abo (b)(5), (b)(6), (b)(7)(C) per OIG with the Acting AG and with others here in ODAG and OLC and the preliminary view is that I could not agree to such an interview until the authority and privilege issues are resolved. Second, and less important, I am completely swamped with managing the Department's response to last week's events and the current threat streams and the inauguration planning and, thus, I need every minute I can get between now and the inauguration. I suggest that you have the right DOJ-OIG people talk to OLC and/or the White House Counsel's Office and, if they clear such an interview, then I'll be happy to participate. Were my own personal interests controlling here, I would gladly talk about the circumstances surroundin (b)(5), (b)(6), (b)(7)(C) per OIG, but that's obviously not the case.

Also, unless someone can provide me with controlling authority that precludes it, I will be audio recording the interview tomorrow. I will communicate that directly to the IG and explain my reasons for that (it has nothing whatsoever to do with either of you). I fully understand and appreciate the need to maintain the integrity of your investigation and I will not share that recording with anyone who may be a witness. As I said, I'll communicate that to the IG as I do not expect you to operate as messengers on that point, but I want to be completely transparent with you about that.
