WASHINGTON – U.S. Senator Claire McCaskill released the following statement on the nomination of Judge Brett Kavanaugh to the Supreme Court:

"I have been thorough in examining Judge Kavanaugh's record. That certainly seems to paint things in a particular light. But it's ridiculous when you look at how they selected which words from each party's officials to include. As an example, here are two of the statements they pulled from (emphasis on which words they selected from each):

Sen Joni Ernst, R-lowa: "If she is accusing him of something so egregious, she needs to be heard."

Sen. Sheldon Whitehouse, D-R.I.: "Survivors need to be heard and respected, not attacked and smeared."

Notice that "needs to be heard" actually appears in both statements. Yet only one is considered by AP to be representative of their statement, despite it being the clear point of both statements.

Their list is full of these. For example, for Sen. Jeff Flake's statement ("Obviously, these are serious charges, and if they're true, I think they are disqualifying"), they pulled out the words "if they're true" instead of "Obviously, these are serious charges."

Absurd.

SEN. RICHARD BLUMENTHAL: thank you, senator hatch. you for being here. this is another great panel. i want to join my colleague, senator whitehouse, who very eloquently and powerfully thanked ms. eastmond, jackson, cover bin and hunter. you are really shown us how an individual voice can make such a difference. i also want to thank melissa smith for your comments on how a collective voice can be impactful, and a lot of young people would not have their individual voices but for your service as a teacher. i've always thought that being a teacher, along with being police, firefighter, emergency responders, you are the unsung heroes, our public service employees. i want to thank you for your personal testimony about the importance of the issues that matter in real lives to real people and have real impact.

MIKE LEE: thank you, mr. chairman. thanks so much to all of you for being here. my friend and colleague, senator kennedy from louisiana, had to step out for a few minutes, wasn't sure whether be back in time, but he asked me to convey his gratitude to each of you for your testimony and your willingness to provide insights. ms. mahoney, i'd like to start with you. i heard mentioned a minute ago speculation about unfair advantage in court, and senator hatch, i can tell you she always has an unfair advantage in court because she's so good. [laughter] you've always been one of my favorite litigators to watch argue cases in the supreme court. it's an odd little hobby of mine, watching supreme court litigants, and always enjoyed you arguing. one of the things i've appreciated about your arguments is that you focus on the law. you focus on what, why your client's case is right. and you focus -- you seem to have an approach that echoes something you said a minute ago which is if you're willing to go to the hard work of finding an answer in a case, you can find the right answer. the law will normally supply a correct answer. you seem to believe that judge kavanaugh shares this view. tell me how that can help instill a sense of civility among members of the bar and among jurists, the belief that there's a right answer in the law?

MAUREEN MAHONEY: i think, i think there is a right answer in the law. i think he believes that, and it should instill a sense of confidence in the judiciary because there is sort of this pervasive view that the justices -- or i becoming more per vase isive -- that the justices are just partisans, you know, deciding for their team. and i certainly don't believe that's the case. i don't think that's what's going on. there are different ideologies, but i don't think it's partisanship. and i think that justice kavanaugh -- judge kavanaugh, justice kavanaugh hopefully, will perform his role in a way that people will understand that he is just working to get the answer the way he asks questions, the way he probes evenly, the way he shows respect for everyone and the way he explains his decisions and the way he surprises people sometimes with the way that he rules. you won't be happy, republicans won't be happy every time. democrats won't be happy every time. but it will be a product of his reasoning and his effort and his work in the case. and i think americans should be grateful for that kind of judicial approach whether they're republicans or democrats, and i would hope that we could get beyond some of this polarization.

SEN. LEE: as someone who's devoted her career to arguing in pregnant of the supreme court, you can -- in front of the supreme court, you can confirm there is no aisle --

MAHONEY: there is no political aisle.

SEN. LEE: and, in fact, 5-4 decisions are very rare.

MAHONEY: they're very rare. yes, they are.

SEN. LEE: ms. tableson, i appreciated your comments. having served as a law clerk myself, i know there's a special bond, relationship that develops between a law clerk and the judge or justice for whom the law clerk is working. one of the reasons for that is you're able to interact with the jurist on a day-to-day basis. not only in seeing, in your case, how judge kavanaugh interacted with his law clerks, but also how he interacted with his colleagues. what can you tell us about what saw and how that would portend for how he would interact with colleagues regardless of their backgrounds andegss o what some people might identify as their political ideologies?

REBECCA TAIBLESON: certainly, senator. the d.c. circuit court of appeals is composed of many judges who have diverse views on the law and on judicial philosophies more generally. but at least when i was there, their views of judge kavanaugh are not diverse. instead, they uniformly respect him, they appreciate his collegiality, his civility, his hard work and, ultimately, the fact that he's a straight shooter. he, there are certainly always going to be disagreements, but those are disagreements that he has in good faith. no hidden agenda, nothing like that. he says what he means and he means what he says. i think on the supreme court he is going to bring those same characteristics, and i think he's going to be sort of a uniter for that reason. i think he's going to bring out the best in his fellow justices, should he be fortunate enough to be confirmed, and is going to have great relationships with justices across the ideological spectrum.

SEN. LEE: thank you. ms. smith, i have great respect for teachers. both my parents worked as educators in different capacities at different points in their careers, and they a always taught me to have great respect for my teachers, especially social studies teachers because of the importance of the subject matter you teach. can you help me understand, i understand that resources are scarce and more resources often need to be devoted to public education to make sure that you as a teacher and your colleagues, those with whom you work have the capacity to do your job, to educate people. help me understand the connection between your concern for those resources and the jurisprudential philosophy of this federal judge. ...

SMITH: with less funding than we have now

SEN. LEE: when you say his position, you don't mean his policy positions because the policymaker but as a jurist deciding on whether or not something is lawful. to say whether the policymakers are empowered to make those decisions, isn't there a difference between those two things?

SMITH: yes i know. we often believe whether they be elected officials or judges, they're not supposed to bring their personal views into it and base decisions on the loss but it doesn't team like that's the case, maybe not with judge kavanaugh but there's also a concern that personal views will influence judgment and a concern that teachers have, that students have and when he has publicly spoken in support of public school vouchers, that's a concern that we have

SEN. LEE: my time has expired, thank you mister chairman.

In declaration, woman alleges she was drugged, raped at 1982 party where Kavanaugh was present

On the eve of a critical Senate hearing that could decide the fate of Supreme Court nominee Brett Kavanaugh, a third woman came forward to accuse him of sexual misconduct in the early 1980s.

The revelations stunned Capitol Hill, where Republican lawmakers are seeking to push through a nomination that legal scholars and lawmakers say would create a conservative majority that could survive for decades.

Judge Kavanaugh's judicial elevation, once expected to move quickly and smoothly through the Senate, now hangs on the votes of a handful of GOP senators troubled by the late-breaking accusations. Sens. Jeff Flake of Arizona, Susan Collins of Maine and Lisa Murkowski of Alaska have all said they would determine their votes after Thursday's hearing. With a 51-49 advantage, Republicans can't afford more than one defection, assuming no Democrat votes for him.

At the Senate Judiciary Committee hearing, Judge Kavanaugh and Christine Blasey Ford are scheduled to testify on her allegations that he sexually assaulted her when they were teenagers. The judge has denied Dr. Ford's claims. Judiciary committee aides were seeking to speak with Ms. Swetnick but she isn't scheduled to appear at the hearing.

The accusations have emerged as a test for Congress in how it handles sexual misconduct issues in the age of the "#MeToo" movement, a challenge that could influence the outcome of the November midterm elections. Republicans lawmakers were so concerned about the optics of their 11-man judiciary committee roster grilling Dr. Ford that they hired a female outside counsel, Arizona prosecutor Rachel Mitchell, to do most of their questioning.

The committee is tentatively scheduled to vote on Judge Kavanaugh's nomination on Friday, and the full-Senate could act on it early next week.

That schedule was rattled Wednesday when Ms. Swetnick issued a sworn statement alleging that between 1981 and 1982, she became aware of efforts by Judge Kavanaugh and his high-school friend, Mark Judge, to "'spike' the 'punch'" at house

parties she attended with drugs "and/or grain alcohol" and subsequently "target" women.

In a statement released by the White House on Wednesday, Judge Kavanaugh called the allegations "ridiculous and from the Twilight Zone." Of Ms. Swetnick, he said: "I don't know who this is and this never happened." Mr. Judge's lawyer denied the allegations.

Ms. Swetnick said she attended more than 10 house parties in the Washington area between 1981 and 1983 with Judge Kavanaugh and Mr. Judge, where she watched them "drink excessively and engage in highly inappropriate conduct, including being overly aggressive with girls" and grabbing them "without their consent."

She said that in 1982, she was drugged and raped by a group of boys. Ms. Swetnick doesn't allege that Judge Kavanaugh and Mr. Judge engaged in the rape but said they were "present" when she was victimized. She said that witnesses could verify her account and that she told people about the attack shortly after it happened.

She also said she had a "firm recollection" that at these house parties, boys lined up outside rooms "waiting for their 'turn' with a girl inside the room," and that those boys included Judge Kavanaugh and Mr. Judge.

High-school friends of Judge Kavanaugh on Wednesday rebutted the new allegations of sexual misconduct. In a letter to the Senate Judiciary Committee, more than 60 people who said they knew the Supreme Court nominee in high school dismissed as "nonsense" accusations that he spiked drinks at parties so women could be assaulted. They said they didn't know Ms. Swetnick.

Ms. Swetnick's declaration was made public in a tweet by attorney Michael Avenatti, a lawyer who also represents Stephanie Clifford, the former adult-film star whom a lawyer for President Trump paid in October 2016 to keep quiet about an alleged affair with Mr. Trump. Mr. Avenatti in recent days has repeatedly called for a Federal Bureau of Investigation probe into the allegations against Judge Kavanaugh.

Hours after Mr. Avenatti tweeted the sworn declaration from Ms. Swetnick, the GOP president attacked him on Twitter, calling him a "third-rate lawyer who is good at making false accusations, like he did on me and like he is now doing on Judge Brett Kavanaugh."

President Trump stands "firmly behind" Judge Kavanaugh, a White House official said, and has "no plans to pull" his nomination.

The new allegations from Ms. Swetnick could renew pressure on Mr. Judge to testify before the Senate committee. Dr. Ford has alleged that he was with Mr. Kavanaugh when she was attacked. Democrats have previously called for Mr. Judge to testify, but a lawyer for Mr. Judge has said his client has no recollection of the episode Dr. Ford described and didn't want to testify.

Ms. Swetnick said she holds active clearances at the Treasury Department, U.S. Mint and Internal Revenue Service. She said in her declaration that she would be willing to testify to the information contained there.


Ms. Swetnick graduated from Gaithersburg High School in 1980, according to a spokeswoman for Montgomery County Public Schools, which would mean she attended the parties described in her declaration after she had graduated. Judge Kavanaugh graduated from high school in 1983.

She has worked for two decades as a web developer, according to an online resume, including as a subcontractor for government agencies including units of the U.S. Treasury and State Departments.

Ms. Swetnick, who Mr. Avenatti said approached him about a month ago with her allegations, has little online presence. A registered voter in Washington, she isn't affiliated with any political party. Federal Election Commission records show no donations by her to federal candidates. She has had a hunting license in Montana, according to public records, and was for years a resident of Bethesda, Md., where she listed a business in 2009 called International Building Solutions.

More recently, Ms. Swetnick moved into an upscale residential and retail area of Washington called City Center, into the same building where senior Trump adviser Stephen Miller lives and where former White House communications director Hope Hicks once resided.

Public records reveal a handful of instances in which Ms. Swetnick filed complaints against others, or been the subject of them. Mr. Avenatti didn't respond to a request for comment.



In 1993, she filed a criminal harassment complaint with state prosecutors in Maryland against a podiatrist and his wife, alleging repeated phone calls, according to court records, but the case was withdrawn two months after it was filed.

In 2001, Ms. Swetnick was the defendant in a domestic-violence case filed by Richard Venneccy in Miami-Dade County, Fla. The case was dismissed when both parties failed to appear in court in March of that year, according to court documents reviewed by the Journal.

Roughly a decade ago, Ms. Swetnick was involved in a dispute with her former employer, New York Life Insurance Co., over a sexual-harassment complaint she filed, according to people familiar with the matter. Representing her in the complaint was the firm run by Debra Katz, the lawyer currently representing Dr. Ford. The company ultimately reached a financial settlement with Ms. Swetnick, the people said.

A spokesman for New York Life confirmed that Ms. Swetnick worked there as an agent for less than two years, from 2006 to 2008. She didn't list her work there on a résumé posted online.

A spokeswoman for Ms. Katz declined to comment.

Records show Ms. Swetnick also had recent run-ins with tax authorities. In 2015, Maryland's comptroller filed a lien against her in Anne Arundel County, a suburb of Baltimore and Washington, for more than \$30,000 in unpaid taxes. The state demanded about the same amount in interest and penalties for a total bill of \$62,821. The state released the lien in 2016.

In 2017, the Internal Revenue Service filed a lien on Ms. Swetnick's Washington apartment for \$40,303 in unpaid taxes, and released it in March, saying the tax bill had been paid.

Mr. Avenatti said in an interview late Tuesday that he had extensively vetted his client's allegations.

"I'll put my vetting process up against Donald Trump's vetting process any day of the week," he said.

The Ranking Member has had the non-BI version of the letter since around 7/30/2018. The Department of Justice and the FBI conduct background investigations in accordance with a memorandum of understanding adopted signed by then-Attorney General Eric H. Holder, Jr., and then-White House Counsel Robert F. Bauer in March 2010. The MOU provides as follows:

"[P]rior to an Appointee's assuming the nominated position ... if the FBI becomes aware of new information that raises questions about the suitability or trustworthiness of an Appointee ... the FBI will so apprise the President or his designated representative as soon as possible."

The FBI does not make any judgment about the credibility or significance of any allegation. The purpose of a background investigation is to determine whether the nominee could pose a risk to the national security of the United States. Consistent with the memorandum of understanding, the FBI forwarded to the White House Counsel's Office a letter alleging that the nominee engaged in an incident of misconduct in the 1980s. The allegation does not involve any potential federal crime. The FBI's role in such matters is to provide information for the use of the decisionmakers.

Sen. Doug Jones, D-Ala., added his name to the handful of Democrats who on Wednesday said that Brett Kavanaugh's Supreme Court nomination should be held up in light of the guilty plea of the president's former personal lawyer and the eight guilty verdicts against President Trump's former campaign manager, Paul Manafort.

Jones said Kavanaugh's nomination should be held up not just because of those legal cases. Alabama's junior senator cited the trove of documents that the Senate Judiciary Committee has yet to obtain from Kavnaugh's tenure as President George W. Bush's staff secretary.

"I think we need to push a pause button right now and let this play out just a little bit," the senator told <u>MSNBC</u>. "And you couple [the legal cases] with the fact that we haven't got the full set of documents, I think it only makes sense."

Jones noted that Senate Judiciary Committee Chairman Chuck Grassley, R-Iowa, was told by the National Archives that the Kavanaugh documents could be delivered by October at the earliest.

By waiting until then, Jones said, "it'll give some of this other stuff some time to play out," referring to Trump being implicated in violating campaign finance laws by former Trump lawyer Michael Cohen. When he pleaded guilty to eight felony counts in a New York federal courtroom on Tuesday, Cohen maintained he bought the rights to the stories of two women who claimed they had affairs with the then-presidential candidate "in coordination and at the direction of a candidate for federal office.

Jones said the Manafort convictions and the Cohen plea - which he called "two bombshells" - are "undermining this presidency." He said the cases also make Kavanaugh's stance on presidential power more relevant.

"You cant ever determine where this will end up. But I think it does raise the stakes a bit on that part of the Kavanaugh record," Jones said.

While some Democrats have cancelled meetings with Kavnaugh following the legal developments, Jones has not gone that far.

"If the schedule holds, then yes, I'm going to go forward with it," he said. "I'm not going to cancel that."

Meanwhile, the senator is keeping an open mind on Kavanaugh's nomination. He has been facing pressure from both sides of the aisle over his vote, including being heckled by a protester at a Birmingham town hall who threw a pair of stuffed lips at Jones' direction and said he could "kiss my ass" if he voted for Kavanaugh.

On the other hand, Jones has been the target of ads from the National Rifle Association and the Judicial Crisis Network urging him to vote for Trump's Supreme Court nominee.

Jones has said that appeals from both sides will not impact his decision.







Last July, as Clarence Thomas stood beside President Bush on a Kennebunkport lawn to accept his nomination, Republicans could hardly contain their glee. Once more, Bush had outfoxed the Democrats. How could white senators vote against a black nominee who, though conservative, had risen from the depths of Southern poverty? Liberal interest groups, with only the scalp of Robert Bork to show for all their judicial headhunting in recent years, nonetheless held out hope. At least it was worth the effort, given that the 43-year-old Thomas might serve on the high court into the 2030s. Since his controversial legal views alone were unlikely to sway senators to vote him down, liberals went out to scour Thomas's personal life. Journalist Juan Williams had done several profiles of Thomas over the years. In a Washington Post oped piece last week, Williams revealed that all summer long he was called by eager Senate staffers seeking "anything on your [interview] tapes we can use to stop Thomas." Did he ever take money from the South African government? Did he beat his first wife?

Nothing surfaced-until they got lucky. In August, Nan Aron, head of the Alliance for Justice, which opposed Thomas, got a call from a person saying Thomas had harassed an employee named Anita Hill in the early '80s. The male caller, whom Aron says she knew, had been a classmate of Hill's at Yale Law School. It isn't known whether he was calling at Hill's behest or even with her knowledge. In any event, Aron passed along the information to the staff of Democratic Sen. Howard Metzenbaum, the only member of the Judiciary Committee to vote against Thomas's successful nomination to the federal appeals court in Washington in 1990. Metzenbaum seemed to be the most likely senator to pursue the tip. It was a long shot. Juicy charges percolate up at the last minute in many Supreme Court fights and they usually don't pan out.

Metzenbaum's Labor-committee staff went forward. On Sept. 3 or 4, a female aide phoned Hill. According to Metzenbaum's chronology, the call was only part of a routine inquiry to three women who worked with Thomas at EEOC. Hill, a law professor at the University of Oklahoma, was asked about such legal issues as gender discrimination. The aide mentioned rumors of sexual harassment, but Hill offered nothing. On Sept. 5 a second Labor aide, Ricki Seidman, called Hill. Seidman works as an investigator for Democratic Sen. Ted Kennedy, who, like Metzenbaum, sits on both Labor and Judiciary. This time Hill said she needed to think about whether she would discuss harassment. Four days later Hill agreed to talk. Seidman referred her to a Metzenbaum lawyer named James Brudney, who had attended Yale with Hill. The next day-when the first round of Thomas's confirmation hearings began--Hill detailed her accusations to Brudney. Trouble was, Brudney wasn't on the Judiciary staff. So,

after consulting Metzenbaum, he forwarded the charges to Harriet Grant, chief of nominations for Judiciary. On Sept. 12, in two calls, Hill repeated her story to Grant.

The ball was rolling--with one roadblock. According to Biden, Hill demanded confidentiality, that Thomas not be informed of her charges and that the FBI undertake no investigation. Hill told Grant that she wanted to share her concerns with the committee to "remove responsibility" and "take it out of [her] hands." Biden decided not to tell other committee members of the allegations. Only he, Metzenbaum and Kennedy knew at this point.

Over the next week, as the Thomas hearings continued, Hill spoke to no one at Judiciary. Grant did receive one call-from Susan Hoerchner, a Yale classmate of Hill's, who told Grant that Hill confided in her in the spring of 1981, at the time of the first alleged harassment by Thomas. Hoerchner corroborated Hill's account, reporting that Hill said Thomas caused her to doubt her own professional abilities. On Sept. 19 Hill called Grant again. For the first time Hill said she wanted all committee members to know her story, even if her name had to be used. Hill insisted she didn't want to "abandon" her concerns about Thomas. The day before, she had given an interview to the University of Oklahoma student newspaper. Though she made no mention of harassment, she said "there were a lot of better" candidates than Thomas for the court vacancy.

Still, she was not willing to involve the FBI, a routine step Biden demanded before the issue could go further. Hill thought it over, concluding on Sept. 21 that she didn't want the FBI investigation because she was "skeptical about its utility." Finally, two days later, in what was at least the seventh conversation that week between Hill and the Judiciary staff, Hill said she would submit a statement of her charges to the committee and then agree to bring in the FBI. Throughout these September negotiations, some senators suspect Hill was in regular contact with aides to Kennedy and Metzenbaum, especially Brudney. Thomas's supporters point to them as the source of alleged arm-twisting on Hill. Sen. Dennis DeConcini, a Democrat, says it's apparent that "a Labor-committee aide was giving her advice." Similarly, the White House wonders if Metzenbaum and Kennedy staff badgered Hill into relenting on confidentiality.

Hill faxed her four-page statement to the committee on Sept 23. Biden passed it on to the White House and FBI. This was the first the Bush administration had heard of Hill's claims. White House counsel C. Boyden Gray ordered the FBI to investigate. While the president was briefed, he and his advisers perceived no ticking time bomb; they assumed the charges would prove false. FBI investigators questioned Hill the same day in Oklahoma. Over the next two days, the FBI also talked with Hoerchner and Thomas himself The nominee learned of the allegations when the FBI showed up at his suburban Virginia house to interview him; he denied the allegations. The FBI completed its report on the 25th. Sources who've seen it say it reads like a bad wire story, a collection of he-said, she-said quotes that reaches no conclusion. Nonetheless, the White House and Republican senators would eventually claim publicly that the report proved Hill wrong.

The White House sent Biden the report, along with a memo from Ken Duberstein, the former Reagan chief of staff hired to manage Thomas's confirmation machine. Biden and his defenders say Hill's desire for confidentiality precluded further investigation. "Talk about sexual

harassment," says a friend of Biden. "How could you pressure this woman?" Of course, he could have called Hill to Washington so that he could meet with her privately to assess her credibility. He could have summoned Hill and Thomas into a closed committee session, though that surely risked a leak. Or he or any other committee member with knowledge of the allegation could have asked for a delay in the vote, pending an attempt at further inquiry.

Biden made one obvious mistake. It was on the night of Sept. 25, after he had received the FBI report. Admittedly under pressure from the White House to get Thomas confirmed before the Supreme Court started its term Oct. 7, Biden scheduled the Judiciary vote on Thomas for Sept. 27. Yet he knew he wouldn't be briefing most of his fellow committee Democrats on the Hill charges until the 26th. That gave colleagues little chance to ask for a postponement of the vote. Biden says he or an aide verbally briefed each of the seven Democrats on the 25th or 26th, and that each had access to both the FBI report and Hill's statement before the vote on Friday the 27th. But some of the senators say Biden gave them short shrift; at least one was never told of the report, NEWSWEEK has learned. Moreover, Hill's statement was given to the other committee Democrats just 20 minutes before the vote--while Biden was on the Senate floor announcing his opposition to Thomas even as he vouched for his character.

Biden wasn't the only one who dropped the ball. NEWSWEEK has learned that Sen. Strom Thurmond, the ranking Republican on Judiciary, didn't tell all the five GOP members of the allegations. Arlen Specter, a wavering vote, first heard about Hill on Thursday (from two Democratic colleagues); he met with Thomas for 30 minutes the morning of the vote. Thurmond staffers told aides to Hank Brown of the charges, but said it contained "nothing of significance," according to Brown. Charles Grassley learned of Hill in newspapers more than a week later. Paul Simon, a Democrat, apparently is the only senator who spoke to Anita Hill prior to the Friday vote. Simon received a call from one of Hill's friends asking that he phone her. When they spoke on Thursday, Hill asked Simon to give her statement out to all 100 senators, but keep it otherwise confidential. Simon suggested that a leak would inevitably occur, so Hill decided against distribution.

Despite the 7-7 deadlock by the Judiciary Committee, Thomas's prospects for confirmation were excellent. The week of Sept. 30, moderate Democrats began declaring support. By Friday, Thomas by all counts had enough votes to win. Going into the weekend-with a full Senate vote scheduled for Tuesday-what could go wrong? "We thought this was in the bag," says a senior administration official.

Sunday is a sleepy day in the capital. Other than churchgoers, the only folks in stockings and ties seem to be on Brinkley. It was this calm that Newsday and National Public Radio disturbed on Oct. 6, when they ran stories on Hill's accusations. Actually, the administration and Thomas knew the night before that the Hill story was about to break. Duberstein turned on the spin cycle. Sen. John Danforth, the Missouri Republican and Thomas's chief patron, held an impromptu press conference at home. They had no idea this bombshell would turn out to be thermonuclear, with a chain reaction to match. Danforth should have listened to his wife. "I dismissed it and she didn't," he acknowleged to The New York Times.

On Monday morning, the Democratic Senate leadership maintained the vote on Thomas would proceed as scheduled the next day. The White House maintained a low profile, though aides did accuse the Democrats of a smear campaign. The assumption that the Hill charges would go away, however, evaporated when Anita Hill went on television. In a one-hour press conference beamed from Norman, Okla., Hill may have killed Clarence Thomas's career plans for the next 40 years. She was credible, she was articulate, she was poised--even in the face of enough menacing phone calls at home that she notified the police. "I resent the idea that people would blame the messenger for the message, rather than looking at the content of the message itself," she said. The political seismographs in Washington recorded the effect: women's groups mobilized, phones blew off the hook in the Senate.

Still, the White House continued to believe Thomas had the votes. Several key senators, NEWSWEEK has learned, told administration officials they needed some evidence, as one official put it, to "hide behind ... something that would allow them to say 'I considered his story and hers, and he's telling the truth'." Gray's office lined up women who worked with Thomas at EEOC who would sing his praises. At 4 p.m., Bush's team gathered to reassess the mess. No women were present. They concluded that, because Hill continued her relationship with Thomas long after she left EEOC, senators could be convinced that she could not possibly have viewed his alleged behavior as very serious.

Leak hunting became an obsession for Republican senators. Their suspicion centered on Metzenbaum, Kennedy and their staffs. Hatch accused Metzenbaum directly--who denied it--and he later apologized. Brown said he intends this week to ask for the appointment of a special counsel. The bad blood spilled over to the Democratic staffs. NEWSWEEK has learned that one meeting of all the chief lawyers for the Democratic members of Judiciary turned into a shouting contest. At issue was Biden's vivisection in the press by these lawyers being quoted anonymously. "People don't trust each other anymore," said a participant.
