## **EU-US Ministerial meeting 14 June, 2013**

### **Media Event – Launch of Annual Report of the Commission for the Support of Victims of Crime 2012**

1. Immediately following the EU-US Ministerial meeting in Dublin Castle, a media event will be held to launch the Annual Report of the Irish Commission for the Support of Victims of Crime 2012.

3. The President of Victim Support Europe, Mr. David McKenna (who is also the director of Victim Support Scotland), will then say a few words on the importance of the voluntary sector in supporting victims across Europe. He will also mention the importance of the EU Victims Directive and will make some remarks on enhancing cooperation between the EU and the US..
4. Vice President Reding, the US Attorney General, Commissioner Malmström and the US Secretary for Homeland Security will then be invited to speak briefly (about 2-3 minutes) on victims issues subject to confirmation of whether they wish to do so.
5. The three members of the Irish Commission for the Support of Victims of Crime, Mr Ray McAndrew (Chairperson), Mr. Terry Delany and Mr. Greg Heylin will be invited to attend this event.
