Dear Director Wray, Acting Director Vanech, Mr. Maher, and Director Ratcliffe:

The American people continue to learn disturbing details about the horrific insurrection at the U.S. Capitol and surrounding area on January 6, and the growing public record is still far from complete. The House Permanent Select Committee on Intelligence (the "Committee" or "HPSCI"), the Committee on Homeland Security, the Committee on the Judiciary, and the Committee on Oversight and Reform (collectively, the "Committees"), in exercise of their legislative and oversight jurisdictions, are reviewing the events of January 6 and related threats against the Nation's peaceful transition of power. The Committees will conduct robust oversight to understand what warning signs may have been missed, determine whether there were systemic failures, and consider how to best address countering domestic violent extremism, including remedying any gaps in legislation or policy.

As a first step, and as described in the annex to this letter, the Committees ask that your organizations produce relevant documents, and schedule briefings, regarding specific intelligence matters associated with the insurrection and threats to the U.S. presidential inauguration.

Security and logistical preparations before January 6 were not consistent with the prospect of serious and widespread violence. Yet, according to media accounts that have surfaced in recent days, federal and other authorities earlier on possessed — and may have shared with some parties — intelligence and other information forecasting a dire security threat against the

Congress's meeting to certify the election results.¹² These latter reports, if acted upon, might have prompted more extensive planning for the event, and the infusion of far greater security and other resources.

Tragically that did not happen. Emboldened by President Trump's inciteful rhetoric and his false claims of a stolen election — at the National Mall that day and for weeks before — a pack of violent insurrectionists forced their way into the Capitol complex with the intent to stop Congress from discharging its constitutional duties to certify the results of the presidential election. The mob caused extensive damage to persons and property. They assaulted woefully under-resourced U.S. Capitol Police officers and other security personnel, a great many of whom bravely resisted. They reportedly tried to steal one officer's gun, hoping to kill him with it, and injured another causing his death.³ They brought firearms, ammunition, explosives, tactical gear, and zip ties to detain potential victims.⁴ Some of them reportedly planned to take hostages and harm lawmakers. Among the riotous mob were suspected domestic violent extremists, including neo-Nazis, white supremacists, anti-government militia, and, most shockingly, current as well as former law enforcement officers and former military servicemembers.

This still-emerging story is one of astounding bravery by some U.S. Capitol Police and other officers; of staggering treachery by violent criminals; and of apparent and high-level failures — in particular, with respect to intelligence and security preparedness.

The Committees therefore request the records and briefings described in the annex attached hereto in pursuit of the following inquiries:

• What elements of the Intelligence Community ("IC") and federal law enforcement knew about threats of violence and destruction before, during, and after the insurrection; whether such information was shared with appropriate personnel and if so, how; whether any information was paused, delayed or withheld; and whether the insurrection had any nexus to foreign influence or misinformation efforts, and to what degree foreign powers have sought to exploit and aggravate the crisis;

- Whether any current or former holders of security clearances and/or of positions in U.S. national security, justice, defense or homeland security organizations participated in the insurrection; and
- The policy and other responses to the insurrection, to include any measures to identify, apprehend or prevent the travel of those who committed crimes, including any Domestic Violent Extremists.

The Committees expect and appreciate your full cooperation with this matter – while of course recognizing that resources appropriately and immediately must be allocated to efforts to counter any continuing threats to the transfer of power, including the presidential inauguration and related activities. The Committees stand ready to work with you to arrange for the requested production of documents and briefings.

The House Permanent Select Committee on Intelligence (the "Committee" or "HPSCI") the Committee on Homeland Security, the Committee on the Judiciary and the Committee on Oversight and Reform (collectively, the "Committees") respectfully request that, consistent with the protection of sources and methods, the Federal Bureau of Investigation ("FBI"), the Office of Intelligence and Analysis ("I&A") and other appropriate components of the Department of Homeland Security ("DHS"), and the Office of the Director of National Intelligence ("ODNI") and its National Counterterrorism Center ("NCTC") produce to the Committees, at the soonest opportunity but **by no later than 5 p.m. on February 15, 2021**:

- All intelligence whether raw or finished that refers or relates to events that could or ultimately did transpire on January 6, 2021, or refers or relates to threats in connection with the U.S. presidential inauguration, including all assessments, bulletins, notes, spot reports, situation reports, briefing materials for senior officials, or requests for assistance; and
- All documents or materials that refer or relate to events that could or ultimately did transpire on January 6, or refer or relate to threats in connection with the U.S. presidential inauguration.

Briefings

The Committees request briefings from your agencies as follows:

- FBI, DHS I&A, NCTC and others as appropriate:
 - A joint classified briefing to the Committees the week of January 22-26 regarding the extent of the Intelligence Community's ("IC") knowledge of a threat against the U.S. Capitol and surrounding area before, during, and after the January 6 attack; and/or in the days leading up to the U.S. Presidential inaugural. The briefing should address whether and how such information was shared with appropriate law enforcement and other counterparts; whether any was paused, delayed, or withheld; and whether the insurrection had any nexus to foreign influence or misinformation.
 - A joint classified briefing to HPSCI during the week of February 1-5 on how the Terrorism Screening Center ("TSC") and National Vetting Center (NVC) apply screening and vetting to Domestic Violent Extremists ("DVEs"), including support from the Intelligence Community to such efforts.

- FBI:
 - A briefing to HPSCI during the week of February 1-5, in coordination with the National Counterintelligence and Security Center ("NCSC") and any other applicable federal department or agency, on whether current or former holders of security clearances and/or of U.S. national security, justice, defense, or homeland security positions participated in violence or other criminal activity relative to the January 6 insurrection and attacks on the U.S. Capitol; and if so, any actions taken in response.
 - A briefing to the Committees during the week of February 1-5 to answer questions on specific concerns on the FBI's intelligence, information sharing and response.
- DHS I&A and other appropriate components of DHS:
 - A briefing to the Committees during the week of February 15-19 on the threat posed by DVEs and targeted violence and prevention programs to counter DVEs.
- NCTC:
 - A briefing to HPSCI during the week of February 8-12 on how NCTC is supporting FBI and DHS on DVEs, including but not limited to the January 6 insurrection and any transnational links between DVEs and other extremists.

• ODNI:

 A briefing to HPSCI during the week of February 8-12 on the efficacy of security clearance and background investigation processes intended to identify and mitigate threats posed by violent extremists, including the ongoing transition to recurrent vetting and the integration of rigorous checks of open source information and social media.

Acting Attorney General Rosen and Director Wray;

On Wednesday, January 6, an armed mob of domestic terrorists breached the walls of the United States Capitol to forcefully interfere with the certification of a free and fair national election. The terrorists, intent on executing a coup, threatened elected officials and staff, terrorized media professionals, destroyed federal property, and ultimately caused the death of five people, including a Capitol Police officer who was bludgeoned to death with a fire extinguisher. Many in the mob wore military or police tactical gear and carried zip-tie restraints, signaling a high level of preparation and coordination for the events that occurred.

This was an attack on our country. As the full extent of the insurrection unfolds, we fervently urge you to investigate the federal and state lawmakers directly involved, as well as those who, through words and conduct, aided and abetted sedition, treason or any other federal crimes.

The events of January 6 were not spontaneous, nor were they the random acts of a diffuse handful of unconnected individuals. For weeks prior to the breach, a group of Republican Arizona legislators and legislators-elect publicly advocated for the overthrow of the election results which encouraged precisely the kind of violent conduct that we witnessed.

Their own social media posts strongly suggest that Arizona State Representative Mark Finchem and former Representative Anthony Kern were present at the riot in Washington D.C. on January 6 and actively encouraged the mob, both before and during the attack on the Capitol. *See, e.g.*, <u>1-6-21 Twitter</u> <u>Post by Rep. Kern</u> (equating the rally to D-Day); <u>photos on the Capitol steps.</u> After the attack, Finchem and Kern sought to conceal the consequences of their conduct by falsely blaming "Antifa."

One of the riot's organizers, Ali Alexander, publicly claimed to have planned and organized the insurrection with Arizona Congressmen Paul Gosar and Andy Biggs; stating in a broadcast that "[W]e four schemed up putting maximum pressure on [C]ongress while they were voting..." <u>1-8-21 Twitter</u> <u>Thread Jason Paladino.</u>

They did all of this in public. What they did outside of plain view we do not yet know. But there is evidence to indicate that Arizona Representatives Mark Finchem, Anthony Kern, Paul Gosar and Andy Biggs encouraged, facilitated, participated and possibly helped plan this anti-democratic insurrection on January 6. It is vital to any current or future federal investigations, and ultimately to the Arizona public they represent, that we learn what these elected officials knew about this planned insurrection and when they knew it.

We the undersigned members of the Arizona Legislature, urge you to fully investigate the extent of their involvement. Expeditious timing of this request is critical, as if you find any evidence that these individuals incited, encouraged, or participated in the lawless behavior that took place on that day, we believe they would be potentially criminally liable and ineligible for public office under Section 3 of the Fourteenth Amendment to the United States Constitution, as having engaged in insurrection and rebellion¹.

Dear Mr. Vice President,

After the horrific attack on the Capitol yesterday, instigated by President Trump, we are writing to you to request you invoke Section 4 of the 25th Amendment to determine the President as unfit if he "is unable to discharge the powers and duties of his office."

This week's events were shocking and unprecedented in our nation's history. They amount to an attempted coup of our nation's legislative body to stop the certification of the electoral college results and the peaceful transition of power from one Administration to the next. President Trump's role leading up to and during the events have made it clear that he is unfit to remain in office for the next 13 days and poses imminent danger to our democracy.

His attacks on you, his own Vice President, his attempts to coerce the Georgia Secretary of State to illegally tamper with election results, his unfounded claims of widespread voter fraud denounced by Senate Majority Leader Mitch McConnell and not supported by the courts or states, and his insistence that he won the election in a landslide, all demonstrate he is a malignant narcissist and demagogue who is incapable of leading and protecting the country.

Equally alarming is his response to the rioters, from failing to provide necessary federal resources including the National Security Special Event designation; turning down the request of the DC Police to have the National Guard participate in the security of the event; failing to immediately deploy additional support once it became clear that the Capitol was breached; and calling the violent rioters "true patriots". Therefore, we urge you to expeditiously step in and move forward with invoking the 25th Amendment. Our democracy is at risk and we must explore every measure the Constitution affords us to remove him from office.

We request an immediate response.

Dear Director Wray:

We write to request an immediate and urgent briefing on the steps the Federal Bureau of Investigation (FBI) is taking to investigate and pursue for prosecution the instigation, planning, and execution of the deadly terrorist attack on the United States Capitol on January 6, 2021, by President Donald Trump, his supporters, and outside groups, as well as to disrupt any further activity designed to attack our government.

President Trump repeatedly incited his supporters to travel to the District of Columbia and carry out violence against the Capitol and Members of Congress. On December 19, 2020, President Trump published a tweet inviting his supporters to come to D.C., stating: "Statistically impossible to have lost the 2020 Election. Big protest in D.C. on January 6th. Be there, will be wild!"¹

At a rally yesterday morning, the President told his supporters that "we got to get rid of the weak congresspeople, the ones that aren't any good" and that "we fight like Hell and if you don't fight like Hell, you're not going to have a country anymore." President Trump ended his speech by telling his supporters, "We're going [to] walk down to the Capitol … you'll never take back our country with weakness. You have to show strength, and you have to be strong."²

The President's personal lawyer, Rudolph Giuliani, also spoke at the rally, encouraging the President's supporters to engage in "trial by combat" to overturn the results of the 2020 Presidential election. The President's son, Donald Trump Jr. warned Republican Members who supposedly do not support the President that "we're coming for you."³

Following the rally, thousands of the President's supporters followed his direction and marched to the Capitol with the goal of preventing Congress from certifying the November 2020 election. Some of the rioters were armed and carrying Trump campaign flags.⁴

As the violent mob stormed the Capitol, President Trump, who reportedly was watching the carnage unfold on television and "was initially pleased by the disturbance."⁵ When President Trump finally released a videotaped statement several hours later, he repeated his false claim that the election was "stolen" and praised the insurrectionists, telling them, "We love you."⁶

In response to President Trump's dangerous behavior, former Attorney General Bill Barr stated that "[o]rchestrating a mob to pressure Congress is inexcusable" and that the President's conduct was a "betrayal of his office."⁷

The attack against the United States Congress resulted in the deaths of at least four people, endangered Members and staff and law enforcement officials, caused damage to the U.S. Capitol building, and disrupted Members of Congress from fulfilling their constitutional responsibility to certify the results of the 2020 Presidential election.

Given the incendiary environment caused and exacerbated by President Trump's rhetoric, along with the upcoming inauguration of President-Elect Joe Biden, it is imperative that the FBI leverage all available assets and resources to ensure that the perpetrators of this domestic terrorist attack and those who incited and conspired with them are brought to justice, and that this domestic terrorist group is disrupted from further actions against our government.

We request an urgent briefing for the Chairs and Ranking Members of the undersigned Committees on how the FBI is working to investigate and hold responsible the domestic terrorists who incited and executed yesterday's attack on the Capitol, as well as how the FBI has been tracking this domestic terrorist group, how it prepared for the events on January 6, 2021, and how it plans to disrupt any further violent plans. This briefing should include detailed information about how the FBI is working to collect evidence and to track these individuals. Please contact our staffs to schedule the briefing.

Dear Mr. Wolf and Director Wray:

We write today regarding the violent insurrectionist acts that took place at the United States Capitol on January 6, 2021, and for information into your agencies' actions leading up to and understanding of the digital environment surrounding the attack. While it is clear that the mob of domestic terrorists, neo-Nazis, and white supremacists was directly incited by President Trump at his preceding rally on the National Mall, many of these extremists were already communicating online and on social media about potential violence and plans to occupy the United States Capitol building in the days and weeks before it unfolded.¹

Since the president lost re-election, he has stoked false and unsubstantiated claims that the election was stolen from him and that actions must be taken to overturn the results. This disinformation spread across digital platforms, fomenting a sharp uptick in reactionary calls for violence. Just from January 1st, there were more than 1,250 posts from QAnon conspiracy theorists on Twitter containing terms of violence. And violence was also specifically directed at Congress. For example, on Facebook, one user wrote in a far-right private group entitled "Joe Biden is not my President" on January 5, "There will be a BIG Civil War if Congress allows the election to be stolen."² On TikTok, videos were posted with close to 279,000 views that promoted violence at the Capitol, calling for people to bring their "mother-[expletive] guns".³ Several threads on mainstream platforms like Reddit and Twitter, and alternative platforms friendlier to those on the far-right like Gab and Parler, contained content for weeks that specifically alluded to planning the violence that took place on January 6. Those at the helm

planning this insurrection even had enough time to create merchandise to wear for the event labeled with things like, "MAGA, Civil War, January 6, 2021".⁴

While this latest sharp increase in violent chatter online is a result of the president's stoking of proven falsehoods, we have seen a steady increase in online extremist and domestic terrorist coordination over the past several years. In 2019, the Federal Bureau of Investigation labeled fringe political conspiracy theories as a domestic terror threat and an intelligence bulletin from the Agency warned of "anti-government, identity-based, and fringe political conspiracy theories very likely to motivate some domestic extremists to commit criminal, sometimes violent activity".⁵ The Department of Homeland Security and Federal Bureau of Investigation are both tasked with operations to track online extremist developments and prevent their enaction. However, there have been some notable failures when it comes to preventing violent extremists from orchestrating events that lead to violence, such as at the "Unite the Right" Neo-Nazi rally that occurred in Charlottesville, Virginia in 2017 and resulted in a domestic terror attack which caused loss of life.⁶ January 6 is as another such failure, and one that placed the foundation of democracy under threat.

Fundamentally, we are concerned that law enforcement was seemingly unprepared for the mob that descended on the Capitol on January 6, despite the hundreds of thousands of posts spread about it publicly online. It is implausible that the federal law enforcement agencies tasked with defending the United States against acts of terrorism would not have been aware of and tracking the online ecosystem leading up to this attack. To that end, we respectfully request a response to the following questions by January 15, 2021, and include, if necessary, a classified addendum:

- 1. Did your agencies anticipate a credible threat of violent activity based on the social media posts leading up to the January 6 attack? If so, what groups were involved and how were they organizing?
- 2. Describe the nature of communication with the White House or any political appointees regarding the online threat landscape leading up to January 6.
- 3. Did your agencies notify the relevant law enforcement entities of the threats of violence, including through the dissemination of intelligence bulletins, to other law enforcement agencies? If so, when did this occur?
- 4. Have your agencies adequately shifted resources, personnel, and training to monitor and find domestic extremism in the online ecosystem?
- 5. The members of the mob were livestreaming their activities on social media. What was the level of monitoring and information sharing in realtime that your agencies provided to local law enforcement and other authorities?
- 6. Did your agencies have any communication with the online platforms regarding the violent extremist content? If so, what did this communication entail and when did it occur?

Protester Who Stormed U.S Capitol Identified as Prominent QAnon Activist, Spread Inflammatory Conspiracy Theories Across Social Media



One of the pro-Trump protesters documented breaking into the U.S Capitol building has been identified as a prominent QAnon activist from Arizona who used his presence on social media to disseminate incendiary antigovernment conspiracy theories.

Known for his attendance at previous pro-Trump protests where he often appeared dressed in fur, head dresses, and other "tribal" clothing and loudly espoused various QAnon conspiracy theories photos of Jacob Chansley (who

also goes by the name Jacob Angeli) have been circulating the internet showing the activist among the violent mob of Trump supporters who breached the U.S Capitol during the "Stop the Steal" protest in Washington D.C.

On his Facebook account, Chansley regularly posted pro-Trump and QAnon-related content: heavily pushing voter fraud, "Satanic" child sex trafficking ring, Coronavirus, "Deep State," and other anti-government conspiracy theories. Examples of these posts follow:

On December 13, 2020, Chansley posted photos documenting his attendance at the December 12 "Million MAGA" protest in the U.S capital holding signs that read "Q Sent Me" and "Hold the Line Patriots," seen below:



Notably, on November 30, 2020, Chansley posted photos of himself shaking Trump's advisor and lawyer Rudy Giuliani's hand, appearing to boast a direct connection to the President to his QAnon followers:



Chansley also ran a YouTube account to which only one 9 minute, 25 second video has been uploaded. On February 27, 2019, Chansley referring to himself in the video under the alias "Yellowstone Wolf - posted the video titled "Secrets Of The Universe: Energy, Frequency & Vibration" in which he explores spiritual and "cosmic" philosophies. Further, Chansley maintained a more active "Yellowstone Wolf" channel on the video hosting platform Bitchute, where he has uploaded 15 videos promoting anti-government conspiracies relating to topics such as CIA "sex trafficking," alleged "crimes" of "treasonous" U.S government official and media outlets, underground "slave trades," "leftist psychological warfare," "communist black magic," voter fraud, among many other outlandish theories.

He is also supposedly the author of a book known as "One Mind At A Time: A Deep State of Illusion," which claims to "exposes the history, strategy, & goals of the Deep State in detail."

(U) Overview: The US Capitol has been cleared and Congress reconvened at 2000 ET 6 Jan, after

protestors breached the US Capitol building. At 0345 ET Congress adjourned after certifying the Electoral College results.

(U) The DC Police Dept announced 14 Metro Police Officers were injured, one seriously. There were four deaths (one shot, one heart attack, and two other medical emergencies) within and around the Capitol grounds on 6 Jan. Approximately 52 people were arrested during the conflict, 26 on Capitol grounds.

(U) The DC Mayor has declared a State of Emergency for a total of 15 days, expiring at 1500 ET on 21 Jan. The Mayor also ordered a District-wide curfew which started at 1800 ET 6 Jan and will continue until 0600 ET 7 Jan. As of 0041 ET, 7 Jan, there have been approximately 40 arrested for curfew violations. DC Metrorail and Metrobus service ended service early on 6 Jan, however normal service will resume today.

(U) The Governor of VA also ordered a citywide curfew for the City of Alexandria and for Arlington County from 1800 ET 6 Jan until 0600 ET 7 Jan. The VA National Guard has been activated to support law enforcement in DC. The Governor of MD has sent State Troopers and has called 500 members of the MDNG up to support law enforcement in restoring order. The Governor of NY has deployed 1,000 members of the National Guard to Washington DC for up to two weeks. The Governor of NJ has deployed 50 State Troopers to assist.

The rest were arrested because of disobeying the curfew put in place by DC's Mayor Bowser from 6 p.m. on Wednesday until 6 a.m. on Thursday. Of those arrested, multiple people were not from the DMV area, according to the information provided on those charged by DC Police. Some of the states that these people charged are from including Michigan, Colorado, Texas and North Carolina.

Riot Response Hampered by No Clear Federal Chain of Command

Even after the federal authorities declared the U.S. Capitol Building cleared of riotous protesters supportive of President Donald Trump, remaining mobs of protesters streaming across district and state lines pose a lingering threat that the officials say the federal government is failing to sufficiently address.

Washington, D.C. Mayor Muriel Bowser has mobilized the entirety of the District's National Guard force to quell violent demonstrations that disrupted congressional proceedings to certify President-elect Joe Biden. She has requested backup from neighboring Virginia, where Governor Ralph Northam has also declared a state of emergency as a result of ongoing unrest in the area.

But with no federal agency taking charge outside of federal property, one member of the D.C. National Guard currently on orders in the District, who spoke to Newsweek on the condition of anonymity, described a chaotic atmosphere that left the chain of command unprepared and unclear.

"What's most concerning is the lack of preparation here," the DC National Guard member said. "I don't know who in the chain of command dropped the ball. There was no plan and we were not in position when we needed to be."

With one woman shot dead during the siege, armed standoffs within the congressional chambers and multiple potential explosive devices discovered, the level of danger was clear, and the DC National Guard member felt irresponsibly placed in harm's way.

"We are also put at a needless risk," the DC National Guard member said, "going out to face a mass act of terrorism with no body armor or weapons."

The storming of the Capitol following repeated calls by Trump to challenge Biden's electoral certification is the first attack on the building since British forces burned the iconic structure more than two centuries ago. during the War of 1812,

"The rest of the world of is waking up to images of the U.S. Capitol being seized," a senior U.S. intelligence official told Newsweek. "This has not happened since 1814."

While federal agencies have offered assistance, no agency has been designated to be the lead agency to an expanding threat.

Now scenes of related disorder are reportedly appearing in other cities including Los Angeles, where bloody brawls broke out between Trump supporters and members of the Black Lives Movement, and in Olympia, Washington, where armed protesters have attempted to break into Governor Jay Inslee's residence. Gunmen also gathered at the Oregon capital of Salem to support Trump's efforts to overturn his electoral loss to Biden.

The FBI is among the federal agencies responding to the riot, though their role—like other agencies—is limited to providing assistance to the U.S. Capitol Police tasked with protecting the legislative building.

"The FBI has been deployed to assist our U.S. Capitol Police partners as requested in protection of federal property and public safety," an FBI spokesperson said in a statement sent to Newsweek.

The Pentagon is also on standby. Acting Defense Secretary Chris Miller issued a statement activating the D.C. National Guard to assist Capitol Police and offer additional services.

"We are prepared to provide additional support as necessary and appropriate as requested by local authorities," Miller said. "Our people are sworn to defend the Constitution and our democratic form of government and they will act accordingly."

The Department of Homeland Security reported that its personnel were also assisting Capitol Police.

"Federal Protective Service and Secret Service have been requested to provide assistance to Capitol Hill Police. They are fulfilling that request," a DHS spokesperson told Newsweek. "The Department of Homeland Security has stood up the DHS Virtual Situation Room to facilitate department and interagency communication and coordination, as we do for many large events in D.C."

Trump offered conflicting messages to the crowd, first telling them to remain peaceful before asking them to return home and then praising their efforts via Twitter, which then locked his account. His actions have caused many in the Republican Party to turn on him and condemn his inflammatory rhetoric.

One of the president's former political appointees to DHS described the situation to Newsweek as "an embarrassment to conservatives everywhere."

Multiple air traffic controllers in New York heard a chilling threat Monday in audio obtained exclusively by CBS News: "We are flying a plane into the Capitol on Wednesday. [PII removed] will be avenged."

The FBI and the Federal Aviation Administration (FAA) are investigating the message.

The threat refers to an Iranian official killed last year in a U.S. drone strike ordered by the United States. It was made on the one-year anniversary of the Iranian official's death, for which Iranian officials have long vowed revenge.

It's unclear who sent the threat. While the government does not believe the warning of an attack is credible, it is being investigated as a breach of aviation frequencies, CBS News has learned.

Sources told CBS News that the Pentagon and other agencies were briefed Tuesday about the digitized voice recording. The sources said they believe the threat was designed to suggest hitting the Capitol on the same day the U.S. Congress is set to count the Electoral College results.

Experts said the intrusion is concerning because it could affect the instructions pilots get about how and where planes fly.

Sources told CBS News a message was sent to air traffic controllers on Tuesday reminding them that any threat or a plane deviating from its flight path should be reported immediately.

The FBI is not commenting but said it takes "all threats of violence to public safety seriously." The FAA said it is in contact with law enforcement.
