SAC offered they could help with surveillance - including surveillance vans and equipment.



(U) Executive Summary

(U//FOUO) As of 30 May 2020, civil unrest erupted sporadically in several U.S. cities after the 26 May 2020 death of Minnesota-based George Floyd while in law enforcement custody. (b)(7)(E) per FBI [redacted]. The unrest is impacting multiple FBI field offices with major protests, rioting, and looting in Minneapolis, Atlanta, Los Angeles, San Francisco, and Washington, D.C. Activities have included Molotov cocktails, blockades, looting, arson, vandalism of property, scaling building walls, graffiti, rocks and bottles thrown at law enforcement. Due to this activity, many cities and states have declared a state of emergency.

(U//FOUO) George Floyd's body is scheduled to arrive in Houston on Sunday, 31 May 2020. His funeral is scheduled for Wednesday, 3 June 2020.

[REDACTED] The unrest is impacting multiple FBI field offices with major protests, rioting, and looting in Minneapolis, Atlanta, Los Angeles, San Francisco, and Washington, D.C. Activities have included Molotov cocktails, blockades, looting, arson, vandalism of property, scaling building walls, graffiti, rocks and bottles thrown at law enforcement. Due to this activity, many cities and states have declared a state of emergency.

(U//~~FOUO~~) George Floyd's body is scheduled to arrive in Houston on Sunday, 31 May. His funeral is scheduled for Wednesday, 3 June, in the vicinity of Ft. Bend County, Texas.
