TRUMP EXECUTIVE ORDERS ON LAW ENFORCEMENT HAVE TOTAL SUPPORT FROM FOP

Chuck Canterbury, National President of the Fraternal Order of Police, said that his members "fully and totally" support the Executive Orders signed today by President Donald J. Trump.

"As a candidate, Donald Trump made it clear to our members that law enforcement was a priority for him," Canterbury said. "The orders he signed today on officer safety, crime reduction and fighting transnational criminal organizations like the cartels is just further evidence that his word is good and that this President will deliver on his promises."

One of the Executive Orders directs the U.S. Department of Justice, now headed by U.S. Attorney General Jefferson B. Sessions III, to develop strategies and pursue legislation to "enhance the protection and safety of Federal, State, tribal and local law enforcement officers."

"In 2016, 253 officers were shot in the line of duty, 64 of whom were killed by gunfire. Of those killed, 33% were murdered in targeted assassinations simply because of the uniform they wear," Canterbury said. "We have discussed our hate crimes expansion bill with the President on previous occasions and we hope that in the development of the Administration's officer safety strategy this issue is given serious consideration."

A second Executive Order creates a Task Force on Crime Reduction and Public Safety to develop new and improved strategies to reduce crime in our nation's communities. A third Executive Order directs the Departments of Justice, State and Homeland Security as well as the Director of National Intelligence, to develop strategies to combat transnational criminal organizations trafficking in human beings, weapons, and drugs.

"Here again, the President makes it very clear that law enforcement must be a priority and is going to ensure that local and State law enforcement agencies have the resources they need to make America safe again," Canterbury said. "In addition, he makes clear that fighting the cartels and other organized criminal enterprises will be a priority for Federal law enforcement agencies."

"We could not be more pleased by the news from the White House today," Canterbury said. "We look forward to playing a big role in helping this Administration shape its strategies on officer safety, crime reduction and the fight against the cartels. I'm confident in President Trump's leadership."

In addition to noting your prior/current government roles, the piece touches on your work for the Chamber of Commerce and the companies and interest groups you represented in private practice. The article also notes that while at the Chamber you teamed up often with Sidley -- where your husband works -- on cases challenging Obama regulations, ect. I realize you're probably not in a position to comment but want to make sure you're aware of what we're writing in case you'd like to. If you have someone you think I should talk to, let me know.

One question I do have is when you relinquished your chief counsel role at the Chamber and whether you have a current relationship with the group. A Lawyers for Civil Justice brochure from 2015 notes that you're a senior advisor to the Chamber. I have a query into the Chamber on this.

WASHINGTON - On his first official day serving as the 84th Attorney General of the United States, Jeff Sessions arrived at the Justice Department and met with top department leadership right after greeting department employees in person and through a video message.

Following a visit on Capitol Hill with Luther Strange, who was appointed by Alabama Gov. Robert Bentley to fill Attorney General Sessions' vacancy in the Senate, Attorney General Sessions received his first Foreign Intelligence Surveillance Act briefing from national security staff.

The Attorney General later met with the senior officials from the Justice Department's law enforcement components, including FBI Director James Comey, Bureau of Alcohol, Tobacco, Firearms and Explosives Acting Director Thomas Brandon, U.S. Marshals Service Acting Director David Harlow and Drug Enforcement Administration Acting Administrator Chuck Rosenberg. They had a vigorous discussion about how to combat the rise in violent crime and prevent drug-related deaths. They expressed their shared commitment to strengthen law enforcement and save lives.

Attorney General Sessions also called top leadership of the National Urban League and National Association for the Advancement of Colored People to build positive relationships and outline his priorities for the department of justice, including his commitment to maintain sound policies for civil rights and voting rights.

VIDEO STATEMENT OF ATTORNEY GENERAL JEFF SESSIONS TO ALL DEPARTMENT OF JUSTICE EMPLOYEES

I love the Department of Justice. There is nothing I have ever done that I am more proud of than serving it for 14 years, first as an Assistant United States Attorney, then for 12 years as United States Attorney. It was a glorious time indeed. I was in court regularly working with the greatest law enforcement officers in the world. Supervising dedicated and talented Assistant U.S. Attorneys, appearing before great federal judges. Some of those with whom I worked are still in service and many equally talented people have joined the Department in the intervening years.

You can know that I respect and value this Department and that I will support the men and women who work here. And, importantly, I know the critical role we all play in maintaining and strengthening the rule of law which forms the foundation for our liberty, our safety, and our prosperity. In this rule of law, we are blessed beyond all nations. And at this department we must do all we can to ensure that it is preserved and advanced.

Such ideals transcend politics. When one is standing in court, representing the United States, there is no place for partisanship or bias. I want you to know I will do my best to be worthy of this trust I have been given. I cannot do it alone. I need you. Each of us must work together to fulfill our responsibility. We will defend our constitutional order regardless of personal or political preference. We will ensure a fair administration of justice where all must believe that they can and will receive equal justice under the law regardless of their station or position in life. Ours is a profound responsibility. In the world of public service, there is no higher calling.

We may come from different backgrounds and we may have different approaches, but I will seek your advice and counsel as we go about making the important decisions of this office. Our goal is to find the right solution to the challenges of our time and then to uphold the law.

That is the goal I was dedicated to as U.S. Attorney and what I will dedicate myself to as your Attorney General.
