

# Whittier police officer killed in shootout, suspect may be involved in separate homicide

WHITTIER >> One officer was killed and another injured in a shootout Monday with a 26-year-old suspected gang member who may have been involved in a separate homicide in East Los Angeles, authorities said.

Whittier Police Chief Jeff Piper identified the deceased officer as 28-year-veteran Keith Boyer of Whittier and the wounded officer as Patrick Hazell, also of Whittier.

“Keith was very humble; he was always smiling, positive, energetic and intelligent,” Piper said. He broke into tears. “He was the best of the best.”

Hazell, who has been with the department for three years, was in stable condition at UC Irvine Medical Center, said Lt. John Corina of the Los Angeles County Sheriff’s Department Homicide Bureau. The suspect, who was wounded and has not been identified, is a known gang member and was released on parole about a week ago, authorities said. He is also a suspect in a homicide that occurred a few hours earlier in East Los Angeles.

Corina said the suspect, who was transported to Los Angeles County-USC Medical Center, was expected to live.

The officers were responding to a traffic collision about 8 a.m. in the area of Mar Vista Street and Colima Road when the shooting occurred, authorities said.

Corina told reporters at the scene the suspect had crashed a stolen vehicle into two other vehicles while traveling south on Colima. The drivers of the other vehicles had helped the suspect push his vehicle around the corner onto Mar Vista before officers arrived.

When officers did arrive, they turned the corner to talk to the suspect who immediately opened fire, striking both officers. They returned fire, striking the suspect.

The officers “were just responding to a report of an accident,” Corina said during an afternoon press briefing. “The next thing they knew, they were in a gunfight. Now we have a dead police officer.”

## POLICE CHIEF'S PLEA

While talking about the case at a press conference at the city's Police Memorial, authorities attributed the homicide to Assembly Bill 109, a state law mandating early prison releases, and Proposition 47, which turned some felony offenses to misdemeanors.

AB 109 was signed into law by Gov. Jerry Brown in 2011 and Proposition 47 was approved by voters in 2014.

"We need to wake up. Enough is enough. You're passing these propositions, you're creating these laws. ... It's not good for our community (and) it's not good for our officers," Piper said. "You have no idea how it's changed in the last four years. We have statistics to show it."

Corina said he did not know why the suspect was released or what his prior charges were, saying investigators still needed to talk to his probation officer.

## SEPARATE HOMICIDE CONNECTION?

Corina said the vehicle the suspect was driving when he crashed in Whittier was reported stolen from East Los Angeles, where at about 5:29 a.m. a man was shot to death in the 1400 block of Volney Drive, according to sheriff's officials.

Witnesses to the East Los Angeles shooting have identified the suspect in the Whittier shooting as the man who shot and killed the victim, Corina said.

Family members on Monday identified the victim as Roy Torres. They said the suspect is Torres's cousin.

The family members said Torres [was shot to death in his bedroom at his parents' hillside home overlooking Cal State LA.](#)

Johnny Garcia, 28, of Whittier, is another cousin of Torres. He said Torres loved to barbecue steak and lobster and was an all-around caring guy. He was also a peacemaker, Garcia said late Monday evening.

Garcia said everyone was asleep in the house when the shooting occurred and that Torres' mother didn't hear anything.

"Roy was in the (converted) garage with Victoria (his girlfriend of five months). This guy came into his house and stole his car," Garcia said. "I don't know what they could have been arguing about. Roy never yelled. I never heard him raise his voice."

## A FATHER NEAR RETIREMENT

Boyer, a father and grandfather, was a couple of years away from retirement, said Jeff McNeal, his friend and band mate.

"He was genuinely the nicest guy you'd ever want to meet, and he had a great joy of performing music and bringing smiles to people," said McNeal, the lead vocalist and founder of

the Temecula rock band Mrs. Jones' Revenge. "He was proud of the work that he did, and we were proud of the work that he did both on and off the stage."

McNeal said Boyer was a lifelong resident of Whittier. The two met several years ago through a mutual friend, and in 2014, when the band was in need of a drummer, McNeal gave Boyer a call.

"He was an exceptional musician," McNeal said. "When he joined our band, he elevated us to a new level that wouldn't have been possible. His skill was such that we were able to play more challenging, more difficult songs."

Whittier police Officer John Scoggins said Boyer was the third in the city's history to be killed in the line of duty, the first since 1979.

The city of about 85,000 has a force of 128 sworn officers. The department also serves Santa Fe Springs.

A vigil for the officers was scheduled for 6 p.m. Monday at the city's Police Memorial.

"Two of our family members have been shot and one of them has passed away," said Councilman Fernando Dutra. "We are in mourning and in prayer for them and the families. We're focusing on what we need to do to support the families and all of the police officers."

In a statement, Los Angeles County Supervisor Janice Hahn, whose district includes the city of Whittier, said she was heartbroken over the death of the officer.

"It is a tragic reminder that every day, police officers risk their own lives to protect and serve their communities," Hahn said in the statement. "My heart is with the family of this fallen officer and his colleagues in the Whittier Police Department as they grieve the loss of one of their own and as we continue to pray for the recovery of the officer who was wounded in this morning's incident."

#### **VIGIL HELD FOR OFFICERS**

Mourners [by the thousands lit candles and listened to speeches](#) outside the Whittier Police Department headquarters hours after the report of Boyer's death.

"This has been a very, very difficult day," Whittier Mayor Joe Vinatieri said, but "by you coming here, you told the men and women of this department that you care."

Police estimated about 2,000 people gathered outside the headquarters to remember Boyer.

Many of the residents who showed up brought flowers and candles to pay their respects at the Whittier Police Memorial.

Chief Piper talked about Boyer's dedication to his job.

"He gave his heart and soul to these communities," he said referring to Whittier and Santa Fe Springs, which has been patrolled by Whittier police since 1995.

Piper said funeral arrangements are pending.

- **CBS News on AG Sessions Rescinding Yates memo on BOP's Use of Private Prisons.** CBS Evening news is running a segment tonight on the decision by Attorney General Sessions to rescind a memorandum from former Deputy Attorney General Sally Yates to BOP meant to reduce reliance on private prisons. The segment raises questions about safety and security at private prison facilities outlined in an OIG report and also questions whether the private prison industry's support of the Trump administration influenced the decision. A DOJ spokesman provided the following statement: "This decision returns discretion to the professionals at BOP who are in the best position to evaluate their needs. We are aware of the OIG report and recommendations and the Bureau of Prisons is continuing to take appropriate measures to ensure the safety and security of all facilities under its supervision. This was an operational level decision made with the support of career professionals at the Justice Department who advised the Attorney General."
- **Media Reports on Number of Individuals Encountered at U.S. Ports of Entry after Executive Order.** Media is reporting on yesterday's filing and today's hearing in the Eastern District of New York in *Darweesh v. Trump* that the federal government held 746 people between Saturday night, Jan. 28 and the end of the day on Sunday, Jan. 29. The department's cover letter accompanying the list was provided to press by the plaintiffs' lawyers. In the filing, the department lawyer referred to the list as consisting of all people "encountered or undergoing processing ... pursuant to the Executive Order" during the relevant time period. The letter also notes that "this list includes legal permanent residents." The statement from the plaintiffs' lawyers also noted, "the identities of the 746 individuals were disclosed to Darweesh counsel under a protective order that prevents their release to the general public." A copy of the protective order was signed by the judge in the case on Thursday. The department declined to comment beyond the public filings and arguments in court.

- [NPR on Expected Rise in Border Fence Litigation.](#) The NPR southwest border correspondent ran a five minute segment on the history of litigation from the

government's use of imminent domain to build border fencing along the U.S. Mexico border, and anticipating an increase as the Trump administration has vowed to expand the border barrier. It included an interview with Judge Hanen in the Southern District of Texas. The department provided background on the land acquisition litigation but did not participate in the on-air story.

- **Eleven Individuals and One Company Charged in Florida with Exporting Prohibited Articles to Syria (National Security Division)** Ali Caby, aka “Alex Caby,” 40, a U.S. permanent resident currently residing in Bulgaria; Arash Caby, aka “Axel Caby,” 43, of Miami; and Marjan Caby, 34, of Miami, Florida, were arrested and charged with exporting prohibited dual-use goods to Syria, in violation of the Syria trade embargo, commerce regulations and a U.S. Department of Treasury designation based on an Indictment charging eleven individuals and one foreign company. The dual-use goods were exported to Syrian Arab Airlines, the Syrian government’s airline, which is an entity designated and blocked by the U.S. Department of the Treasury’s Office of Foreign Assets Control for transporting weapons and ammunition to Syria in conjunction with Hizballah, a terrorist organization and the Iranian Revolutionary Guard Corps. Also charged in the indictment were Adib Zeno, Rizk Ali, Ammar Al Mounajed, Zhelyaz Andreev, Mihaela Nenova, Lyubka Hristova, Iskren Georgiev, Ivan Sergiev and Syrian Arab Airlines.
- **Virginia Man Sentenced to 11 Years in Prison for Attempting to Provide Material Support to ISIL (National Security Division)** Mahmoud Amin Mohamed Elhassan, 26, of Woodbridge, Virginia, was sentenced today to 11 years in prison and 10 years supervised release for attempting to provide material support and resources to the Islamic State of Iraq and the Levant (ISIL), a designated foreign terrorist organization, and making false statements to the FBI. Elhassan, who is originally from Sudan, pleaded guilty on Oct. 24, 2016. According to court documents, Elhassan aided and abetted the attempt of Joseph Hassan Farrokh, 29, also of Woodbridge, to travel from the U.S. to Syria in order to fight on behalf of ISIL.
- **Member of Mexican Sex Trafficking Ring Sentenced to 188 Months in Prison Term for Sex Trafficking Scheme (U.S. Attorney’s Office for the Eastern District of New York)** Paulino Ramirez-Granados, a member of the Granados family sex trafficking ring, based in Tenancingo, Tlaxcala, Mexico, was sentenced today to over 15 in prison and five years of supervised release by U.S. District Judge Kiyo Matsumoto of the Eastern District of New York, for trafficking young Mexican women into the United States and forcing them into prostitution. He was also ordered to pay restitution to Jane Doe #1 in the amount of \$1,229,760. Ramirez-Granados is the latest member of the Granados organization to be sentenced in this case since 2013.
- **Administrator of Miami-Area Home Health Agency Sentenced to 126 Months in Prison for Involvement in \$2.5 Million Medicare Fraud Scheme (Criminal Division)**

Raciel Leon, 42, of Miami, the administrator of a Miami-area home health agency was sentenced before U.S. District Judge William J. Zloch of the Southern District of Florida to a 126 month prison term for his role in a \$2.5 million Medicare fraud scheme. In December 2016, he was convicted after a two-week jury trial of one count of conspiracy to commit health care fraud and wire fraud and one count of conspiracy to defraud the United States and pay and receive health care bribes and kickbacks. Ten of Leon's co-conspirators previously pleaded guilty, or were convicted at trial, in this and other related cases filed in the Southern District of Florida.



WASHINGTON—U.S. investigators have examined contacts Attorney General Jeff Sessions had with Russian officials during the time he was advising Donald Trump's presidential campaign, according to people familiar with the matter.

The outcome of the inquiry, and whether it is ongoing, wasn't clear, these people said. The contacts were being examined as part of a wide-ranging U.S. counterintelligence investigation into possible communications between

members of Mr. Trump's campaign team and Russian operatives, they said.

The Federal Bureau of Investigation, which has been leading the investigation, didn't immediately respond to a request for comment. The White House directed requests for comment to the Justice Department.

During his confirmation hearing for attorney general in January, Mr. Sessions, a Republican senator from Alabama, testified under oath that he had no contact with Russian officials as a campaign surrogate and never discussed the 2016 election with Russian officials.

But Mr. Sessions spoke with the Russian ambassador to the U.S., Sergei Kislyak, while the Republican National Convention was under way in Cleveland last summer, according to his spokeswoman, Sarah Flores. He also spoke with Mr. Kislyak on another occasion last year, by phone from his Senate office, she said.

Ms. Flores said the contact last July occurred when Mr. Sessions spoke at a Heritage Foundation event attended by Mr. Kislyak in Cleveland, appearing in his capacity as a senator, not a campaign official. She said several

ambassadors approached Mr. Sessions after his speech at the Heritage Foundation event, including Mr. Kislyak.

"It was short and informal," she said.

She said the attorney general wasn't aware that his communications have been under investigation.

During his confirmation hearing in January, Mr. Sessions was asked what he would do if any evidence emerged that someone affiliated with the Trump campaign communicated with the Russian government during campaign and said: "I'm not aware of any of those activities."

"I have been called a surrogate at a time or two in that campaign and I didn't have—did not have communications with the Russians, and I'm unable to comment on it," he said.

Ms. Flores said Mr. Sessions wasn't required to disclose the contacts because they took place in his capacity as a senator, not a campaign official.

"The attorney general has been very clear that as a senator he had conversations with the Russian ambassador," Ms. Flores said in a statement. "Last year, the senator had over 25 conversations with foreign ambassadors as a senior member of the Armed Services Committee, including the British, Korean, Japanese, Polish, Indian, Chinese, Canadian, Australian, German and Russian ambassadors."

The focus of the U.S. counterintelligence investigation has been on communications between Trump campaign officials and Russia. The inquiry involving Mr. Sessions is examining his contacts while serving as Mr. Trump's foreign-policy adviser in the spring and summer of 2016, one person familiar with the matter said.

The investigation is being pursued by the FBI, Central Intelligence Agency, National Security Agency and Treasury Department, officials have said. Counterintelligence probes seldom lead to public accusations or criminal charges.

However, the probe, if ongoing, could create a highly unusual and sensitive political dynamic given that the FBI is part of the Justice Department that Mr. Sessions as attorney general, now leads. Mr. Sessions has only been in office for under a month and the investigation began before he was nominated and approved by the Senate.

The FBI's role in the investigation into Mr. Sessions' conversations left the agency "wringing its hands" about how to proceed, said one person familiar with the matter.

Mr. Trump asked for the resignation of his national security adviser, Mike Flynn, after Mr. Flynn misled Vice President Mike Pence over the nature of a conversation he had in December with Russia's ambassador to the U.S.

The White House has denied any inappropriate interactions between associates of Mr. Trump and Russian officials. Asked during a news conference in February if anyone advising his campaign had contact with Russia during the campaign, Mr. Trump said "nobody that I know of."

Committees in the House of Representatives and the Senate are investigating Russia's alleged involvement in the election campaign and possible ties or communication between Russian officials and the Trump campaign.

Russia has denied interfering in the U.S. election, blaming accusations on American politicians who want to sabotage relations between the two countries.

Some Republicans contend that the Russia investigations are politically motivated and are being pushed by people who were furious that the FBI, led by its director, James Comey, continued to investigate Hillary Clinton's emails late into the 2016 election campaign. These Republicans say that the Russia investigations will prove to be without foundation.

Until this week, Mr. Sessions had resisted calls to remove himself from any role investigating possible ties between Trump associates and Russia. Democrats have said he should do so because of his place advising the Trump campaign.

On Monday, he suggested he would take himself off a case under certain circumstances, though he left out any specifics. Mr. Sessions told reporters he would "recuse myself on anything that I should recuse myself on, that's

all I can tell you.

As a senator, Mr. Sessions was a sharp critic of Russia. He supported kicking the country out of the Group of Eight summit and called for sanctions against Moscow for its 2014 invasion of Ukraine.

"I believe a systematic effort should be undertaken so that Russia feels pain for this," Mr. Sessions said at the time.

But his rhetoric softened after he endorsed Mr. Trump, and he advocated better relations with Russia.

Mr. Sessions joined the Trump campaign in February 2016 at a rally in the former senator's home state of Alabama. Within days, Mr. Trump named him chairman of his campaign's national-security advisory committee.

It is unclear whether anyone in Congress knew about the investigation into Mr. Sessions' Russian interactions before Mr. Sessions was confirmed.

The investigation into Mr. Sessions' communications comes amid calls from Democrats and some Republicans for an independent inquiry into the possible cooperation between the Trump campaign and the Russian government to influence the 2016 election, particularly through cyberattacks.

U.S. intelligence agencies already concluded that Russia hacked the Democratic National Committee and the personal email account of Hillary Clinton's campaign chairman, John Podesta. Emails from both were released on the website WikiLeaks.

At first, Mr. Trump disputed that assessment, but later said: "I think it was Russia, but we also get hacked by other countries."

Justice Department regulations require the attorney general to remove himself from investigations that present a real or perceived conflict of interest. But ultimately, there is no practical mechanism, other than public pressure or an impeachment proceeding, to force the matter.

The disclosures Wednesday spurred questions about whether Mr. Sessions could oversee investigations.

"If there is something there and it goes up the chain of investigation, it is clear to me that Jeff Sessions, who is my dear friend, can not make this decision about Trump," said Sen. Lindsey Graham (R., S.C.), adding that a special prosecutor might be needed.

The law has changed since wide-ranging probes into the Clinton Administration, when a three-judge panel could appoint an "independent counsel" or a "special prosecutor." Today, the attorney general retains far more control over the scope of a special investigation and its prosecutorial jurisdiction.

Mr. Sessions can also appoint a temporary “special counsel” from outside the Department of Justice to conduct an investigation into a particularly sensitive matter and possibly prosecute related wrongdoing.


