LOS ANGELES - A handful of candidates have emerged as potential successors to U.S. Attorney Debra Wong Yang, who announced on Tuesday she was leaving her post to become a partner at Gibson Dunn & Crutcher.

Those seeking the position, according to sources speaking on condition of anonymity, include Thomas O'Brien, the current head of the criminal division of the U.S. attorney's office, and Nathan Hochman, a former federal prosecutor now in private practice. Both declined comment.

While local attorneys and judges predicted many takers for the highly visible position, they also said the pool of strong candidates might be small because only two years remain in the Bush Administration and the next U.S. Attorney faces sizeable internal challenges.

Some members of the local bar suggested the administration might forgo a permanent replacement because of time constraints. But those involved in the process that resulted in Yang's 2002 selection dismissed such assertions.

"That would not be in our interests," said Thomas R. Malcolm, an Irvine-based partner at Jones Day, of an interim U.S. attorney serving for the remainder of the Bush presidency.

Malcolm sits on a local three-person committee that will be involved in the selection process. The other members of the committee are attorneys Terry W. Bird and Elwood Lui.

While local Republicans are intent on filling the upcoming U.S.

Attorney vacancy with a permanent hire, the process will not be completed by Nov. 10, Yang's scheduled departure date.

According to sources, an interim U.S. attorney will likely be appointed prior to Yang's departure.

Sources speculated that while George S. Cardona, the current chief assistant in Los Angeles, might be tapped for the interim position, he was likely not in the running for the permanent position because he is a Democrat.

Cardona declined to comment for this article.

"The appointment of a U.S. attorney is driven by politics, especially in this administration," said a federal prosecutor, who requested anonymity.

"No one but a proven Republican" will get the position, the prosecutor said.

O'Brien and Hochman are both Republicans, according to sources.

O'Brien has been chief of the criminal division of the U.S. attorney's office for over a year. The six-year veteran of the office previously headed up the civil rights division. Before becoming a federal prosecutor, O'Brien was a Los Angeles County assistant district attorney.

Hochman is a partner at the Beverly Hills law firm Hochman, Salkin, Rettig, Toscher & Perez where his practice focuses on white-collar criminal defense. He served as an assistant United States attorney for seven years before going into private practice. During part of his tenure in the office, he headed the Los Angeles Disaster Fraud Task Force and secured convictions against more than 70 people for defrauding federal disaster assistance programs.

While several attorneys, both inside and outside the office, have been mentioned as potential candidates, no leading candidates have yet emerged, according to several knowledgeable sources.

"We want everyone to have the opportunity to apply," Malcom said.

Speculation has also surrounded another internal candidate, Christine Ewell, chief of the major frauds section.

But Ewell said she was not interested in the position.

Most local attorneys bristled at the idea of someone who has never worked it the office assuming the position.

LOS ANGELES - Among the candidates vying to be the next U.S. attorney in Los Angeles are several with close ties to Washington and strong conservative credentials.

Some observers say the current pool contrasts with past candidates, who had tighter connections to the local federal bar and more-centrist politics.

U.S. Attorney Debra Wong Yang announced two weeks ago she was resigning. Shortly after, local bar discussions centered on Thomas P. O'Brien, the office's criminal division chief, and Nathan J. Hochman, a former assistant United States attorney in private practice, as potential replacements.

But discussions also have taken place in Washington, D.C., and those talks have focused on a different set of names that includes Daniel B. Levin, counsel at Wilmer Hale; Daniel P. Collins, a partner at Munger Tolles & Olson; Arif Alikhan, a senior Justice Department official; Uttam S. Dhillon, an official with the Department of Homeland Security; and Pierre Prosper, a former State Department official.

These candidates all served as assistant U.S. attorneys in the Central District of California, but have gone on to more high-profile roles in the Justice Department and the Bush administration.

Sources expected Republican Party figures Gerald L. Parsky and Eric M. George to play a major role in the selection process but said the dynamics of the process will be different for candidates

with stints at "Main Justice" and other federal departments in Washington, D.C.

These candidates may be better positioned, sources predicted, because they come to the process with pre-existing and well-established relationships with Attorney General Alberto Gonzales and other high-level administration officials.

Before rejoining Wilmer Hale last year, Levin served as acting assistant attorney general for the office of legal counsel and worked closely with Gonzales. He also previously served as chief of staff and special assistant to FBI Director Robert Mueller.

Reached last week at his office in Washington, D.C., Levin declined to comment.

Collins also served in the Justice Department for two years as an associate deputy attorney general.

During his tenure in the office, he worked on initiatives involving the exploitation of children and identity theft. Collins did not return telephone calls seeking comment.

Alikhan is a senior adviser to Gonzales on cybercrime and intellectual property policies.

But pursuing the position would be more complicated for Alikhan than some other candidates because he recently accepted the position of deputy mayor of homeland security and public safety in Los Angeles.

A representative of Los Angeles Mayor Antonio Villaraigosa said Alikhan will assume his new position next week.

Reached at his office in Washington, D.C., Alikhan said Justice Department policies prevented him from commenting on the upcoming U.S. attorney vacancy.

Dhillon, another U.S. attorney candidate, according to sources, also declined to comment.

A Department of Homeland Security spokeswoman said Dhillon would neither confirm nor deny he plans to seek the U.S. attorney position.

She would only say that Dhillon "serves at the pleasure of the president."

In May, the Senate unanimously confirmed him as the Department of Homeland Security's first director of the Office of Counternarcotics Enforcement.

Dhillon previously served as chief counsel for the House's Committee on Homeland Security and policy director for the House Republican Policy Committee.

Prosper was U.S. ambassador-at-large for war crimes issues. He also served as a special assistant to the assistant attorney general for the criminal division.

Last year, Prosper sought the California Republican Party nomination for state attorney general but dropped out of the race when he did not reach his own fundraising goals. He declined comment.

The appointment of a U.S. attorney with Washington, or high-level, federal government experience, while common in other districts around the country, would be a departure for the Central District.

David E. Nahmias, a U.S. attorney in Georgia, began his government career as a federal prosecutor in Atlanta but spent three years at the Justice Department in Washington before returning to the city to assume the U.S. attorney position.

Yang's résumé, which includes stints in private practice, as a local federal prosecutor and as a judge, but no Justice Department experience, more closely tracks with prior occupants of the position in Los Angeles.

A former Bush administration official not involved in the selection process said that, regardless of past processes, administration connections likely would trump a track record with the local bar this time around.

The former official also said some of the candidates with Washington experience have served in critical roles for administration and have been very supportive of it on their return to the private sector.

During his tenure in the Justice Department, Levin was involved in rewriting a Bush administration memo on torture.

The original memo drew harsh criticism from human rights groups and some members of Congress for too narrowly defining torture.

This summer, Collins testified before the Senate Judiciary Committee urging the senators to overturn certain holdings in /Hamdan v. Rumsfeld, /548 U.S. (2006), a case in which the court held military commissions used to try detainees at GuantÃinamo Bay violated the Code of Military Justice and the Geneva Conventions.

Collins previously filed an amicus brief in the case supporting the government. A former federal prosecutor described some of the candidates as "conservative ideologues" and predicated the appointment of a strongly political U.S. attorney would be a departure for the office, which has a tradition of leaders, much like Yang, who are fairly moderate and apolitical.

When it comes to public comments about her potential replacement, Yang is exercising similar neutrality. In an e-mail sent two weeks ago announcing the resignation, Yang said she would consult with the attorney general about possible replacements.

Last week, Yang declined to state whether she threw her support behind any candidate during her discussion with Gonzales. Yang would say only that she discussed the needs of the office.

Several former assistant U.S. attorneys said the needs of the office are fairly obvious: more attorneys.

During her four-year tenure, Yang presided over several high-profile trials, plea agreements and indictments involving Ralphs grocery chain, the law firm Milberg, Weiss, Bershad & Schulman, and the Internet company Homestore.com. But the office has been plagued with low morale in the face of budget cuts and unfilled attorney vacancies, according to sources.

The Los Angeles U.S. attorney's office is the largest outside of Washington, D.C. The office is allocated 275 attorneys and, according to one assistant U.S. attorney, is "dozens" short of that

number.

Yang leaves office on Nov. 10. The Justice Department is expected to appoint an acting U.S. attorney to the position until a permanent replacement can be installed.

A former federal prosecutor described some of the candidates as "conservative ideologues" and predicated the appointment of a strongly political U.S. attorney would be a departure for the office, which has a tradition of leaders, much like Yang, who are fairly moderate and apolitical.

When it comes to public comments about her potential replacement, Yang is exercising similar neutrality. In an e-mail sent two weeks ago announcing the resignation, Yang said she would consult with the attorney general about possible replacements.

Last week, Yang declined to state

whether she threw her support behind any candidate during her discussion with Gonzales. Yang would say only that she discussed the needs of the office.

Several former assistant U.S. attorneys said the needs of the office are fairly obvious: more attorneys.

During her four-year tenure, Yang presided over several high-profile trials, plea agreements and indictments involving Ralphs grocery chain, the law firm Milberg, Weiss, Bershad & Schulman, and the Internet company Homestore.com. But the office has been plagued with low morale in the face of budget cuts and unfilled attorney vacancies, according to sources.

The Los Angeles U.S. attorney's office is the largest outside of Washington, D.C. The office is allocated 275 attorneys and, according to one assistant U.S. attorney, is "dozens" short of that number.

Yang leaves office on Nov. 10. The Justice Department is expected to appoint an acting U.S. attorney to the position until a permanent replacement can be installed.

Judge is in race for U.S. attorney job

Dickran Tevrizian was asked to apply as L.A.'s top prosecutor, a move many find unusual because he could retire or be a private jurist.

In a highly unusual development, veteran Judge Dickran M. Tevrizian has emerged as one of the leading candidates for the job of top federal prosecutor in Los Angeles.

Tevrizian, who has been a federal judge for 21 years, was considering leaving the bench to go into the lucrative field of private judging. But he was recruited by local lawyers to apply for the position, according to a number of people in the legal community.

Tevrizian, 66, declined to comment. But several lawyers who are conversant with the selection process said he is among half a dozen people, including five former federal prosecutors, seeking to fill the vacancy left by former U.S. Atty. Debra Wong Yang, who resigned to join a private law firm.

Tevrizian's candidacy is "highly unusual," said Loyola Law School professor Laurie Levenson, who worked in the U.S. attorney's office in Los Angeles from 1981 to 1989. She noted that at least nine U.S. attorneys have ascended to the federal bench after serving as the top federal prosecutor in Los Angeles. But there is no precedent here for the reverse: to give up a federal judgeship, which is a lifetime appointment, for the U.S. attorney's position, which has minimal job security.

Levenson said Yang's successor will take the job at a "pivotal moment" in the history of the office, which has been understaffed and beset with other problems in recent years.

"There are significant morale issues," Levenson said. "They have lost a lot of senior people."

Other candidates for the position include Daniel P. Collins, a partner at Munger, Tolles & Olson in Los Angeles and a former clerk to Supreme Court Justice Antonin Scalia; and Uttam S. Dhillon, a top lawyer in the U.S. Department of Homeland Security, who was a federal prosecutor in Los Angeles and served as chief counsel for the House of Representatives Committee on Homeland Security.

Also applying are Kimberly Ann Dunne, a partner at Sidley Austin; Nathan Hochman, a partner in Hochman, Salkin, Rettig, Toscher & Perez in Beverly Hills; Daniel Levin, a partner at WilmerHale in Washington, D.C.,

who served as counselor to U.S. Atty. Gen. John Ashcroft, special assistant to FBI Director Robert Mueller, senior associate counsel to Bush and legal advisor under National Security Advisor Stephen Hadley; and Thomas O'Brien, who is chief of the criminal division of the U.S. attorney's office in Los Angeles.

Tevrizian grew up in Southern California and attended Los Angeles High School before graduating from USC and USC Law School.

A long-time Republican, Tevrizian spent six years in private practice before being tapped for a Municipal Court judgeship by Gov. Ronald Reagan in 1972 and elevated to the Superior Court by Gov. Jerry Brown in 1978.

In 1985, Tevrizian was appointed by then-President Reagan to the federal bench.

In that job, Tevrizian presided over a number of high-profile cases, including the corruption case of former Democratic Assemblyman Bruce Young of Norwalk, the multimillion-dollar securities fraud case of onetime carpet-cleaning entrepreneur Barry Minkow and the government's prosecution of Hollywood private investigator Anthony Pellicano on explosives charges.

Judge is in race for U.S. attorney job

Dickran Tevrizian was asked to apply as L.A.'s top prosecutor, a move many find unusual because he could retire or be a private jurist.

In a highly unusual development, veteran Judge Dickran M. Tevrizian has emerged as one of the leading candidates for the job of top federal prosecutor in Los Angeles.

Tevrizian, who has been a federal judge for 21 years, was considering leaving the bench to go into the lucrative field of private judging. But he was recruited by local lawyers to apply for the position, according to a number of people in the legal community.

Tevrizian, 66, declined to comment. But several lawyers who are conversant with the selection process said he is among half a dozen people, including five former federal prosecutors, seeking to fill the vacancy left by former U.S. Atty. Debra Wong Yang, who resigned to join a private law firm.

Tevrizian's candidacy is "highly unusual," said Loyola Law School professor Laurie Levenson, who worked in the U.S. attorney's office in Los Angeles from 1981 to 1989. She noted that at least nine U.S. attorneys have ascended to the federal bench after serving as the top federal prosecutor in Los Angeles. But there is no precedent here for the reverse: to

give up a federal judgeship, which is a lifetime appointment, for the U.S. attorney's position, which has minimal job security.

Levenson said Yang's successor will take the job at a "pivotal moment" in the history of the office, which has been understaffed and beset with other problems in recent years.

"There are significant morale issues," Levenson said. "They have lost a lot of senior people."

Other candidates for the position include Daniel P. Collins, a partner at Munger, Tolles & Olson in Los Angeles and a former clerk to Supreme Court Justice Antonin Scalia; and Uttam S. Dhillon, a top lawyer in the U.S. Department of Homeland Security, who was a federal prosecutor in Los Angeles and served as chief counsel for the House of Representatives Committee on Homeland Security.

Also applying are Kimberly Ann Dunne, a partner at Sidley Austin; Nathan Hochman, a partner in Hochman, Salkin, Rettig, Toscher & Perez in Beverly Hills; Daniel Levin, a partner at WilmerHale in Washington, D.C., who served as counselor to U.S. Atty. Gen. John Ashcroft, special assistant to FBI Director Robert Mueller, senior associate counsel to Bush and legal advisor under National Security Advisor Stephen Hadley; and Thomas O'Brien, who is chief of the criminal division of the U.S. attorney's office in Los Angeles.

Tevrizian grew up in Southern California and attended Los Angeles High School before graduating from USC and USC Law School.

A long-time Republican, Tevrizian spent six years in private practice before being tapped for a Municipal Court judgeship by Gov. Ronald Reagan in 1972 and elevated to the Superior Court by Gov. Jerry Brown in 1978.

In 1985, Tevrizian was appointed by then-President Reagan to the federal bench.

In that job, Tevrizian presided over a number of high-profile cases, including the corruption case of former Democratic Assemblyman Bruce Young of Norwalk, the multimillion-dollar securities fraud case of onetime carpet-cleaning entrepreneur Barry Minkow and the government's prosecution of Hollywood private investigator Anthony Pellicano on explosives charges.






