We don't yet know what format the Judge's actual hearing – if any – will take. So, in terms of format, the moot will proceed in two stages: First, two "counsels" (Mark Paoletta and Jill Tyson) will question the Judge for 30 minutes each. Second, a panel of "Senators" (10 Democrats and 5 Republicans) will question the Judge. Each Democrat will have 10 minutes, and each Republican will have 5 minutes. 
