With respect to your requests for certain additional pieces of information, as you may be aware, on May 23, 2019, the President of the United States issued a memorandum empowering Attorney General William Barr to conduct a "review of intelligence activities relating to campaigns in the 2016 U.S. Presidential election and certain related matters."

Attorney General Barr appointed me to lead the investigation based on the President's Memorandum. I have assembled an investigative team to assist in carrying out this work ("Review Team"). One area that is a focus of our investigation is the origins of the FBI's counter-intelligence investigation of members of the Trump Campaign as well as related U.S. and foreign intelligence gathering before the opening and then during that investigation (to include the actions of government officials based on any of this intelligence and whether any actions were taken in violation of applicable regulations, policies or criminal laws). Based on our discussions with Embassy personnel and other information, the Review Team believes that your government has information that is particularly relevant to this inquiry.

With regard to today's meeting, we again want to thank you for making arrangements for us to inspect relevant documents. To simplify matters and based on your requests regarding understanding and agreements, the Review Team understands and agrees that any information provided by the Australian Government today will not be disseminated outside the necessary members of the Department of Justice or used in legal or other proceedings absent prior consultation with, and the agreement of, the Australian Government.

Further, the Review Team agrees that any interviews of Mr. Downer or (b) (6), (b) (7)(C) will be conducted outside the United States at locations and times agreed to by the individuals themselves and the Australian Government.

The Review Team also acknowledges and agrees that in allowing the Review Team to inspect the documents to be provide at today's meeting, the Australian government expressly does not waive any diplomatic protections or immunities, including diplomatic immunities attaching to Mr. Downer, (b) (6), (b) (7)(C) the documents and/or or the information contained in the documents.



The Attorney General has appointed me, in my current capacity as the United States Attorney for the District of Connecticut, to lead the Review. I have assembled an investigative team to assist in carrying out this work. One area that is the focus of the Review is the origins of the FBI's counter-intelligence investigation of members of the Trump Campaign, as well as related U.S. and foreign intelligence gathering before the opening and during the investigation, to include the actions of government officials based on any of this intelligence.

During the course of the Review, the investigative team has seen information that strongly indicates both individuals from Australia and documents in the possession of the Australian government are material to the Review and highly relevant to understanding the origins of the counter-intelligence investigation.

The purpose of this letter is to request your voluntary cooperation in the Review by consenting both to provide relevant documents in your government's possession and

to voluntary interviews of certain individuals who are Australian citizens. In this regard, attached hereto as Appendix A is a list of Australian citizens with whom we would like to meet to discuss relevant matters and the documents that are relevant to our inquiry.

We are hopeful that we can address these issues on a cooperative, voluntary, and expeditious basis. Please note that, pursuant to the firm directive of the Attorney General and our experience in investigating and prosecuting extremely sensitive national security matters, we will make it very high priority to protect sensitive and classified information by seeking to prevent the unwarranted exposure of sources, methods, and materials the disclosure of which could endanger individuals' safety and harm to U.K and U.S security interests.
