Summary of the Meeting

USA Romero opened the meeting talking about her own background. She said that she believes strongly in the democratic process, and it is important to her to hear from the elected officials. She said she wants to hear from them, understanding that they represent the views of their constituents. USA Romero stated that she lives in Philadelphia and has been a victim of crime.

She stated that she is dedicated to enforcing laws against guns and drugs; she highlighted that her office is engaged with DEA on Operation Overdrive. USA Romero noted that the Department does not endorse safe injection sites.

The elected officials went around the room and introduced themselves and talked about their position on safe injection sites. They were appreciative of the opportunity to explain their views to the USA. As a whole, all of the elected officials were opposed to safe injection sites.

The elected officials raised the below topics:

- The drug problem in Kensington is hard on families and businesses. Kids can't play outside because of the needles and prostitution.
- A visit to safe injection site in New York was concerning because it is across the street from a preschool. There was no zoning, no permitting necessary, and the site closes at 8:00 PM, which seems early to close for drug users. The New York site also gave out pipes. The lines at safe injection site in New York were long, people shooting up in line, and it appeared to be open-air drug market. There was a New York Post story that detailed how there was a person in a van selling drugs at the site openly. There are also almost 200 homeless addicts near the site. See https://nypost.com/2023/04/15/dealers-sell-drugs-from-van-to-nearby-injection-site-clients/.
- One official said that they initially thought they were supportive of the sites, but a visit to safe injection site in Toronto changed their mind on the subject. Needles were everywhere. Nearby stores had to secure merchandise because people would steal everything. Community members warned that he didn't want sites in his community. A staff member at the site said less than 4% of visitors to site as for help. If people get high and leave, they can still die. The site isn't open all the time, so they teach people how to safely inject the drugs. He knows the state says they'll offer help but said it won't be different than Toronto and the site wouldn't help addicts or community.
- Several officials stated that the Philadelphia Mayor Jim Kenney said he is supportive of safe injection sites. The officials noted that the Mayor does not speak for the rest of the elected officials and noted that the Mayor's term is ending in December 2023. One official said that only 27% of people in the city are in favor of the sites. People advocating for the sites are from outside the community.
- One official's district has the biggest concentration of drug and alcohol recovery facilities in the state. He said is in support of recovery facilities, but safe injections sites are different. He said the sites create a marketplace for drugs and violence and people still would not know if their drugs contained a lethal dose of fentanyl. He asked a representative from the proposed site whether they would ever transition to helping people get into recovery. For example, if the same person came in X number of times to take drugs, would they offer that person help? The proposed site representative responded that people should be able to take drugs. The recovery movement opposes these sites.
- One official lives near two of the biggest drug markets in Philadelphia; most murders happen within a three-block radius of these drug markets. Seniors are afraid to leave their houses. The official said the proposed safe injection site would close at 6 PM, which is too early to even be helpful. The official concluded that the neighborhood doesn't want it the site and the city doesn't want it.

- One official's office receives hundreds of calls from his constituents opposing safe injection sites.
- One official has drafted legislation prohibiting safe injection sites. She stated that the state legislature would preempt the city and take away the city's authority to allow safe injection sites.
- One official said the city already has treatment options with proven results.
- Several officials said the reports that they support safe injection sites are false; noting only the Mayor and the District Attorney are in support.

The USA closed the meeting by thanking the representatives and reiterating that it was important to her to hear their voices. The meeting then concluded.

Thanks for following up with us on this issue. Within the past month, there have been some significant developments in San Francisco in its quest to open multiple safe consumption sites throughout the City. On or about June 16, SF announced that it would be closing it's SF Linkage Center – the site that was borne out of the Mayor's Declaration of Emergency last December with the purported goal provide community access to health and human services to those in need. There were also reports that the site had also become a place where some can go and safely consume drugs. The following week after announcing the closure of the Linkage Center, SF announced the opening of a new drug sobering center (SoMa RISE) in a close by location where people on the street can temporarily ride out highs and could get connected to treatment. I've attached an article describing the site. We have not had the opportunity to fully engage SF officials in a discussion about these sites. I am curious about whether DOJ has finalized their views on these centers. I'm happy to schedule a meeting this week to discuss.



S.F.'s Tenderloin Center for people on the streets was a mystery for months. A tour only raised the curtain a little

The best way for government officials to avoid confusion and skepticism about their work is to be transparent about what they are doing.

That's not what's happened at the Tenderloin Center — formerly known as the Linkage Center — in United Nations Plaza since <u>Mayor London Breed hastily opened the service facility</u> in January as part of <u>her pledged crackdown on crime and drugs in the Tenderloin</u>. The center, obscured behind tents and a tarp-covered fence, provides basic needs including showers and food, while aiming to connect people to services and housing.

On Thursday, after months of requests, Breed's Department of Public Health finally flung open the center's doors to members of the media — sort of. It provided a brief tour, but only before the facility opened to guests.

So journalists could see the offices, furniture, computers and harm reduction supplies, but they were unable to observe any interactions between staff and people in need.

And that's too bad, because a lot of good work appears to be happening inside the Tenderloin Center. City officials and nonprofit workers should be proud of what the center is trying to accomplish instead of secretive about it.

They should also understand that the public demands accountability over how money is spent dealing with the city's most crucial and high-profile challenges and whether the city is successfully connecting people to long-term care.

The center, which seems to be staffed by well-intentioned people offering valuable help, is not the problem. The problem is Breed, the police and the rest of city government providing an inadequate response to the <u>miserable street</u> conditions prompting so many people to need the center in the first place.

As I interviewed staff outside the center Thursday after the brief tour, a barefoot, filthy woman hustled down the sidewalk, sobbing. Another woman screamed threats at the top of her lungs. Drug dealing, fencing of stolen goods and fentanyl smoking went on as usual in the plaza as people rushing to work tried to ignore the devastation.

Here's what I can tell you: The center is open from 8 a.m. to 8 p.m. every day — except Thursday, when it doesn't open until 11 a.m. for staff meetings. Visitors enter on Market Street, where they briefly check in at a front table, telling a staff member their preferred name, what they're seeking and whether they're housed.

They can leave their belongings safely monitored and then visit the rest of the building, no questions asked. They can eat healthy food, do laundry, take showers and talk to counselors.

There's a row of offices where city staff can connect people to housing and treatment, as well as contact their probation or parole officers. There's also a living room with couches, art supplies and computers.

Outside, in a patio surrounded by tarp-covered fencing and covered in tents, sits an area that's garnered controversy: a circle of plastic chairs where people can use drugs, as well as 10 plastic tables where people can inject drugs. Boxes for the safe disposal of needles sit on the tables, and a cart full of harm reduction supplies rests to the side.

When the center opened, the city didn't share publicly that there would be a drug-use area. It was only discovered when Michael Shellenberger, an author-turned-gubernatorial candidate who has criticized the center, jumped the fence and spread the word.

City officials would have been far smarter to <u>follow the lead of New York City</u> and open a real supervised consumption site indoors and in a clinical setting. At the sites in New York, the first two in the country, journalists, neighbors and others can tour the sites and talk to anyone who's willing to share their stories.

After all, saving lives is something to be proud of — not something to be hidden away. The Tenderloin Center, too, is saving lives — and reports reversing scores of overdoses, which is essential in a city that sees a body or two taken to the morgue every day, struck down by drugs.

Donna Hilliard, executive director of Code Tenderloin, one of the nonprofits staffing the Tenderloin Center, said city officials should be more open with the media and the public about what's going on at the center. She said she's frustrated by the secrecy and wished the media could see the center when it's open and serving guests.

Asked why it's taken city officials so long to grant such a limited tour, she said, "I don't know, but it's been driving me crazy! Just let them in! Then they'll see what's going on."

So what is going on? As Hilliard described it, a lot of heart-breaking, yet essential, work.

She said about 500 people use the center each day, many of them staying for several hours. She described the patio as loud, but not chaotic, and a place where people can discard shame about their drug use and form connections with staff who can help them.

She's seen people of all ages and races use the space, as well as veterans, seniors, disabled people and women who are victims of human trafficking. She said that in a city with far too few treatment beds, <u>emergency room doctors are releasing people</u> with mental health issues and drug addictions to the center in hospital gowns and bracelets.

She said she's seen women arrive at the center naked after being raped on the streets or fleeing their pimps. Others show up in extreme distress after not sleeping or eating for days.

While Hilliard doesn't have a problem with the fact that people are using fentanyl, heroin, meth and crack cocaine on the patio, she said she doesn't understand why city officials take such a hands-off approach to the open-air drug markets dotting the area, with dealers occupying corners 24/7.

"You can travel anywhere else in the world, and you don't see it like you see it in San Francisco," she said. "It's crazy."

While it's easy for fentanyl dealers to prey on people with addictions, it's much harder to connect people to help. In the center's first five months, more than 49,000 visits have taken place, but there have been just 53 connections to substance-use treatment. And just 21 connections to mental health services. It's unclear if there's overlap in those groups.

Services include methadone treatment, psychiatric care, therapy, crisis stabilization beds and other forms of help, said Alison Hawkes, a spokesperson for the Department of Public Health. The center doesn't track whether the connections are successful and long-term.

The center has also made 900 placements into shelters and 150 placements into permanent supportive housing, said Emily Cohen, a spokesperson for the Department of Homelessness and Supportive Housing. That doesn't mean 1,150 people have received beds, Cohen pointed out, since some people might get multiple short-term shelter placements in the course of five months or receive a shelter bed and then a permanent room.

Almost all of the visitors have received basic necessities like food, showers, laundry and a place to rest.

Also squishy is just how much this center costs. The Chronicle has tried for weeks to nail down an exact figure, but even the city controller's office hasn't been able to definitively provide one. On Thursday, Hawkes said the mayor's

new budget includes \$10.6 million to fund the center for the second half of this year. It's still unclear how much the first six months cost.

Supervisor Hillary Ronen, chair of the board's budget committee, said the board has approved a \$75,000 monthly lease on the space through the end of 2022, but hasn't yet approved funding the services. She said she's glad so many people are accessing basic services, but she hasn't yet seen proof that will lead to long-term help for drug addictions and mental illness.

She said she's worried the money and attention has been pulled from Mental Health SF, legislation passed three years ago to reform the city's broken mental health care system that included a far more robust treatment center. That center still doesn't exist.

"I feel like we have a problem in this city that we don't just create a vision and stick with it and fully implement it," she said. "We're constantly changing directions."

Krista Gaeta, interim director of the center, said it takes time to build relationships to move beyond providing meals and showers to something more life-changing. But she thinks the Tenderloin Center will get there.

"It's about giving people hope there's something on the other side," she said.

I could see hope inside the center. It's the despair on the other side — past the tarp-covered fence — that needs fixing.

Re: Support for overdose prevention program

Dear Mr. Attorney General:

As Mayors of cities committed to preventing overdose deaths, we write to express our strong support for the opening of supervised overdose prevention programs to address the serious public health concern of opioid-related overdose deaths. To that end, we urge you to issue a public statement on behalf of the U.S. Department of Justice ("DOJ") to institute a new policy that deprioritizes federal enforcement of the Controlled Substances Act ("CSA") against medically supervised overdose prevention programs. And we request that the DOJ reverse the position of the prior administration that the CSA prohibits evidence-based medical programs aimed at preventing drug overdoses and connecting individuals to drug treatment. This shift in federal policy will pave the way for harm reduction programs to open, saving countless lives and assisting in efforts to successfully connect people to recovery programs for their addictions, reduce needles on our streets, and promote healthier and safer communities in cities across the nation.

There is a serious national epidemic of opioid addiction and overdose deaths. In 2019, over 1.6 million Americans suffered from substance use disorders related to prescription opioids, heroin, and synthetics such as fentanyl. During the 12 months ending in May 2020, the Centers for Disease Control and Prevention reported a 98% increase in synthetic opioid involved deaths in 10 western states including California. (See Substance Abuse and Mental Health Services Administration, Key Substance Use and Mental Health Indicators in the United States: Results from the 2019 National Survey on Drug Use and Health, HHS Publication No. PEP20-07-01-001, NSDUH Series H-55 (2020); Centers for Disease Control and Prevention, Overdose Deaths Accelerating During COVID-19, Dec. 17, 2020, www.cdc.gov/media/releases/2020/p1218-overdose-deaths-covid-19.html.)

According to new data published by the Centers for Disease Control and Prevention, more than 87,000 Americans died of drug overdoses between September 2019 and September 2020, the highest ever recorded since the opioid epidemic began in the 1990s. (*See* Ahmad FB, Rossen LM, Sutton P. Provisional drug overdose death counts. National Center for Health Statistics. 2021, https://www.cdc.gov/nchs/nvss/vsrr/drug-overdose-data.htm.) In 2020, exacerbated by the COVID-19 pandemic, the number of overdose fatalities soared due to fear, stress, job loss,

isolation and limited access to support services. Synthetic opioids, such as illicitly manufactured fentanyl, are a primary driver in overdose deaths nationally. While all of our cities invest in a continuum of behavioral health care services including prevention and treatment services for substance use disorders and provide and administer thousands of life-saving doses of naloxone each year, these tools are insufficient to help everyone who needs them.

Overdose prevention programs are a proven tool that will reduce deaths and help end the addiction and overdose epidemic. Also known as supervised consumption programs, overdose prevention programs allow individuals to inject or consume illicit drugs in a hygienic environment under the supervision of trained staff while they are provided with opportunities to engage in other health and social services that encourage treatment. In addition to providing clean injecting equipment, safe injection education, and referrals to treatment or other parts of the care continuum, these programs would administer oxygen and emergency medical care. Monitoring for overdose is a key element of supervised consumption, particularly pertinent to fentanyl, because onset of overdose can be rapid and waiting for emergency medical service assistance could mean the difference between life or death. Overdose prevention programs will be critical to reducing the number of overdose deaths and saving hundreds of lives each year. State legislatures are recognizing the promise of this policy and ten other states have introduced legislation permitting the operation of supervised overdose prevention programs including Arizona, California, Colorado, Illinois, Maryland, New Hampshire, New Jersey, New Mexico, New York and Rhode Island.

Internationally, such programs have shown strong success in reducing harm and encouraging people to accept services. There are approximately 100 programs currently operating in over 65 cities and ten countries around the world (Switzerland, Germany, the Netherlands, Norway, Luxembourg, Spain, Denmark, France, Australia, and Canada). A study of a facility in Vancouver, Canada found that there was a 35% reduction in mortality within 500 meters of the facility within three years of opening, and 46% of clients entered treatment during the same time period. (See Marshall, B.D., et al., Reduction in overdose mortality after the opening of North America's first medically supervised safer injecting facility: a retrospective population-based study, Lancet, 2011, pp. 1429-37; DeBeck, K., et al., Injection drug use cessation and use of North America's first medically supervised safer injecting facility, Drug Alcohol Dependence, 2011, 113(2-3): p. 172-6.) A new study suggests that documented criminal activity decreased rather than increased in the area around an unsanctioned safe consumption site in the five years following opening. (See Peter J. Davidson, et al., Impact of an unsanctioned safe consumption site on criminal activity, 2010–2019, Drug and Alcohol Dependence, 2021.) Safe consumption programs have also been shown to reduce perceived safety and neighborhood disorder associated with public injection of drugs and to reduce injection-related litter in the surrounding area.

The Trump administration opposed these harm reduction programs and took the position that such programs would violate the "crackhouse" provision of CSA. Based on that position, the DOJ filed suit to block a Philadelphia non-profit from opening such a site, and issued public statements condemning efforts by other cities. The district court in the Philadelphia lawsuit held that harm reduction efforts do not violate the CSA, but unfortunately the Third Circuit Court of Appeals reversed, siding with the Trump administration. *See United States v. Safehouse*, 408 F.

Supp. 3d 583 (E.D. Pa. 2019); *United States v. Safehouse*, 2021 WL 97622 (3d Cir. Jan. 12, 2021). The issue may be further litigated in the Third Circuit and elsewhere.

We urge you to reevaluate the DOJ's position on the question of whether the CSA prohibits medically supervised overdose prevention programs, and to issue a public statement explaining that it does not. Even if you are not prepared to issue a public conclusion on the legal question interpreting the CSA, we urge you to issue a policy deprioritizing enforcement of the CSA against operators and clients of overdose prevention programs as a national policy. The threat of federal enforcement is one of the greatest disincentives to opening and operating these lifesaving programs in San Francisco and elsewhere, and we ask that you end that threat.

With overdose prevention programs in place, cities will be better able to address the needs of individuals suffering from addiction and save countless lives. These medically supervised sites help people get into treatment and do not perpetuate criminality. They are a sensible harm reduction tool that is key to stopping the epidemic plaguing this country. As Mayors, we see this tool as critical to addressing the urgent crisis of overdose deaths occurring in our cities. We appreciate your consideration of these issues and look forward to your response so that we can immediately move forward with authorizing these programs and begin saving lives.


