The Office of the Attorney General for the District of Columbia is reviewing the legality of aspects of the federal government's response to the George Floyd protests in the District. Specifically, the federal government has called in several out-of-state National Guards and federal law-enforcement entities (including, the Bureau of Prisons, according to public reports) to police District streets. The District government has received very little information about the legal basis for these entities' presence.

We are seeking information regarding the legal authority for these entities' presence in the District and their actions. Specifically, we request responses to the following questions by 5 p.m. on June 6, 2020:

- 1) Did any federal government official contact any state regarding deployment of its National Guard to the District of Columbia? If so, which states were contacted, by whom, and when?
- 2) What authority is the federal government relying on for deploying out-of-state National Guard units to the District of Columbia?

- 3) What is the stated mission of any out-of-state National Guard personnel deployed to the District of Columbia and who determined that mission?

- 7) What federal law-enforcement personnel (such as, but not limited to Bureau of Prisons personnel) have been sent to the District from other locations or, if already in the District, reprogrammed to respond to protests and demonstrations in the District of Columbia since May 25, 2020? For each responsive entity, please provide the following information:
  - a. What is the legal authority for the entity's presence in the District?
  - b. What is the stated mission of the entity's presence in the District?
  - c. What is the scope of law-enforcement authority for the entity in the District? Specifically, do they have authority to make arrests and if so, for what offenses and in what geographical boundaries? Please provide the legal basis for any asserted law-enforcement authority.
  - d. To whom does the entity report concerning activities in the District?
  - e. Are officers from the entity armed? If so, what is the legal basis for this?
  - f. Do personnel from this entity acting in the District have law-enforcement training, including knowledge about the rights to protest and assemble?
  - g. How do personnel from each entity handle requests from District law-enforcement and District residents to identify themselves?

I would also welcome a meeting to discuss the need for accountability, transparency, and compliance with federal and District law in connection with the extraordinary actions taken regarding these protests.

Dear President Trump:

I write to inform you that, with last night's curfew ending at 6:00 a.m. today, I have ended the state of emergency in the District of Columbia related to demonstrations. The protestors have been peaceful, and last night, the Metropolitan Police Department did not make a single arrest. Therefore, I am requesting that you withdraw all extraordinary federal law enforcement and military presence from Washington, DC.

Since Home Rule, we have developed a finely wrought system of coordination with federal partners, and we will continue to work with them to ensure the safety of demonstrations. We are well equipped to handle large demonstrations and First Amendment activities.

Furthermore, I continue to be concerned that unidentified federal personnel patrolling the streets of Washington, DC pose both safety and national security risks. The deployment of federal law enforcement personnel and equipment are inflaming demonstrators and adding to the grievances of those who, by and large, are peacefully protesting for change and for reforms to the racist and broken systems that are killing Black Americans.

Our police and incident command have clear channels of communication and roles and it is important to note that these additional, unidentified units are operating outside of established chains of command. This multiplicity of forces can breed dangerous confusion, such as when helicopters are used in a war-like tactic to frighten and disperse peaceful protestors.

Adding to the confusion and my concern are the units that lack identifying insignia. When citizens are unable to clearly identify legitimate law enforcement officers, it creates unnecessary risks for both protesters and officers. In fact, we found many years ago that conflict between police and citizens is reduced when law enforcement affiliation is apparent; thus, identifying insignia is mandatory in Washington, DC.

The safety and freedom of the residents and visitors to the District of Columbia is paramount. My view is that law enforcement should be in place to protect the rights of American citizens, not restrict them. I appreciate your prompt consideration of this request.


