Reaching out from The Daily Signal. Can the DOJ/FBI comment on Attorney General Garland's comments today in which he admitted that he relied on the National School Board Association's letter claiming there has been a spike in threats against school boards and teachers. Did Garland/ or the DOJ independently confirm that there has actually been such a spike? What evidence is there of such a spike without the NSBA letter?

In addition, can Garland or the DOJ comment on the fact that one of the persons mentioned in the NSBA letter actually is the father of a girl allegedly anally raped in a Loudoun County school bathroom? Did the DOJ or Garland know this before the memorandum was issued? What steps is the FBI/DOJ taking to investigate Loudoun County and it's potential cover up?

In addition, why does Garland say he does not know about the Loudoun County rape case? Why has the AG not been briefed about such a nationally impactful case?

Finally, can the DOJ comment on news that the White House collaborated with the Biden administration before sending the letter calling on the FBI and DOJ to investigate?

Hope all is well. The US Government is planning the next phase of Operation Allies Welcome. Phase 2 is a much smaller phase, but it will not be on DOD military installations. Instead, it will most likely be a conference center/hotel complex out near Dulles.

Because of the location, not federal law enforcement will have jurisdiction. The Loudoun County Sherriff's Office is willing to provide law enforcement responses but is seeking reimbursement (akin to what we did in New Mexico and at Ft. Pickett). DOJ committed to finding a way to provide similar support. I'm still waiting on (1) a cost estimate and (2) the conditions we'd ask for—e.g., are officers required to stay at the installation—but DHS has asked for us to become part of the conversation.

Could I ask you guys to "get the band back together," as it were? I'm hoping (b) (5)  
(b) (6) would be enough to cover this phase.
