I hereby rescind the memorandum dated August 18, 2016, sent to you by former Deputy Attorney General Sally Q. Yates, entitled "Reducing our Use of Private Prisons." In that memorandum, former DAG Yates directed "that, as each contract reaches the end of its term, the Bureau should either decline to renew that contract or substantially reduce its scope in a manner consistent with law and the overall decline of the Bureau's inmate population." The memorandum changed long-standing policy and practice, and impaired the Bureau's ability to meet the future needs of the federal correctional system. Therefore, I direct the Bureau to return to its previous approach.

Scott,

As I have done previously, I wanted to make a record that I got a call from a lobbyist, Brian Ballard, on the private prison rescission memo. He expressed concerns that despite the rescission memo having been issued, BOP was still operating under the old DAG guidance.

I explained, just as I did with all previous calls that this Justice Department does not engage in negotiation or discussion with lobbyists. I said I could not talk about the inner-workings of operational decision making of BOP and we certainly would not direct them to take any particular actions based upon special interest.

I requested that he call his representatives in Congress.

Finally, I told him that the new memo, which is a public document, provides BOP with the discretion to contract for private bed space based upon their operational needs, not specific quotas from Washington. If he was seeing that additional bed space was not being renewed, it was not due to an adherence to the Yates' policy, but based upon operational decisions by career subject matter experts within BOP.

Dear Attorney General Sessions:

As you know from your time serving on the United States Senate Committee on the Judiciary, the Federal Bureau of Prison's (BOP) lack of oversight regarding contracts with privately operated prisons has been an important oversight issue. The potential for waste, fraud and abuse has proven to be significant without proper oversight. For example, in April 2015, the Department of Justice Office of the Inspector General (OIG) audited BOP's contract with Reeves County Detention Center in Pecos, Texas for compliance with contract terms and conditions relating to billings, staffing requirements, and contract oversight and monitoring. OIG found substantial waste and abuse.

Specifically, OIG found that "Reeves County improperly requested and the BOP improperly paid \$1.95 million in fringe benefits it was not entitled to receive, including \$175,436 in payroll taxes and workers' compensation insurance[.]"<sup>1</sup> In addition, Correct Care Solutions, LLC (CCS) improperly requested \$74,765 in fringe benefits that were unsupported by payroll documentation.<sup>2</sup> I wrote to the BOP regarding these troubling issues.<sup>3</sup>

The OIG also determined that "the BOP needs to improve how it monitors contract prisons in several areas."<sup>4</sup> Specifically, the OIG concluded "deficiencies related to contract prisons' security inspection systems could jeopardize the safety and security of inmates and

prison staff, and the BOP should address them promptly."<sup>5</sup> BOP has attempted to address many of the issues identified in the OIG report, but cause for concern still exists. It is unclear to what extent BOP performs oversight of these contracts to reduce waste, fraud, and abuse. Accordingly, DOJ should explain, in detail, what steps it will take, or has already taken, to ensure proper oversight of privately operated prisons.

In August 2016 the DOJ issued a memorandum to the BOP directing that it not renew contracts with private prisons as they reach the end of their term or to "substantially reduce its scope in a manner consistent with law and the overall decline of the Bureau's inmate population."<sup>6</sup>

On February 21, 2017, the DOJ issued a memorandum to BOP rescinding the above mentioned memorandum stating that it "changed long-standing policy and practice, and impaired the Bureau's ability to meet the future needs of the federal correctional system."<sup>7</sup> This departure from previous DOJ guidance regarding future private prison contracts has re-ignited the debate over the proper oversight of private prison use by BOP.

In an effort to better understand the rationale behind your decision as well as exercise the Committee's oversight responsibility with regard to DOJ and the BOP, please answer the following questions:

- 1. In light of previous oversight lapses at privately run prisons, how will the DOJ ensure that BOP is engaging in proper oversight of them to prevent waste, fraud, and abuse?
- 2. In light of the rescission, what steps are being taken to ensure that the federal and private bed population is appropriately managed in order to reduce costs to the taxpayer?

Please number your responses according to their corresponding questions. I request a response no later than March 28, 2017. If you have any questions, please contact Josh Flynn-Brown of my Judiciary Committee staff at (202) 224-5225. Thank you for your cooperation in this important matter.

#### **INDEPENDENCE OF YOUR OFFICE:**

# Non-responsive record

**16.** As we discussed in our meeting, if you are confirmed, you will oversee the federal Bureau of Prisons (BOP) and be responsible for ensuring that almost 200,000 federal inmates are treated in a humane fashion.

When I was Chairman of the Subcommittee on the Constitution, Civil Rights, and Human Rights, I held two hearings on the human rights, fiscal, and public safety consequences of solitary confinement. Anyone who heard the chilling testimony of Anthony Graves and Damon Thibodeaux exonerated inmates who each spent more than a decade in solitary confinement knows that this is a critical human rights issue that we must address.

In light of the mounting evidence of the harmful even dangerous impacts of solitary confinement, states around the country have led the way in reassessing the practice. Progress has been made at the federal level as well. Last year, the Justice Department issued a report on the use of restricted housing in the federal prison system, and BOP has begun to implement a number of the report's recommendations for reform. However, there are still approximately 10,000 federal inmates in segregation.

### a. Do you believe that long-term solitary confinement can have a dangerous impact on inmates?

**RESPONSE:** Prison officials must be able to secure offenders and prevent them from disrupting operations and harming correctional employees and other inmates. If confirmed, I will work closely with BOP about how best to handle dangerous prisoners.

#### b. Will you commit that, if you are confirmed, you will examine the evidence and work with BOP to make further improvements in the area of restricted housing?

**RESPONSE:** If I am confirmed, I will work with BOP and others in the Department to ensure that inmates are held in appropriate housing conditions.

17. Deputy Attorney General Sally Yates issued a memo in August 2016 to begin the process of phasing out BOP's use of private prisons. In the memo, she cited an August 2016 DOJ Inspector General (IG) report that found that private contract facilities used by BOP do not maintain the same level of safety and security as BOP-run facilities (<u>https://oig.justice.gov/reports/2016/e1606.pdf</u>). Specifically, the IG
noted that private facilities "had more frequent incidents per capita of contraband finds, assaults, uses of force, lockdowns, guilty findings on inmate discipline charges, and selected categories of grievances." The IG also found that some of the facilities improperly housed new inmates in solitary confinement. Despite this evidence, the Attorney General recently issued a memo that directed BOP to "return to its previous approach."

#### a. Do you accept the IG's findings?

**RESPONSE:** I have no independent basis of knowledge about the Inspector General's findings and am not in a position to comment. I am committed to ensuring that all BOP facilities are safe, secure, and humane.

### **b.** Do you believe that there is a need for private prisons in the federal prison system?

**RESPONSE:** It is my understanding that the goal is to maintain the Bureau of Prisons' flexibility to manage the federal inmate population based upon capacity needs, consistent with the need to ensure safety, security, and effective reentry programming. Whether private or public, detention facilities should be humane, secure, and safe for prisoners and staff.

### c. If confirmed, what steps will you take to ensure that these problematic facilities operate in a manner that ensures the safety and security of all inmates and staff?

**RESPONSE:** I am committed to ensuring that all BOP facilities are safe, secure, and humane. I will decide upon specific steps after a careful analysis of the issues.

In that memorandum, former DAG Yates directed "that, as each contract reaches the end of its term, the Bureau should either decline to renew that contract or substantially reduce its scope in a manner consistent with law and the overall decline of the Bureau's inmate population." The memorandum changed long-standing policy and practice, and impaired the Bureau's ability to meet the future needs of the federal correctional system. Therefore, I direct the Bureau to return to its previous approach.

Zach - Per your request, the following three items comprise our update this week:

On Wednesday, April 26, I testified at an oversight hearing before the Crime Subcommittee of the House Judiciary Committee. The hearing went well. We have a small number of "get backs" that we will work with OLA to provide to the Committee. Chairman Gowdy made a strong opening statement acknowledging the challenges of managing a large prison system, and the importance of both public safety and reentry portions of the mission. Other members also noted the importance of our dual mission. A number of members from both sides of the aisle also mentioned the importance of Federal Prison Industries and expressed their support for the program and concern for the loss of inmate jobs over the past few years (Goodlatte, Chabot, Richmond). Several members also asked about private prisons. I reiterated the BOP population is expected to increase, and that we plan to use private prisons to assist us by providing additional capacity as the population increases beyond what is safe to house in BOP facilities; notably for the low security criminal alien population. Ranking Member Conyers and several others also expressed concerns about health care in private facilities. I reiterated that inmates with health issues are transferred to BOP facilities, so that the private facilities are only caring for generally healthy inmates. However, we also have extensive oversight to ensure that routine health care treatment is carried out appropriately in the private facilities. It appears that my comments were well received and several members expressed their appreciation for the hard, dangerous, and important work we do in the Bureau of Prisons.

Also yesterday, as you know, the FBI and the US Attorney's Office conducted a joint operation with BOP staff to dismantle a child porn network operating out of the Federal Correctional Institution, at Ft. Dix, NJ. Five inmates were arrested and charged with using contraband cellphones and SD cards to distribute pornographic materials, among other charges. The U.S. Attorney's Office issued a comprehensive press release thanking the Bureau of Prisons for our assistance (attached).

Next week we plan on finalizing our program for the May 9 Correctional Workers Week ceremony at the National Law Enforcement Memorial. The Attorney General is scheduled to speak at the 9:30 am event, and the Acting Director and Acting Deputy Director will also be making remarks.

#### <u>FIVE INMATES ARRESTED AT FEDERAL CORRECTIONAL INSTITUTION – FORT</u> <u>DIX FOR DISTRIBUTING IMAGES OF CHILD SEXUAL ABUSE</u>

CAMDEN, N.J. Five men imprisoned on child pornography charges were arrested today at the Federal Correctional Institution-Fort Dix and charged with new counts of distributing images and videos of child sexual abuse within the prison, Acting U.S. Attorney William E. Fitzpatrick announced.

The inmates were charged with using contraband cellphones and micro SD cards to distribute the images, as well as selling and possessing with intent to sell the images and videos on federal property and conspiracy to commit these offenses. They are scheduled to appear later today before U.S. Magistrate Judge Karen M. Williams in Camden federal court.

"These five defendants, each having been previously convicted and imprisoned for trafficking in child pornography, have allegedly continued while in prison to trade and profit from the exploitation and sexual abuse of innocent children," Acting U.S. Attorney Fitzpatrick said. "The federal law enforcement community is committed to protecting our nation's children by exhaustively investigating and aggressively prosecuting those who seek to do them harm."

"Anyone who sexually exploits children, whether incarcerated or not, will be relentlessly pursued and brought to stand trial for their heinous crimes," stated Timothy Gallagher, Special Agent in Charge of the FBI's Newark Field Office. "The FBI and our law enforcement partners are resolute in this commitment and remain ever vigilant in protecting one of society's most vulnerable members, our children."

According to documents filed in this case and statements made in court:

Anthony C. Jeffries, 31, of Orange, Virginia, is serving a 168-month sentence, with a scheduled release date of Aug. 13, 2022, following his guilty plea in the Western District of Virginia to three counts of distribution of child pornography and one count of possession of child pornography. He is allegedly a leader of the Fort Dix child pornography network, and maintained a "cloud" account containing images and videos of child sexual abuse. Jeffries allegedly transferred a micro SD card containing images of child sexual abuse to a government informant at Fort Dix on Nov. 1, 2016. The micro SD card included videos involving prepubescent children, including infants and toddlers and depictions of child sexual abuse.

Brian J. McKay, 46, of Brookhaven, Pennsylvania, is serving a 180-month sentence, with a scheduled release date of June 28, 2021, following his guilty plea in the Eastern District of Pennsylvania to one count of distribution of child pornography and one count of possession of child pornography. McKay is charged with allegedly transferring micro SD cards containing images of child sexual abuse to a government informant at Fort Dix on Nov. 1, 2016, and on Feb. 15, 2017, on behalf of other inmates (conspirators Allen and Roffler, below). The first micro SD card included child sexual abuse videos involving prepubescent children as well as bestiality. The second micro SD card included hundreds of images and videos of child sexual abuse.

Jordan T. Allen, 30, of Plain City, Ohio, is serving a 102-month sentence, with a scheduled release date of Dec. 30, 2018, following his guilty plea in the Southern District of Ohio to one count of receipt of child pornography. He is charged with receiving payment from a government informant at Fort Dix on Feb. 15, 2017, in exchange for the micro SD card that McKay transferred to the informant on that date. Allen told the informant that he utilized The Onion Router (also known by its acronym, "TOR") to access images of child sexual abuse.

Christopher D. Roffler, 29, of Virginia Beach, Virginia, is serving a 100-month sentence, with a scheduled release date of Aug. 22, 2019, following his guilty plea in the Eastern District of Virginia to one count of transportation of child pornography. He is charged with receiving payment from a government informant at Fort Dix on Nov. 1, 2016, in exchange for the micro SD card that McKay transferred to the informant on that date.

Erik M. Smith, 35, of Iron Mountain, Michigan, is serving a 235-month sentence, with a scheduled release date of March 26, 2027, following his guilty plea in the Western District of Michigan to one count of receipt of child pornography. He is charged with distribution of images of child sexual abuse and selling and possessing with intent to sell images of child sexual abuse on federal property. Smith allegedly sold a micro SD card containing images of child sexual abuse to a government informant at Fort Dix on Feb. 15, 2017. Smith stated that he had sufficient postage stamps a form of illicit currency among inmates in order to obtain a cellphone to access the cloud account.

The counts of distributing child pornography, selling and possessing with intent to sell child pornography, and conspiracy to commit these offenses due to the prior convictions of each of the defendants carry a mandatory minimum sentence of 15 years in prison, a maximum potential penalty of 40 years in prison, and a \$250,000 fine.

Acting U.S. Attorney Fitzpatrick credited special agents of the FBI, under the direction of Special Agent in Charge Timothy Gallagher in Newark, with the investigation leading to today's arrests. He also thanked officials of the Bureau of Prisons and FCI-Fort Dix for their assistance with the investigation.

The government is represented by Assistant U.S. Attorneys Justin C. Danilewitz and Gabriel Vidoni of the U.S. Attorney's Office's Criminal Division in Camden.

The charges and allegations in the complaints are merely accusations, and the defendants are considered innocent unless and until proven guilty.

On May 19, 2017, it was reported that the Bureau of Prisons started the process for acquiring at least one new private prison to house immigration offenders "in anticipation of population increases due to new law enforcement initiatives." This follows the Department's February decision to rescind guidance calling for a reduction in the federal

use of private prisons. According to an August 2016 report by the Inspector General, private prisons are less safe and do not provide adequate healthcare for inmates.

### a. Can you confirm that the BOP is currently taking or will soon be taking bids for at least one new private prison to house immigration offenders?

**Response**: Yes, the Request for Proposal (RFP) was issued on May 25, 2017, and closed on July 10, 2017. The award is anticipated in the fourth quarter of 2018.

### b. What is your affirmative plan for ensuring these new private facilities are safe and will provide adequate healthcare?

**Response**: Over the past year, BOP has taken steps to enhance safety, security, and programming at private contract prisons by significantly strengthening its Oversight Checklist and other tools used to monitor, track, and evaluate contractor performance. This includes enhanced reviews in the areas of staffing requirements, food service, transfer requests, inmate appeal rights, correctional services, and safety. In addition, BOP heightened reporting procedures to require that contractors provide greater detail regarding safety and security information in a manner conducive to trend analysis and comparative reviews. BOP improved monitoring of health care programming by adding an additional subject-matter expert to the monitoring team. This team has developed a system for enhanced tracking of routine medical services.

**Private Prisons** 

a. Does the Department have any plans to construct new private prisons or expand existing private prisons? If so, when were these plans put into place?

**Response**: BOP does not construct, assist with construction, or budget for the construction or expansion of private prisons.

b. Are private prisons that contract with the federal government required to operate under the same laws, rules, and regulations as federally owned and operated prisons? If not, how are they regulated differently and why are they regulated differently?

**Response**: Both BOP-owned facilities and private prisons with which BOP contracts are required to maintain accreditation by the American Correctional Association (ACA), maintain PREA certification, and be certified from an accredited Health Care Organization. In addition, both BOP facilities and private prisons with which BOP contracts are required to adhere to all applicable federal, state, and local laws and regulations governing a correctional environment.

#### **Questions Posed by the Honorable Grace Meng**

Last year, the Obama Administration committed to phasing-out the use of private prisons by the U.S. federal government. When outlining this new policy, Deputy Attorney General Yates cited the following basis for the decision: (1) a decreasing prison population; (2) private prisons a do not provide the same level of correctional services, programs, and resources; (3) private prisons do not save substantially on costs; and (4) findings from a DOJ Office of Inspector General report that states private prisons do not maintain the same level of safety and security. One of the first acts Attorney General Sessions performed was to reverse this policy. Why did the Department choose to reverse course and recommit to the use of private prisons?

**Response:** For decades, BOP has relied on privately operated prisons to house low-security criminal aliens. The private prison industry helped BOP manage the unprecedented growth in the inmate population that began in the 1980s. While the federal prison population has decreased in recent years, BOP needs the flexibility of private prison contracts to avoid the need for costly, new BOP facility construction.

Deputy Attorney General Rosenstein, have you or Attorney General Sessions, now, or have you ever, owned stock in any publicly traded private prison company?

**Response:** I do not now, and I do not believe I ever have.

In contracts that the federal government enters into with private prisons, it generally guarantees that a certain percentage of cells will be filled with prisoners. How does the federal government guarantee that a certain number of Americans will be imprisoned each and every year? Are you concerned that this creates a public policy incentive for law enforcement agencies to actually increase recidivism?

**Response:** BOP projects future capacity needs based on information from a variety of sources, such as the Administrative Office of the U.S. Courts, the U.S. Sentencing Commission, and the Department's criminal components. Contracts with private prisons often include guarantees to obtain the best competitive price for the United States. BOP's projections have no impact or influence over the number of individuals prosecuted by the Department.

In August 2016, the Bureau of Prisons (BOP) announced plans to end its use of private prisons. However, Attorney General Sessions rescinded this policy and directed BOP "to return to its previous approach." Are all private facilities that were previously in use being used again? Do you believe that all such facilities are proper for housing our federal inmates?

**Response:** Eleven of the thirteen privately operated adult facilities under contract with the Bureau of Prisons (BOP) in August 2016 are still used to house sentenced federal offenders. All eleven privately operated adult contract facilities have received and maintain their American Correctional Association (ACA) accreditation, PREA certification, and accreditation by the Joint Commission, a non-profit organization that provides accreditation for health care programs. In addition, the BOP has oversight staff at each location to ensure that daily operations are in compliance with the contract terms and requirements.

For decades, the BOP has relied on privately-operated prisons to house low-security criminal aliens. The private prison industry helped the BOP manage the unprecedented growth in the inmate population that began in the 1980s. While the federal prison population has decreased in recent years, the BOP needs the flexibility of private prison contracts to avoid the need for costly, new BOP facility construction.

On April 14, 2017, BOP released a pre-solicitation notice for the management and operation of a contractor-owned, contractor-leased correctional facility.

### a. How many private facilities does BOP use currently and is there no space available to house additional inmates at these existing facilities?

**Response**: BOP currently contracts with four providers to manage and operate eleven secure adult contract facilities. The current capacity utilization in the private prisons is 94.3%.

#### b. What is the estimated cost of a project like this?

**Response**: The estimated cost of a solicitation will depend on the number of beds contracted. For example, a 1,800-bed contract can average approximately \$445 million for a ten-year period. For a 9,540-bed contract, the cost can average approximately \$2.4 billion for a ten-year period and involve multiple vendors.

#### c. How many more beds does the BOP need?

**Response**: BOP is not seeking to increase the number of contract beds in privately managed secure facilities. However, BOP is seeking to replace existing contracts that are expiring. The net number of contract beds, however, will not change.

## d. Are private prisons that contract with the Federal Government required to operate under the same laws, rules, and regulations as federally-owned and operated prisons? If not, how are they regulated differently and why are they regulated differently?

**Response**: Both BOP-owned facilities and private prisons with whom BOP contracts are required to maintain accreditation by the American Correctional Association (ACA), maintain PREA certification, and be certified by an accredited Health Care Organization. In addition, both BOP facilities and private prisons with whom the BOP contracts are required to adhere to all applicable federal, state, and local laws and regulations governing a correctional environment.

e. How does the Department justify its belief that contract prisons offer appropriate health and correctional services and are safe and secure places to house Federal inmates?

**Response**: BOP has taken steps to enhance safety, security, and programming at private contract prisons by significantly strengthening its Oversight Checklist and other tools used to monitor, track, and evaluate contractor performance. This includes enhanced reviews in staffing requirements, food service, transfer requests, inmate appeal rights, correctional services, and safety. In addition, BOP has heightened reporting procedures to require that contractors provide greater detail regarding safety and security information in a manner conducive to trend analysis and comparative reviews. BOP has also improved monitoring of healthcare programming by adding an additional subject-matter expert to the monitoring team, which has developed a system for enhanced tracking of routine medical services. Going forward, the BOP will carefully review this enhanced information and its updated inspection tools on a regular basis to ensure the contract prisons' ongoing effectiveness.
