You will join the Council Session from 2:00pm - 2:30pm, during which time you will provide brief remarks and answer questions.

Proposed remarks are provided in **TAB 2**.

NCAI vetted and previewed for us the likely questions you will be asked. We have provided suggested responses for you in **TAB 3**.

For your situational awareness, we expect Secretary Haaland to address the session just before you.

II. National Congress of American Indians

a. Background

NCAI was founded in 1944 in response to the "Indian termination" policies which sought to limit Tribal sovereignty and force assimilation.

Today, NCAI bills itself as "the oldest, largest, and most representative American Indian and Alaska Native organization serving the broad interests of Tribal governments and communities." The organization's stated purpose is to "serve as a forum for unified policy development among Tribal governments" to: (1) advance Tribal governance and treaty rights; (2) promote Tribal economic development, health, and welfare; and (3) give the public a better understanding of Tribes.

NCAI represents a diverse network of Tribal nations, citizens, and organizations, but it does <u>not</u> formally represent Tribal governments.

NCAI's Executive Council Winter Session offers Tribes an opportunity to hear from members of Congress and the Administration to further inform and strengthen important government-to-government relationships.

Several members of the Biden Administration have spoken at NCAI events. For example, Vice President Harris and five Cabinet members spoke at NCAI's Annual Convention in October 2021.

b. Leadership & Relevant Biographies

NCAI is governed by voting members who elect an Executive Committee. The Executive Committee includes the NCAI President, Frist Vice President, Recording Secretary, Treasurer, and 12 Regional Vice Presidents. All members serve two-year terms.

The current NCAI President is Fawn Sharp. Ms. Sharp is the previous President and current Vice President of the Quinault Indian Nation in Washington.

Your session will be led by NCAI's new Chief Executive Officer Dante Desiderio and First Vice President Mark Macarro.

Dante Desiderio previously served as the Executive Director of the Native American Finance Officers Association (NAFOA), a national organization focused

on growing Tribal economies. Under his leadership, the organization increased its focus on economic growth by developing a robust advocacy presence in Washington, D.C. Mr. Desiderio is a member of the Sappony, an Indian Tribe based on the border of North Carolina and Virginia, where he serves in a leadership and advisory role on a number of programs related to community and economic development. He previously served on the inaugural board of the Center for Indian Country



Development at the Federal Reserve Bank of Minneapolis and on an Advisory Boards for the University of North Carolina and Arizona State University.

Mark Macarro has been the elected Tribal Chairman of the Pechanga Band of Luiseño Indians in Southern California for over twenty years. He first was

elected to the Pechanga Tribal Council in 1992. Chairman Macarro served as program manager for the library and museum of the Rincon Reservation from 1992 through 1995, and as the director of youth education at Soboba Reservation's Noli School from 1990 through 1992. He began his career in Indian country as a grants/contracts administrator for the Pechanga Reservation in 1988. He also served as a California state credentialed substitute teacher for grades 7-12. Chairman Macarro's father, the late Leslie Macarro, was a Pechanga Tribal member and a



correctional peace officer killed in the line of duty in May of 1988 while working for the California Youth Authority.

III. Background for Q&A Topics

During your session, you will engage in an approximately fifteen-minute question and answer session with Executive Director Desiderio and Chairman Macarro. They have previewed the expected questions, which broadly speaking cover four main areas: (a) implementation of President Biden's recent Executive Order on Tribal public safety; (b) the reauthorization of the Violence Against Women Act (VAWA); (c) principles underlying the nation-to-nation relationship between Tribes and the Federal Government; and (d) Native American Voting Rights. The expected questions and proposed answers are located in **TAB 3**.

a. Executive Order 14053

On November 15, 2021, you attended the White House Tribal Nations Summit. During that event, you joined President Biden when he signed Executive Order 14053, "Improving Public Safety and Criminal Justice for Native Americans and Addressing the Crisis of Missing or Murdered Indigenous Persons."

The Executive Order directs the Justice Department to take a number of steps, many of which overlap with previous Department workstreams.

Section 2 of the E.O. directs the Justice Department to develop a comprehensive strategy regarding federal law enforcement's efforts to prevent and respond to violence against Native Americans, including MMIP cases. The plan will also require the Department to designate a person to serve as an outreach services liaison for relevant federal criminal cases.

Section 3 of the E.O. directs the Departments of Justice and Interior to develop guidance and technical assistance for Tribal entities on a series of topics, including implementing special domestic violence criminal jurisdiction under VAWA, responding to *McGirt*, coordinating Tribal Community Response Plans, and providing grants to support Tribal law enforcement and victim services programs.

<u>Section 4</u> of the E.O. focuses on improving data collection, analysis, and information sharing. This focus area overlaps with requirements in Savanna's Act and recommendations from a recent GAO report.

<u>Section 5(c)</u> of the E.O. directs the Interior Department to consult with the Attorney General to evaluate existing technical assistance regarding community-based conflict resolution, healing courts, and culturally appropriate victim services.

<u>Section 6</u> of the E.O. prioritizes the role of Tribal consultations.

The same day that President Biden executed the E.O., the Deputy Attorney General issues a memorandum creating a **Department Steering Committee to Address the Crisis of Missing or Murdered Indigenous Persons**.

The Steering Committee, which is led by ODAG and the Office of Tribal Justice, is taking a holistic approach to aligning and improving the Department's efforts to address the MMIP crisis. It includes COPS, CRM, CRT, EOUSA, FBI, OJP, OLP, OVW, and USMS.

b. VAWA Reauthorization

The 2013 reauthorization of VAWA included a historic provision that recognized the inherent authority of Tribes to exercise special domestic violence criminal jurisdiction over non-Indian offenders who commit acts of domestic violence in Indian country. *See* 25 U.S.C. § 1304.

After that reauthorization, the Justice Department moved swiftly to implement the law's initial pilot project structure in 2013. That project remains in effect today. That pilot laid the foundation for the 27 tribes that exercise special domestic violence criminal jurisdiction today.

NCAI has been a key voice in pushing for further expansion of special domestic violence criminal jurisdiction in the current efforts to reauthorize VAWA.

On February 9, 2022, a bipartisan group of Senators joined together to introduce the VAWA Reauthorization Act of 2022. This followed similar efforts in the House last year.

The introduced reauthorization legislation would allow participating Tribes to prosecute non-Indian perpetrators of sexual violence, sex trafficking, domestic

violence against child victims, stalking, and elder abuse. The proposed legislation would also seek to expand special domestic violence criminal jurisdiction to Alaska Native villages on a pilot basis.

The Administration and the Department have been vocal supporters of the reauthorization legislation, including the expanded special domestic violence criminal jurisdiction provisions.

c. Nation-to-Nation Relationship

You may be asked about the Department's commitment to respecting its nation-to-nation relationship with Tribal partners, including through its U.S. Attorney's Office (USAO) operations and litigating positions in the Supreme Court.

In 2010, Deputy Attorney General Ogden issued a memorandum regarding an "Indian Country Law Enforcement Initiative." This document spelled out a new policy for USAOs with Indian Country jurisdiction. As part of that plan, USAOs are required to develop operational plans for addressing public safety in Indian Country. The 2010 Ogden Memorandum makes clear that those plans should be based on Tribal consultations.

We understand the DAG is considering updating the 2010 Ogden Memorandum. Though we should <u>not</u> announce that update yet, we can commit to furthering and building on the principles in the 2010 Ogden Memorandum.

With respect to the Department's positions on litigation issues related to treaty and trust obligations, the safest reference point is the Memorandum of Understanding that you signed in October. This document reinforced the Justice Department's commitment to respecting Tribal sovereignty and promoting Tribal treaty rights.

d. Native American Voting Rights

Given the rural and disconnected nature of many Native reservations, ballot access and voting rights are key areas of concerns for Tribal stakeholders.

In March 2021, President Biden issued an Executive Order on "Promoting Access to Voting." 86 Fed. Reg. 13623 (Mar. 10, 2021). Section 10 of that order established a "Native American Voting Rights Steering Group." The Steering Group was tasked with (1) engaging in consultations with Tribes on voting rights issues, and (2) issuing a report on protecting voting rights for Native Americans.

Justice Department staff participated in the consultations and have weighed in on early drafts of the report, which will be published in March.

As a more general matter, the Department's efforts to protect and promote voting rights across the country includes protecting the franchise in Indian country.

IV. Miscellaneous Item – Tribal Nations Leadership Council

In 2010, Attorney General Holder established the Tribal Nations Leadership Council. The purpose of the Council is to facilitate dialogue and coordinate efforts between the Justice Department and Tribal governments.

The Council is comprised of twelve Tribal leaders, each representing Tribes in their respective region (as defined by the Bureau of Indian Affairs). Council members are selected by their peers.

The Council has not met with senior Department leadership since December 2017. Though the Office of Tribal Justice routinely holds calls with the Council, Council members have repeatedly requested a meeting with current Department leadership.

We recommend that in your brief opening remarks to NCAI, you commit to meeting with the Council this Spring.

And the operative text at 523.43 states: (a) Procedure for loss of FSA Time Credits. An inmate may lose earned FSA Time Credits for violation of the requirements or rules of an EBRR Program or PA.



Attached is the ES memo and strategic plan that is on its way to OAG. There is a placeholder for a message from the AG on page 2. The text on pages 5 and 6—mission, values, introduction—has been edited and approved by the DAG, but if the AG wants to make changes there, it won't cause too much heartburn. The text in Section II, and especially the metrics, however, has been vetted repeatedly through the components—in addition to having been edited and approved by the DAG. In many cases, the components feel strongly about particular words and terms of art that describe their work, including their statutory missions and limitations. Section III has also been cleared twice. If the AG wants to make changes in these sections, we would appreciate the opportunity to check with the affected components to at least let you know if they believe it would be problematic. Also, because the Publisher format is a little finicky (and doesn't have a track changes feature) and because we are still finalizing the technical material in the appendices, we think it's easiest if I hold on to the pen.

OMB is focused on the Agency Priority Goals. They are pulling those together from all the agencies and are going to format and publish them in a variety of ways, which requires lead time. We understand that our ability to make changes to those at the staff level ends on Friday (2/18). As noted in the cover memo, the whole plan is due to OMB on 2/23. The Strategic Planning and Performance Staff in JMD will transmit the final once approved.


