It is concerning that they would make all of these statements about DOJ without allowing us to review. I think the statements about EMTALA, HIPAA, and the AG statement on travel are accurate. But I'm concerned about this:

DOJ will defend any VA providers whom states attempt to prosecute for violations of state abortion laws.

We have been much more careful in our wording, saying only that we'd defend providers prosecuted for appropriately carrying out their duties. And I don't think the WH should be announcing who DOJ will defend. I would be strongly inclined to ask them to correct this to: "DOJ has stated that it will defend any VA providers whom states attempt to prosecute for appropriately carrying out their duties," although I'd pull the exact language of our prior statements first. (In the car now so I can't do it.)





As we discussed, the Presidential Memorandum of January 22, 2023, calls on the Attorney General, HHS Secretary, and DHS Secretary to provide information on:

- i) potential barriers faced by patients seeking legal access to mifepristone or other reproductive healthcare, as well as by providers and entities, including pharmacies, that provide reproductive healthcare in providing mifepristone or other reproductive healthcare, and any recommendations for addressing these barriers; and
- (ii) whether any additional institutional resources may be necessary to address these barriers.

CRT's jurisdiction--and therefore, our information—focuses on the FACE Act. The essential purpose of the ACT is to prevent individuals from erecting barriers to accessing reproductive health care. The attached discussion thus responds to the Presidential Memorandum by addressing our FACE Act prosecutions, and that is all it addresses.



# HHS Secretary Xavier Becerra Issues Statement on Supreme Court Issuing Stay in Alliance for Hippocratic Medicine v. FDA



This afternoon, the Vice President will convene the Task Force on Reproductive Healthcare Access to discuss steps the Administration is taking to protect women's access to reproductive health care, particularly in the wake of Friday's court decision on medication abortion. Coinciding with the meeting, the Administration announced a series of new actions to safeguard patient privacy. Below are talking points and resources around the announcements and meeting. The beginning of the Task Force meeting will be <u>livestreamed</u> at <u>2:45pm ET today</u>.

#### **Talking Points:**

Hi all,

- Today, the Biden-Harris Administration is announcing new actions to safeguard patient privacy at the third
  meeting of the Task Force on Reproductive Healthcare Access with Vice President Harris, in the wake of
  unprecedented attacks against women's reproductive health care.
  - 1. The Department of Health and Human Services is issuing a Notice of Proposed Rulemaking to strengthen privacy protections under HIPAA to strengthen patient-provider confidentiality and help health care providers give complete and accurate information to patients. HHS is also issuing guidance to better safeguard patients' electronic health information, including their information related to reproductive health care.
  - 2. The Department of Education is issuing guidance on student privacy under FERPA and a know-your-rights resource to help students understand their privacy rights for health records at school.

- 3. The Federal Communications Commission is launching a new guide for consumers on best practices for protecting their data on mobile phones, including geolocation data, which can be especially important in the context of accessing reproductive health care.
- 2. Today's Task Force meeting comes in the wake of Friday's court decision, when a district court in Texas took the dangerous step of rejecting FDA's approval of a needed medication—mifepristone, a drug used in medication abortion that the FDA first approved as safe and effective over two decades ago.
  - 1. If Friday's preliminary injunction stands, it will put women's health at risk and undermine FDA's ability to keep safe and effective medications available to patients who need them.
  - 2. We are fighting this ruling in the courts, and the Department of Justice has already filed a notice of appeal to the Fifth Circuit Court of Appeals and sought a stay of the injunction pending appeal.
- 3. Even as we continue our fight in the courts to protect access to medication abortion, our Administration will continue to push on all fronts to defend reproductive rights and take meaningful steps to protect access to reproductive health care.

#### Topline points on Texas decision:

• We strongly disagree with the Texas District Court's decision.

- A court in Texas has taken the virtually unprecedented step of rejecting FDA's approval of a needed medication. If today's decision stands, it will put women's health at risk and undermine the FDA's ability to keep safe and effective medications available to patients who need them.
- We were prepared for this outcome, and the Department of Justice has already announced that they will be appealing the court's decision and seeking a stay pending appeal. Mifepristone continues to be available and approved for the time being. The Justice Department is reviewing the decision from Washington State.
- First, this lawsuit is an attack on access to medication writ large. While an outrageous attack on women's access to reproductive care, this decision goes beyond that to undermine basic health care and access to FDA-approved medicine. It poses an existential threat to the FDA's authority to review and approve a wide range of safe and effective drugs.
- Second, we will continue to stand by the safety record of mifepristone—a drug that has been on market for more than 20 years and is used safely in more than 60 countries and provides critical care for women. FDA has carefully considered and reviewed clinical evidence regarding this medication and determined it is safe and effective for the last two decades.
- Third, today's decision further strips away a woman's ability to make decisions about her own body with her doctor. This decision, if it stands, will prevent women across the country from accessing an essential FDA-approved drug. And it threatens not only the use of this medication for abortion, but also for other critical purposes—like helping women manage miscarriages.
- It's another step towards the ultimate goal we've heard from anti-choice officials at both the state and national level—eliminating access to abortion for all women in every state.

- Attempting to take an entire drug off the market is a dangerous interference in health care determinations by the FDA, based on science.
- Our Administration will work to protect reproductive rights and to ensure women can make their own decisions about their own bodies.

#### What will the FDA do in response to the decision? Will FDA withdraw mifepristone from the market?

- We are not going to get ahead of the courts. As of Friday, the Texas decision is stayed for seven days, so the status quo remains in place. Mifepristone remains approved and available for use by women and health care providers.
- DOJ has already appealed and we will continue to fight in the courts to maintain the stay and ultimately win this case in the Supreme Court, if necessary.

### What do next steps look like? Will the Administration be taking any additional action to protect access to mifepristone?

- As I said, we are prepared for this fight.
- DOJ has already appealed and we will continue to fight in the courts to maintain the stay and ultimately win this case in the Supreme Court, if necessary.
- We also want to be clear that protecting access to abortion has long been a major priority, a priority made
  more urgent by the Supreme Court's decision in Dobbs. The President and Vice President have consistently
  underscored the importance of FDA-approved medication abortion including on the day of the *Dobbs*decision, in Executive Orders, and most recently in a Presidential Memorandum issued in January 2023.
- The Texas lawsuit is a continuation, and escalation, of attacks on evidence-based policies that the Administration put in place to ensure access to this safe and effective medication.

#### Washington State/ mifepristone decision

• The Department of Justice is still reviewing this case so I have no comment beyond that.

#### Call to ignore court ruling

- We stand by FDA's approval of mifepristone, and we are prepared for a long legal fight, if needed.
- DOJ has already appealed and we will continue to fight in the courts to maintain the stay and ultimately win this case in the Supreme Court, if necessary.
- We understand the frustration regarding this decision.
- But as dangerous a precedent it sets for a court to set aside FDA's expert judgment regarding a drug's safety and efficacy, it would also set a dangerous precedent for the Administration to disregard a binding decision.
- There is a process in place for appealing this decision and we will pursue that process vigorously and do
  everything we can to prevail in the courts.

#### Home base abortion points:

- Reproductive freedom is a fundamental right and medical decisions should be made between a woman and her doctor without government interference.
- The vast majority of Americans agree. But Republican officials have introduced more than 300 bills restricting abortion so far this year.
- The Biden-Harris Administration is coordinating with state leaders who are fighting to protect reproductive rights.
- And we've taken historic action to expand access to reproductive health care:
  - The President's Task Force on reproductive health care access is working across the federal government to protect access to care.
  - And he's signed two Executive Orders to protect access to abortion and contraception, support a
    woman's right to travel for medical care, strengthen privacy measures, and address discrimination in
    health care.
  - President Biden also issued a Presidential Memorandum on what would have been the 50<sup>th</sup> anniversary of Roe v. Wade that is aimed at protecting safe access to medication abortion in particular.


