Good afternoon, Mr. Brown,

Thank you for speaking with me last week. As we discussed, we hope to speak with you soon regarding any information possessed by your client, Mr. Jeffrey Rosen, which is *not* already available in another setting. We seek to discover whether Mr. Rosen possesses knowledge that may not have been fully explored in his prior testimony. We are particularly interested in communications between Mr. Rosen and former President Trump, Mark Meadows, Pat Cipollone, former Vice President Pence and his staff, or others concerning circumstances and events in Georgia. The Special Purpose Grand Jury is trying to determine the level of knowledge within the White House concerning Georgia-related allegations of electoral fraud, malfeasance, or interference.

As you have noted, Mr. Rosen has offered testimony in several settings regarding the events following the general election of 2020. While we do not possess all of the materials and transcripts related to Mr. Rosen's testimony, we have reviewed the transcripts of his interview with the Senate Judiciary Committee as well as the public portions of his testimony before the January 6th Select Committee. We now seek to understand whether Mr. Rosen possesses any additional information relevant to the SPGJ's investigation that may not have been fully examined in his prior appearances.

We hope to discuss any relevant information discussed in the following communications involving Mr. Trump:

- A meeting on December 15, 2020, between Mr. Trump, Mr. Richard Donoghue, and Mr. Rosen, in which the
 "suitcases of ballots" allegations from State Farm Arena were discussed, as well as the issue of "sending a letter
 to state legislatures in Georgia or other states"
- A phone call on December 24, 2020
- A phone call on December 27, 2020, described by Mr. Rosen as a "longer call" with references to the Georgia Senate runoff races
- A phone call on December 28, 2020
- A phone call on December 30, 2020, in which Mr. Rosen indicated that DOJ would not pursue election litigation requested by the president
- A meeting on December 31, 2020, including Mr. Trump, Mark Meadows, Pat Cipollone, Richard Donoghue, and Chad Mizelle, during which the former president wanted to discuss voting machines and dissatisfaction with DOJ's investigations
- A phone call on January 3, 2021, in which Mr. Trump asked Mr. Rosen about a report of a truck full of shredded ballots in Cobb County, Georgia

Additionally, we hope to generally discuss any instances in which the following topics were discussed:

- The specific claims cited by former President Trump on a January 2, 2021 phone conversation with Georgia Secretary of State Brad Raffensperger; these include the following claims:
 - o "250-300,000 ballots dropped mysteriously into the rolls"
 - Tens of thousands of voters turned away from polls because "they've already been voted for"

- 4,502 votes from people who were not registered at all
- 18,325 votes from "vacant address voters"
- 904 votes from voters registered at a P.O. Box
- 4,925 out-of-state voters
- 5,000 "dead people" who voted
- 3,000 pounds of shredded ballots
- Numerous claims and statements related to events at State Farm Arena, including claims regarding Ms.
 Ruby Freeman or Ms. Shaye Moss
- Any knowledge or discussion of the plan to convene and submit electoral votes from alternative slates of Trump electors in various states, including Georgia

While we would also welcome additional insight into the circumstances surrounding Jeff Clark's proposed appointment as Acting Attorney General, since it is clearly very relevant to Georgia, we understand that Mr. Rosen has testified extensively on this subject. We intend to inquire further into a specific topic related to Mr. Clark: the January 3, 2021 Oval Office meeting concerning Mr. Clark reportedly contained a discussion of numerous specific allegations of voter fraud from various states, including Georgia. We are interested in Mr. Rosen's recollection, if any, of Georgia-specific allegations discussed during that meeting.

Finally, to the extent possible, if you are able to assist us in acquiring additional testimony or other tangible evidence from Mr. Rosen relating generally to the above topics which we currently do not possess, we would greatly appreciate such assistance.

Once you have had the opportunity to go over the above circumstances and issues, please contact me to schedule a time to speak again. We hope that we are able to fulfill our duty to the SPGJ while also respecting the concerns of DOJ and your client. Thank you very much for your time and attention in these extraordinary circumstances.
