Maggie and Julie,

Attached is a list of representative active matters under the TFKC ambit. These are not nearly all of the efforts that are currently ongoing, both under our direct supervision and through the efforts of USAOs around the country. Rather, these reflect successes to date and cases that are representative of 1) continuing efforts for short-term seizures, and 2) mid- and long-term priorities focusing on facilitators and evasion networks.

As discussed, I am providing below a handful of talking points for interactions with the French, Czech, and Ukrainian counterparts, as well as some information on HSI's substantial efforts in support of the Task Force to date.



- (U) the United States plans to designate the following individuals and entities pursuant to Russia-related Executive Order (E.O.) 14024:
 - (U) **Public Joint Stock Company Transkapitalbank (TKB)** and its subsidiary **Joint Stock Company Investtradebank**. TKB has offered its clients the ability to conduct transactions through its proprietary Internet-based banking system, called TKB Business, as an alternative communication channel to the Society for Worldwide Interbank Financial Telecommunication (SWIFT). TKB has offered this service in part for the purpose of processing U.S. dollar (USD) payments for sanctioned clients. TKB's solicitation of business from sanctioned persons heightens the enforcement risks that TKB poses for third countries. In addition, U.S. businesses are generally shunning exposure to Russia, and continued relationships with TKB absent authorization could threaten business relationships with U.S. firms. TKB is being designated for operating or having operated in the financial services sector of the Russian Federation economy. Joint Stock Company Investtradebank is being designated for being owned or controlled by, or for having acted or purported to act for or on behalf of, directly or indirectly, TKB.
 - (U) **Konstantin Malofeyev** has been designated by OFAC pursuant to E.O. 13660 since 2014 and has also been sanctioned by Australia, Canada, the European Union (EU), Japan, New Zealand, and the United Kingdom (UK). Malofeyev has funded separatist activities in Ukraine and supported pro-Russian activities that have undermined democracy, interfered in elections, and reduced security and stability in several countries. On April 6, the U.S. Department of Justice charged Malofeyev with conspiracy to violate U.S. sanctions and violating U.S. sanctions in connection with his hiring an American citizen to work for him in operating television networks in Russia and Greece and attempting to acquire a television network in Bulgaria. Malofeyev also allegedly conspired to illegally transfer a \$10 million investment he made in a U.S. bank to a business associate in Greece. Malofeyev is being designated under E.O. 14024 for having acted or purported to act for or on behalf of, directly or indirectly, the Government of the Russian Federation (GoR).
 - (U) Treasury will designate an additional 27 entities which are part of Malofeyev's global sanctions evasion and disinformation network:
 - The **Autonomous Noncommercial Organization for the Study and Development of International Cooperation in the Economic Sphere International Agency of Sovereign Development (IASD)**, a financial advisory structure registered in Moscow that pursues deals around the world to facilitate business opportunities for sanctioned Russian companies and enrich Malofeyev himself, is being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Malofeyev.
 - Financial services company **Agent de Asigurare Lider Asig Societate cu Raspundere Limitata**, financial company **Organizatia de Creditare Nebancara Lider Leasing SRL**, diversified company **OKAF Trading Societatea cu**

- **MGI PTE Ltd**, a Singapore-based management consultancy, facilitated IASD's activities in Cuba and is being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, IASD.
- **Joint Stock Company Marshal.Global (MarGlo)**, a Moscow-based financial company linked to a number of Malofeyev associates, provides a wide range of financial services that enables sanctioned Russian companies to attempt to evade U.S. sanctions. MarGlo is being designated for operating or having operated in the financial services sector of the Russian Federation economy and also for being responsible for or complicit in, or having directly or indirectly engaged or attempted to engage in, deceptive or structured transactions or dealings to circumvent any United States sanctions, including through the use of digital currencies or assets or the use of physical assets, for or on behalf of, or for the benefit of, directly or indirectly, the GoR.
- Russia-based **Tsargrad OOO (Tsargrad)** is a cornerstone of Malofeyev's broad malign influence network. Tsargrad, through its affiliated channel Tsargrad TV, spreads pro-Kremlin propaganda and disinformation that is amplified by the GoR. Tsargrad served as an intermediary organization between pro-Russian European politicians and Russian officials, and recently pledged to donate more than \$10 million to support Russia's unprovoked war in Ukraine. Tsargrad is being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Malofeyev.
- **Analiticheski Tsentr Katekhon OOO (Katekhon)**, located in Moscow, purports to be a think tank but actively disseminates anti-Western and pro-Kremlin disinformation, including extreme anti-Ukrainian content. Katekhon is being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Tsargrad.
- The **All-Russian Public Organization Society for the Promotion of Russian Historical Development Tsargrad (Tsargrad Society)** is a Russia-registered organization which has been accused of involvement in espionage on behalf of Russia. Tsargrad Society is being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Malofeyev.
- Several other parts of Malofeyev's Tsargrad network are also being designated. **Teshilovo OOO** and **Spetsinvestservis OOO (Spetsinvestservis)** are being designated for being owned or controlled by, or having acted or purported to act

for or on behalf of, directly or indirectly, Malofeyev. **Imenie Tsargrad OOO (Imenie), Tsargrad-Media OOO (Tsargrad-Media)**, and Crimea, Ukraine-based **Kurort Livadiya OOO** are being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Tsargrad. **Tsargrad Park OOO (Tsargrad Park), Kurort Tsargrad Spas-Teshilovo OOO, Zareche-Oka OOO, Proizvodstvenno-Stroitelnaya Kompaniya SNM, Imperiya 19-31 OOO (Imperiya), and Ekoferma Zareche OOO** are being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Imenie. **Tsargrad-Kultura OOO** is being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Tsargrad-Media. **Kontur OOO** and **Tureya OOO** are being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Imperiya.

- **Limited Liability Company Vladeks Kholding, Limited Liability Company Vladeks, and Limited Liability Company Russian Digital Solutions**, all Russia-based companies, are being designated for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Kirill Konstantinovich Malofeyev, Malofeyev's adult son who is also being designated.

 - Russian national **Mikhail Aleksandrovich Leshchenko**, MarGlo's general director, is being designated for being or having been a leader, official, senior executive officer, or member of the board of directors of MarGlo.
 - Russian national **Pavel Vladimirovich Kuzmin** provided legal services to Malofeyev in multiple capacities, including as IASD's legal chief and the director of legal services at Tsargrad. Tsargrad-Media and Tsargrad Park general director **Natalya Aleksandrovna Tyurina** is being designated for being or having been a leader, official, senior executive officer, or member of the board of directors of Tsargrad-Media and Tsargrad Park.

In 2021, Bitriver shifted legal ownership of its assets to a Switzerland-based holding company, Bitriver AG, which is being designated for operating or having operated in the technology sector of the Russian Federation economy. Due to the distributed nature of blockchain-based assets, virtual currency users typically have no way of discerning whether the energy expended to confirm their transactions also generated revenue for the Russian war machine. The United States is committed to ensuring that no asset, no matter how complex, becomes a mechanism for the Putin regime to offset the impact of sanctions. Treasury is additionally designating 10 Russia-based subsidiaries of Bitriver AG for being owned or controlled by, or having acted or purported to act for or on behalf of, directly or indirectly, Bitriver AG: **ООО Management Company Bitriver, ООО Bitriver Rus, ООО Everest Grup, ООО Siberskie Mineraly, ООО Tuvaasbest, ООО Torgovy Dom Asbest, ООО Bitriver-B, ООО Bitriver-K, ООО Bitriver-North, and ООО Bitriver-Turma**.
- (U) Treasury is designating 16 board members of Public Joint Stock Company Bank Financial Corporation Otkritie (Otkritie) for being or having been leaders, officials, senior executive officers, or members of the board of directors of Otkritie, an entity whose property and interests in property are blocked pursuant to E.O. 14024. along with 12 of its subsidiaries, was designated on February 24 for operating or having operated in the financial services sector of the Russian Federation economy. The 16 board members being designated are 15 Russian nationals, **Kseniya Valentinovna Yudayeva, Mikhail Yurevich Alekseev, Anatoly Mikhailovich Karachinskiy, Vladimir Vladimirovich Kolychev, Alexey Yurevich Simanovskiy, Andrey Fedorovich Golikov, Elena Borisovna Titova, Mikhail Mikhaylovich Zadornov, Dmitriy Olegovich Levin, Svetlana Petrovna Emelyanova, Tatyana Gennadevna Nesterenko, Irina Vladimirovna Kremleva, Viktor Andreevich Nikolaev, Sergey Georgievich Rusanov, and Nadia Narimanovna Cherkasova**, and one New Zealand national, **Paul Andrew Goldfinch**.

Dear Secretaries Blinken and Yellen,

We write to urge the Biden Administration to examine U.S. sanctions on goods that are produced by or benefit Russian companies or oligarchs close to the Kremlin, specifically in the diamond industry and Alrosa, a company already sanctioned to an initial degree along with its CEO Sergei Sergeevich Ivanov. We commend President Biden's March 11th announcement that the United States would prohibit imports of Russian-origin diamonds and agree that those who personally gain from the Kremlin's policies should share in the pain of a vigorous sanctions regime. With that said, more must be done to make sure that sanctioned Russian companies and the oligarchs that run them cannot exploit loopholes to profit from U.S. consumers and the global economy.

Alrosa is the world's largest diamond mining company, with sales that totaled \$4.2 billion in sales last year, it is responsible for 90 percent of Russia's diamond mining capacity, which accounts for 28 percent globally. It is a company that is one-third owned by the Russian government, and until recently had an office in New York City. Alrosa's CEO is Sergei Sergeevich Ivanov, son of one of Putin's closest allies, Sergei Borisovich Ivanov. Sergei Borisovich Ivanov previously served as the Chief of Staff of the Presidential Executive Office, Deputy Prime Minister, and Defense Minister of Russia and remains a permanent member of the Security Council of the Russian Federation.

We are concerned that the two tranches of sanctions issued by the Treasury Department to target Russia's diamond industry will have a minimal impact on Alrosa and Sergei Ivanov's ability to freely operate on the world market. The February 24th sanctions that listed Alrosa only blocked debt and equity transactions, making a small dent in Russia's oversized stake in the global diamond trade.¹ Although an important initial step, along with the designation of Alrosa's CEO, these have yet to impede trade and revenues that eventually reach the Kremlin.

The administration also announced an import ban on March 11th which would ban "products of Russian Federation origin," including non-industrial diamonds, from entering the United States.² Experts note a "major loophole" remains in the sanctions regime that allows for importation of diamonds manufactured in India or elsewhere because of the interpretation provided in OFAC FAQs.³ Namely, the term "Russian Federation origin" excludes goods "substantially transformed in a third country," and it has long been the view of Customs and Border Protection that the cutting or polishing of diamonds in a third country would qualify as a substantial transformation. A recent report on the diamond industry indicated approximately

95% of the world's diamonds are cut and polished in India.⁴ Thus, as it stands at this time, a diamond can be mined by an Alrosa subsidiary, polished or cut in India or another country, and sold to the United States without any prohibition, making a profit for the Russian government.

We first ask that the Treasury Department reconsider the interpretation of origin that allows for the importation of diamonds from countries that may cut or polish Alrosa's diamonds. Second, the United States should work with its Indian counterparts, as well as those in trading centers such as Dubai, to ensure they are not being used to line the pockets of those closest to Vladimir Putin. Finally, State and Treasury Departments should provide guidance to Customs and Border Protection (CBP) and the Department of Homeland Security (DHS) to ensure we prohibit the importation of Russian diamonds into the United States.

Vladimir Putin's unprovoked and brazen invasion of the sovereign territory of Ukraine should be met with a forceful response from the United States and its partners. Luxury goods, especially items like diamonds that are used mainly for export to wealthy nations, should be among the first that Treasury and State Departments consider future action. We ask for your consideration of additional actions that would constrain the Kremlin's capacity to access revenue from their diamond industry which could fund the invasion of democratic and sovereign Ukraine.
