3 was. And we talked about, you know, a number of things,
4 from Mosul Dam to Syria. But then I -- on the 2nd, I, I was
5 supposed to call -- it was Kevin McCarthy. I was supposed
6 to get in touch with him because -- this was after the 14th
7 election and he won -- you know, they won.

8 MR. ZWONITZER: Right.

9 PRESIDENT BIDEN: And I wanted to talk to him
10 about how we proceed --

11 MR. ZWONITZER: It looked like he was going to
12 Speaker at that -- or --

13 PRESIDENT BIDEN: Well, no.

14 MR. ZWONITZER: -- not Speaker.

15 PRESIDENT BIDEN: But he was going to be the
16 number two guy.

17 MR. ZWONITZER: Right.

18 PRESIDENT BIDEN: Yes, he was.

19 MR. ZWONITZER: Yeah.

20 PRESIDENT BIDEN: And, and but he wanted to talk
21 to me about what we could get done; where, where could we
22 cooperate.

23 MR. ZWONITZER: Right.

24 PRESIDENT BIDEN: And he came over to the house.
25 Then there was a Bono event and I was supposed to come up --

8 the Department of Defense, as well as with Department of
9 Energy, because we were putting together a program where

11 major initiative on rebuilding the energy infrastructure
12 because it was so vulnerable because a lot of it was along
13 the shoreline, a lot of it was -- there were -- we talked
14 about -- there were several billion dollars' worth of
15 outages a year that cost consumers a lot and how we could be
16 -- we should -- we could be -- our grid could be vulnerable
17 to being shut down.

18 MR. ZWONITZER: Right.

19 PRESIDENT BIDEN: Not by cyber, but by natural
20 disaster.

21 MR. ZWONITZER: Right. Hurricane. Right.

22 PRESIDENT BIDEN: Global warming, hurricanes and
23 Sandy-type storms.

24 MR. ZWONITZER: Is there any discussion of -- does
25 he ever talk about decentralizing -- I mean, uncoupling --

3 small --

4 PRESIDENT BIDEN: Yeah. He talks about basically
5 a new grid. What he talks about is -- for example, he
6 points out that there are -- I don't have the numbers.

8 thousand miles of gas pipeline --

9 MR. ZWONITZER: Um-hum.

10 PRESIDENT BIDEN: -- most of it laid in the '50s,
11 a lot of it leaking. He talks about how what a clear and
12 present danger it is, particularly in New England. He talks
13 about some of our water infrastructure being, being wooden
14 pipes that are still --

15 MR. ZWONITZER: Still wooden pipes?

16 PRESIDENT BIDEN: -- wooden, wooden. Wooden.

17 Talks about how they've some -- there's methane
18 leaking from some of these pipes and the number of jobs we'd
19 create. We can get all this information easy enough.

20 And I ended up going up - I can't remember when -
21 going up to Philadelphia to talk to the PENG (phonetic)
22 about all the stuff that they, they could and should be
23 doing to, to significantly increase the, the safety --

24 MR. ZWONITZER: Um-hum.

25 PRESIDENT BIDEN: -- of the system, and how --

2 PRESIDENT BIDEN: -- many hundreds of thousands of
3 jobs we'd create, et cetera.

4 And so I was, I was the guy who was -- you know,
5 lead that effort for -- and which we, which we started to
6 do. And --

7 MR. ZWONITZER: I got the sense that the Secretary
8 of Energy is a guy who is pretty optimistic about, like,
9 just what was going on with, with energy --

10 PRESIDENT BIDEN: Yeah, no, no. He was --

11 MR. ZWONITZER: -- ((b)(6), (b)(7)(C) 0:04:33.6)
12 energy in general.

13 PRESIDENT BIDEN: -- optimistic and he talked
14 about the great chances, and he thinks that I'm the only one
15 who really understands it and he needed me to be the face of
16 this effort, which for the better part of that year that I
17 was.

18 We also talked about, at that same thing -- we
19 talked about vets projects that had to take place, had to be
20 -- to deal with the plight of veterans.

21 I talked about -- talked with Congressman Tim
22 Murphy of Connecticut. He had a bill to, to --

23 (Phone ringing.)

24 PRESIDENT BIDEN: -- focus on mental health.

25 Hello? No, she's not here yet. Let's wait --

2 PRESIDENT BIDEN: -- 'til she gets here, okay?
3 I'll call you ((b) (6), (b) (7)(C) 0:05:34.5).

4 And -- so I talked about that, and gun safety and
5 mental health was a -- was the -- that was the connection.

6 MR. ZWONITZER: He was a --

7 PRESIDENT BIDEN: He's a congressman --

8 MR. ZWONITZER: He was in the --

9 PRESIDENT BIDEN: -- in Connecticut.

10 MR. ZWONITZER: -- from near Newtown?

11 PRESIDENT BIDEN: Yeah.

12 MR. ZWONITZER: Yeah.

13 PRESIDENT BIDEN: Well, maybe not -- I don't think
14 he's -- represents Newtown, but near.

15 MR. ZWONITZER: Okay.

16 PRESIDENT BIDEN: And then talked with National
17 Security Advisor Susan about following up with Brazil and
18 Dilma, which I was getting back on track. I was working her
19 really hard. I --

20 MR. ZWONITZER: You had been there New Years,
21 right? To Brazil?

22 PRESIDENT BIDEN: Yeah. Remember, though, she was
23 -- she -- I was one that rebuilt the relationship with her.

24 MR. ZWONITZER: Right. After the --

25 PRESIDENT BIDEN: After the WikiLeaks stuff and --

2 MR. ZWONITZER: Right.

3 PRESIDENT BIDEN: -- all that. And so I spent a
4 lot of time putting that relationship back and then she gets
5 impeached, but --

6 I spent a lot of time, Tony and I, talking about
7 Ukraine and it unfolding. And I talked -- I called Jim
8 Inhofe, talking about energy infrastructure. He's from
9 Oklahoma, and, you know, talk about why this could work for
10 both the energy producing guys, as well as the environmental
11 guys, to, you know, get funding for, you know, digging up a
12 bad pipe --

13 MR. ZWONITZER: Right.

14 PRESIDENT BIDEN: -- or, you know, connectors and
15 all that.

16 And then I -- the Delaware River project was all
17 about deepening the Delaware River with a corps of
18 engineers. I was fighting to get money for that. So I
19 called Carper, Coons, Carney (phonetic), Senator Casey, and
20 Bill -- Bob Brady, the congressman.

21 MR. ZWONITZER: Um-hum.

22 PRESIDENT BIDEN: And I had to call Eliot Engel in
23 the Foreign Relations Committee who was fighting the Iran
24 deal to try to, you know, reign him in, which I was able to
25 do. And I had to talk about Carper supporting the Iran --

2 PRESIDENT BIDEN: -- deal and help. We got --
3 plus Carper was very engaged in helping me get funding for
4 Central American and the Northern Triangle.

5 MR. ZWONITZER: Right.

6 PRESIDENT BIDEN: So I talked to him about that.

8 MR. ZWONITZER: Was this all literally in one --
9 in that one day?

10 PRESIDENT BIDEN: Yeah, yeah.

11 MR. ZWONITZER: My God.

12 PRESIDENT BIDEN: And I --

13 MR. ZWONITZER: Man.

14 PRESIDENT BIDEN: And then I -- we had a very
15 brief staff discussion about -- well, I called
16 President Anastasiades of Cyprus because -- inquiring about
17 his health. [REDACTED] (b) (6), (b) (7)(C) I think he was
18 still in the hospital here in New York. It came to an
19 operation.

20 And I talked about the University of Delaware
21 Biden Center, you know, and what my Senate legacy was going
22 to be as it related to Delaware.

23 MR. ZWONITZER: That was already happening?

24 PRESIDENT BIDEN: That was -- well, it was an
25 early discussion.

3 PRESIDENT BIDEN: But I think it was already
4 happening.

5 And then the non-, the non-, the non-classified
6 part of what -- part of my discussion with POTUS that day

9 stickers that people would be getting spontaneously to, you
10 know --

11 MR. ZWONITZER: And he had seen those?

12 PRESIDENT BIDEN: He had, he had raised them. I
13 don't know whether he saw them or not, but he knew there was
14 a spontaneous effort --

15 MR. ZWONITZER: So -- right.

16 PRESIDENT BIDEN: -- to try to draft Joe Biden.
17 And, and we -- so we -- and then POTUS was talking about you
18 got to avoid the -- I can't remember what he meant by it.
19 Avoid the Mitt Romney, John Kerry situation, which is where
20 they got -- I assume he means they got pulled into start
21 earlier than they --

22 MR. ZWONITZER: Um-hum.

23 PRESIDENT BIDEN: -- were supposed to. And he
24 said -- his comment to me was, I'm very protective of your
25 legacy and your image. So before you do anything in --

12 that. What are Republicans going to do? He talked about
13 the hypocrisy -- we both talked about the hypocrisy of the

18 his plans are for -- we're going to do the last year. He
19 wants to help the poor. He said, you know, I don't know if

22 reading.

23 We talked about the Central America strategy. He
24 really liked my op-ed that I did on Central America. He
25 said the situation-- we have to detail how you're going --

PRESIDENT BIDEN: -- to layout this is the Northern Triangle ([REDACTED] 0:14:42.0). I told him of the tentative plan for me to visit the Triangle before heading to Panama.

And Ash's confirmation. Ash Carter is -- this was Ash Carter's confirmation. We talked about that I guess for a minute.

MR. ZWONITZER: So can I ask you two things about that lunch? One is that when he said, I'm very protective of your legacy and your image and --

PRESIDENT BIDEN: He was worried that I would get into -- I think it was all about him trying to talk me into not running.

MR. ZWONITZER: Yeah.

PRESIDENT BIDEN: And he was worried that if I got started with this, this, this draft Biden thing, I let it get out of hand, couldn't go anywhere --

MR. ZWONITZER: ([REDACTED] 0:15:49.3).

PRESIDENT BIDEN: -- it would tarnish my image, tarnish my legacy.

MR. ZWONITZER: Um-hum.

PRESIDENT BIDEN: And so he wanted to make it clear that he was, quote, very protective of my legacy, very protective of my image. And so wait until you have more --

3 you can really win this thing.

8 actually get done, you know. Is it doable? And, and, and,

13 the time, or are you --

14 PRESIDENT BIDEN: That, that was my read at the
15 time.

16 MR. ZWONITZER: Okay.

17 PRESIDENT BIDEN: I mean, he probably, at some
18 point, said at a minimum it would be a really uphill battle.

19 MR. ZWONITZER: Right.

20 PRESIDENT BIDEN: And she's -- you know, she's
21 already really well, like, organized. So -- and then, you
22 know, a few days later, I have notes from a Ron Klain
23 meeting. Well, he, he said -- you know, Ron was pushing,
24 and he says that you really shouldn't decide -- you need,
25 you need a group to put together -- to hold the terrain --

3 develop a narrative as to, you know, how we're -- how I'm
4 going to decide. So the narrative you tell the press, you

8 is my decision process. And you, you need to explain the
9 decision criteria for people. Oh, and what you don't want

13 MR. ZWONITZER: Hamlet (phonetic).

14 PRESIDENT BIDEN: Yeah.

15 MR. ZWONITZER: Yeah.

16 PRESIDENT BIDEN: The, the Hamlet piece. You --
17 what you got to -- you got to say, here are the things that
18 I believe in. You got to make sure I'm always up and
19 positive. No burning desire to run. This is a personal
20 decision. I won't make it before May or June, just like
21 we've talked about. It's not like I have a burning desire
22 to run. And he said, you got to make it your choice. How,
23 how I'll make the choice, what will trigger the choice, and
24 when I'll make the choice.

25 Oh, he said it's my decision to run or not run.

2 PRESIDENT BIDEN: It doesn't have to do with the
3 field. I'm not out testing the message. Remember when she
4 was testing messages. Avoid the whole idea of looking like
5 you're testing.

8 the 17th.

10 MR. ZWONITZER: Well, I think we have that pretty

15 MR. ZWONITZER: So how, how did you bring Dilma
16 back in the, in the boat, so to speak?

17 PRESIDENT BIDEN: I really wooed her. And I spent
18 a lot of time talking to her, I spent a lot of time
19 convincing her that it was in U.S. interest to have a
20 relationship with them. She used the phrase at a press
21 conference that Vice President Biden is seductive.

22 MR. ZWONITZER: I, I remember you --

23 PRESIDENT BIDEN: You know, we're not married yet,
24 but he is seductive. I got her to believe that we weren't
25 deliberately, you know, trying to undermine her and we --

PRESIDENT BIDEN: -- weren't listening to all her conversations, and that she had to understand that it was, it was not in her interest at all to, to cut ties with us. And that -- I had talked to her about how I made a commitment of what we weren't going to be doing in the future in terms of dealing with her and her government.

And the bottom line is that she, she began this -- she said, okay, and she wasn't going to come to the United States. I worked out a ((b) (6), (b) (7)(C) 0:24:04.d) where she would be able to come and, and basically patched everything up between the two. But I just worked really hard.

MR. ZWONITZER: Yeah.

PRESIDENT BIDEN: I was honest with her, didn't in any way mislead her.

MR. ZWONITZER: How, how strongly did she register her anger with you?

PRESIDENT BIDEN: Very strongly. And she didn't trust anything America was doing, what -- you know, I said, you can trust me, I'll level with you. You -- and then I'd talk with her about tell me what your greatest political problems are. Maybe you can use me as an excuse to why you, you know, have to do what you have to do. I just went -- I had multiple, multiple phone calls with her. Went down and visited her. Talked about, you know, how we could work --

PRESIDENT BIDEN: -- together, how we could help.

So I just -- I mean, it took months, but I, I really, really worked the relationship on a personal basis.

MR. ZWONITZER: You -- was that -- was her visit here sort of the moment where you felt like it was put back together or --

MR. ZWONITZER: Yeah.

PRESIDENT BIDEN: I mean, that was -- she, she had refused to come and I had talked her into, to, to coming and have the equivalent of a state dinner and -- to show our respect for her, because she was getting the living hell beat out of her at home for dealing with this at all. You know, it was, like, cut-off relationships, et cetera.

MR. ZWONITZER: Didn't you have a -- like, a personal connection, like a -- somebody -- like a nephew or something that she had?

PRESIDENT BIDEN: No, but I paid a lot of attention to -- I'd have to go back and -- I'm sure I've got a lot of material on, on the Dilma relationship. I mean, there's a lot of stuff that I, that I did.

I, I'm sure I can get us a lot on that.

MR. ZWONITZER: Okay.

PRESIDENT BIDEN: And, and then -- and I was --

PRESIDENT BIDEN: And -- well, challenge the democratic critics of Hillary -- oh, that should be critics including Hillary. In other words, make the case for Obama. Look, make the case that basically says, I'll take the blame for every mistake we made as long as you give me all the credit too and we did a great job. Challenge democratic critics, including Hillary.

The other piece of that was we had decided, and Mike's idea was, and Ron was still loyal in those days, was, was to say -- because he came in to see me, and I took extensive notes. I don't know where the hell they are. The -- that Mike's idea was, look, this is what we've done and I'm proud of it. I'll take credit for it if you -- I'll take blame and credit. But this is what I'm going to do from here.
