Dear Judge Day,

I hope all is well. It was great to meet you yesterday, and as we talked about I wanted to set a time for a follow up meeting to discuss the cases my organization (the [National Jewish Advocacy Center](#)) has been bringing to expand the toolbox of ways in which we can fight antisemitism. In particular I think you might be interested in the Anti-Terror cases we have brought, as well as the FACE Act cases and the RICO action we are working on. (In fact, while we were there at the meeting yesterday, we got a ruling in one of those anti-terror cases [denying](#) their MTD).

I am in DC frequently and would be happy to come in whenever it works for you. In the meantime, I am attaching a few things in case background is helpful:

Complaints in:

Newman v. AP- we sued the Associated Press for buying photos from Hamas

Lavi v. UNRWA USA- we sued UNRWA USA for aiding and abetting Hamas

Haggai v. Kiswani- we sued Within Our Lifetime and other NY based groups, including Mahmoud Khalil's group CUAD, for material support for terror

Jan v. People's Media Project- we sued the Palestine Chronicle, a 501(c)(3) that was paying a Hamas operative to hold hostages

Gess v. BAM Trading Services- we sued Binance, the largest cryptocurrency exchange, for sending remittances to FTO's. This is a great example of how DOJ coordination helps; we cite tons of the discovery DOJ got in the criminal case.

Parizer v. AMP- we sued National Students for Justice in Palestine and their parent organization for being the PR agents of Hamas. I am also attaching an amicus brief from 20+ State AGs in support.

SCLJ v. CodePink- our FACE Act case in LA, protecting synagogues from violent protests/pogroms.

To the extent it is helpful I am also attaching some recent media I have done on these cases in which I brought the receipts on TV to show everyone what material support really looks like:

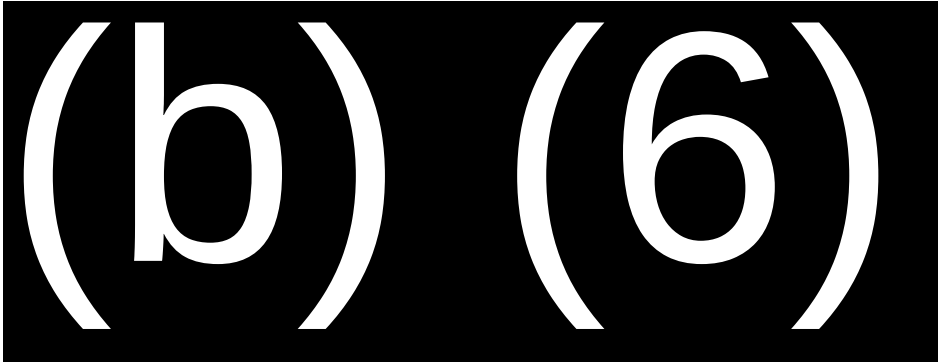
