## **PROBABLE CAUSE STATEMENT**

On April 29, 2018, Border Patrol Agent J. Lara was performing assigned duties in the Imperial Beach Border Patrol Station's area of responsibility. Agent Lara was wearing an agency issues rough duty uniform. At approximately 10:40 PM, infrared scope operator, Border Patrol Agent L. Massinburge, informed Agent Lara that he had observed one individual walking north down a draw towards a place known to Border Patrol agents as the "35 Draw." Guided by Agent Massinburge, Agent Lara responded and after a brief search, Agent Lara found one individual laying in the brush. This location is approximately four miles west of the San Ysidro, California, Port of Entry and approximately 300 yards north of the United States/Mexico International Boundary. Agent Lara conducted an immigration inspection. The subject, later identified as the defendant, Elvin Leonel GUTIERREZ-Flores, stated he is a citizen of Honduras, and was not in possession of any immigration documents that would allow him to enter or remain in the United States legally. At approximately 10:45 PM, Agent Lara placed GUTIERREZ under arrest.
