PROBABLE CAUSE STATEMENT

On April 29, 2018, Border Patrol Agent J. Hernandez was performing assigned duties in the Imperial Beach Border Patrol Station's area of responsibility. At approximately 10:40 PM, scope operator, Border Patrol Agent D. Mandagie, observed one individual walking north down a draw toward a place known to Border Patrol agents as the "Eucci Grove." Guided by Agent Mandagie, Agent Hernandez responded and after a brief search, Agent Hernandez found one individual attempting to hide in the surrounding brush. This area is approximately four miles west of the San Ysidro, California, Port of Entry and approximately 300 yards north of the United States/Mexico International Boundary. Agent Hernandez identified himself as a Border Patrol agent and conducted an immigration inspection. The individual, later identified as the defendant Obeniel VASQUEZ-Lopez, stated that he is a citizen of Guatemala without any immigration documents that would allow them to legally enter or remain in the United States. At approximately 10:50 PM, Agent Hernandez placed VASQUEZ under arrest. During administrative processing, VASQUEZ stated that he entered the United States on April 29, 2018.
