Workshop 1: Forum Cities Preventing Youth Violence Through Positive Behavioral Interventions & Supports (PBIS)
Roosevelt Room (Third Floor)

PBIS incorporates principles fundamental to the Forum, such as balancing prevention with intervention as well as reliance on evidence-based practices and data-based decision-making. The Department of Education (ED) has partnered with the Department of Justice to provide funding for 10 Forum cities to strengthen their capacity and sustainability to implement PBIS. Five Forum cities have also been awarded ED School Climate Transformation Grants (SCTGs). SCTGs are administered as part of the “Now Is the Time” White House initiative, which was launched in 2013, to protect children and families from gun violence, make schools safer, and expand access to mental health services. This session will describe the key features of PBIS as a multitiered system of supports and the potential benefit for reducing violence while contributing to positive school climate. Representatives from Detroit, Salinas/Monterey County, and Philadelphia will highlight their efforts and share lessons learned.

In late 2014 the U.S. Departments of Education (ED) and Justice (DOJ) released a Correctional Education Guidance Package to help states and local agencies strengthen the quality of education services provided to America’s estimated 60,000 young people in confinement every day. Overseeing a comprehensive violence prevention/community-building initiative raises unique and challenging issues not present when overseeing a single program. Without proper governance, a comprehensive strategy soon devolves into an unconnected collection of disparate programs. Included among the questions the panel will address: As those who manage the effort have no line authority over most of those engaged in a comprehensive effort, what is the source of (or the sources of) their authority?
