It was a further part and an object of the conspiracy that CHRISTOPHER WILSON, a/k/a "Eric Fields," JACK KAVNER, a/k/a "Bob Wiley," a/k/a "Phil Powers," and DANIEL QUIRK, a/k/a "Lou Epstein," a/k/a "Bill Huckabee," a/k/a "Josh Newman," the defendants, and others known and unknown, within the United States, in an offense involving and affecting interstate and foreign commerce, knowingly would and did engage and attempt to engage in monetary transactions in criminally derived property of a value

COUNT THREE

(Destruction, Alteration, or Falsification of Records in a Federal Investigation)

The Grand Jury further charges:

6. In or about March 2017, in the Southern District of New York and elsewhere, CHRISTOPHER WILSON, a/k/a "Eric Fields," the defendant, did knowingly alter, destroy, mutilate, conceal, cover up, falsify and make a false entry in a record, document, and tangible object with the intent to impede, obstruct, and influence the investigation and proper administration of a pending investigation by the Department of Homeland Security, a department and agency of the United States, to wit, WILSON destroyed and concealed records of a telemarketing company WILSON owned and operated after becoming aware that certain of WILSON's coconspirators were arrested by the Department of Homeland Security.

(Title 18, United States Code, Section 1519.)

FORFEITURE ALLEGATIONS

7. As the result of committing the offense alleged in Count One of this Superseding Indictment, CHRISTOPHER WILSON, a/k/a "Eric Fields," JACK KAVNER, a/k/a "Bob Wiley," a/k/a "Phil Powers," and DANIEL QUIRK, a/k/a "Lou Epstein," a/k/a "Bill

Huckabee," a/k/a "Josh Newman," the defendants, shall forfeit to the United States, pursuant to Title 18, United States Code, Section 981(a)(1)(C) and Title 28, United States Code, Section 2461(c), any and all property, real and personal, that constitutes or is derived from proceeds traceable to the commission of said offense, including but not limited to a sum of money in United States currency representing the amount of proceeds traceable to the commission of said offense.

8. As a result of committing the offense alleged in Count Two of this Superseding Indictment, CHRISTOPHER WILSON, a/k/a "Eric Fields," JACK KAVNER, a/k/a "Bob Wiley," a/k/a "Phil Powers," and DANIEL QUIRK, a/k/a "Lou Epstein," a/k/a "Bill Huckabee," a/k/a "Josh Newman," the defendants, shall forfeit to the United States, pursuant to Title 18, United States Code, Section 982(a)(1), any and all property, real and personal, involved in said offense, or any property traceable to such property, including but not limited to a sum of money in United States currency representing the amount of property involved in said offense.

SUBSTITUTE ASSET PROVISION

9. If any of the above-described forfeitable property, as a result of any act or omission of the defendants:

(a) cannot be located upon the exercise of due diligence;

(b) has been transferred or sold to, or deposited with, a third person;

(c) has been placed beyond the jurisdiction of the Court;

(d) has been substantially diminished in value; or

(e) has been commingled with other property

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p) and Title 28 United States Code, Section 2461(c), to seek forfeiture of any other property of the defendants up to the value of the above forfeitable property.
