

UNITED STATES OF AMERICA'S COMPLAINT FOR TEMPORARY RESTRAINING ORDER, PRELIMINARY AND PERMANENT INJUNCTION

(FILED UNDER TEMPORARY SEAL)

Plaintiff, the United States of America ("United States"), through the undersigned counsel, hereby sues EUGENE MAROTTA ("Marotta"), individually, and as an officer, director, or managing member of ART MASTERS, LLC, ART MASTERS, LLC ("Art Masters, LLC"), a Nevada corporation, also d/b/a PALM BEACH LIQUIDATION GALLERY, and WILLIAM CLUTTER ("Clutter"), individually, also d/b/a Edge Graphics (Marotta, Art Masters, LLC, and Clutter are collectively referred to herein as "Defendants"), and alleges as follows:

INTRODUCTION

- Since June 2016, and continuing to the present, Defendants Marotta,
 Clutter, and Art Masters LLC, have used the U.S. Mail to engage in a predatory mail
 fraud scheme impacting primarily the elderly and vulnerable.
- 2. As part of that scheme, Defendants have mailed thousands of solicitations to induce recipients to send payments to Defendants. These solicitations appear to be sent by a legitimate business entity and give the impression that they are personalized letters notifying recipients that they have won a large package of cash and prizes, generally worth at least \$350,000. The solicitations direct recipients to pay \$161.25 to claim their winnings.
- 3. In reality, the solicitations are nothing but form letters sent by a business with no legitimate operations. Victims receive no prize. Instead of the promised award, victims who send the Defendants the requested \$161.25, receive nothing at all or nearly worthless lists of publicly-advertised sweepstakes and ink-jet printed reproductions of an artwork.
- 4. Thousands of victims, mostly the elderly and vulnerable, suffer financial losses from the Defendants' fraudulent schemes. Since mid-2016 alone, Defendants have swindled victims out of over a million dollars.
- 5. The United States seeks to prevent continuing and substantial injury to the victims of fraud. It brings this action for a temporary restraining order, preliminary and permanent injunctions, and other equitable relief pursuant to 18 U.S.C. § 1345, in order to enjoin the ongoing commission of criminal mail fraud in violation of 18 U.S.C. §§ 1341 and 1349.

JURISDICTION AND VENUE

- 6. The Court has subject matter jurisdiction over this action pursuant to 18 U.S.C. § 1345 and 28 U.S.C. §§ 1331 and 1345.
 - 7. Venue lies in this district pursuant to 28 U.S.C. § 1391(b)(2).

PARTIES

- 8. Plaintiff is the United States of America.
- 9. Defendant Marotta is an officer, director, or managing member of Art Masters, LLC. Acting alone or in concert with others, he has formulated, directed, controlled, had the authority to control, or participated in the acts and practices set forth in this Complaint. Marotta resides in this district, and in connection with the matters alleged herein, transacts or has transacted business in this district and throughout the United States.
- 10. Defendant Art Masters, LLC, also doing business as Palm Beach Liquidation Gallery ("PBLG"), is a Nevada limited liability company registered with the State of Florida as a foreign limited liability company authorized to transact business in Florida. PBLG's principal office is located at 2881 E. Oakland Park Blvd., Suite 413, Fort Lauderdale, Florida. In connection with the matters alleged herein, PBLG transacts or has transacted business in this district and throughout the United States.
- 11. Defendant Clutter operates an unincorporated entity doing business as Edge Graphics. Acting alone or in concert with others, he has formulated, directed, controlled, had the authority to control, or participated in the acts and practices set forth in this Complaint. Clutter is a resident of Nevada. In connection with the matters

alleged herein, Clutter transacts or has transacted business in this district and throughout the United States.

12. In connection with the matters alleged herein, Marotta, Clutter, and PBLG, have caused fraudulent solicitations to be mailed to potential victim throughout the United States.

DEFENDANTS' ONGOING FRAUDULENT SCHEME

- 13. Since June 2016 and continuing to present, Defendants have engaged in a mail fraud scheme. Defendants have mailed nearly 150,000 fraudulent solicitations to potential victims across the country.
- 4. Defendants' solicitations—which are entitled "UNAWARDED CASH & PRIZE NOTIFICATION"—give the impression that they are personal letters informing recipients that have won a large package of cash and prizes, typically worth at least \$350,000. They direct recipients to return a "Shipping Authorization" as well as \$161.25, to claim their "Unawarded Cash/Prize Payout Compendium" as well as an "exclusive liquidation asset," which, as the solicitations explain, is available to them only because of their purported status as a "verified beneficiary." *See* Exhibit A.
- 15. Defendants' solicitations appear to come from a legitimate organization tasked with notifying prize winners. The solicitations are signed by PBLG's "Head Comptroller" and purportedly originate from the organization's "Office of the Registrar." The solicitations also indicate PBLG has an "Office of Compliance" and a "Certification Officer."

- 16. Defendants send their letters via certified mail, requiring recipients to sign for the letter, impressing both the legitimacy and importance of the communication.
- 17. Defendants' solicitations emphasize that the recipients have already been selected to receive the prize package. Above bolded text stating, "Office of Compliance- Scheduled for Distribution: \$350,000.00," the recipients' "Status" is listed as "CONFIRMED—Awaiting Signed Shipping Authorization." Other representations include:
 - This is your FINAL NOTICE to receive Unawarded Payout Compendium for over \$350,000.00 in GUARANTEED CASH/PRIZES.
 - Your selection as a VERIFIED BENEFICIARY is fully established and confirmed.
 - YOU ARE ELIGIBLE FOR AWARD ENTITLEMENTS
 - CASH & PRIZE SCHEDULED FOR DISTRIBUTION:
 \$350,000.00, RECIPIENT[:] [RECIPIENT'S NAME]
 - CASH ADVISORY AWARD, \$350,000.00, OFFICIALLY
 DOCUMENTED AND GUARANTEED"
- 18. To bolster the impression that recipients have won and will receive the prize package, Defendants' solicitations represent that recipients have been specifically selected to receive the letter. The solicitations represent that the solicitations' promised wealth "is now being held in the name of [Recipient]." They also include file numbers, confirmation numbers, distribution numbers, and an "FFD Tracking Number."

19. The solicitations stress that an urgent response from the recipients is required:

The deadline is 7 days from receipt of this notice.

We must receive your reply or your shipment number 118807865 will be CANCELLED. Your authorization is not valid without delivery status authorization label affixed. Do not delay.

- 20. An all caps, block text disclaimer is located on the back of the solicitation. Sandwiched between an explanation of what the "liquidation asset" is—a "signed giclée valued at \$500"—and the company's return check and refund policy, is language explaining that with the purchase of the "liquidation asset," recipients will receive "an independent information report with over \$350,000.00 in case and prize opportunities" This vague language purportedly advises that the "Compendium" described by the front of the solicitation is nothing more than information about publicly-available sweepstakes. This disclaimer does not counteract the solicitations' overall impression that the recipients will receive thousands in cash and prizes if they pay the processing fee.
- 21. The solicitation packets contain a "Shipping Authorization" and pre-addressed return envelopes. The "Shipping Authorization" states that the "Over \$350,000.00 Unawarded Cash/Prize Payout Compendium" is free, but the recipients are required to pay PBLG \$161.25 for the "exclusive liquidation asset." Recipients are not given the option to forgo the "liquidation asset," and receive the "Over \$350,000.00 Unawarded Cash/Prize Payout Compendium" without paying PBLG \$161.25.
- 22. Recipients are directed to fill out the authorization and return it to PBLG's Fort Lauderdale Post Office Box along with the \$161.25.

- 23. Defendants' personalized, urgent solicitations lead victims to believe they have won a substantial prize package and are required to pay the fee to receive it.
- 24. Victims who pay PBLG \$161.25 do not receive a prize. Some victims receive nothing at all. Others receive a brown mailing tube containing an ink-jet printed reproduction of an obscure piece of art (the "liquidation asset") and a "Certificate of Authenticity." Victims also receive what the solicitations refer to as the "Compendium" or "independent information report," a list with information regarding publicly-advertised sweepstakes and a login to an email account set up in the victims' names containing additional sweepstakes information. *See* Exhibit B.
- 25. Marotta and Clutter share operational responsibilities for PBLG's mailings. For instance, both Marotta and Clutter handle the scheme's finances. Clutter sends Marotta purchase orders and check requests. Marotta writes the checks and forwards copies of certain checks to Clutter.
- 26. Both Marotta and Clutter share responsibility for processing and tracking victim returns, as well as sending victims fulfilment items, *i.e.*, the art reproduction and the sweepstakes information. Marotta retrieves the victim responses from the P.O. Box and logs them. He also sends Clutter a daily email detailing which recipients responded and how they paid. Clutter processes that information and provides Marotta labels to be used to send art reproduction and sweepstakes reports to victims.
- 27. Since the Defendants began mailing their fraudulent solicitations in June 2016, they have received approximately 6,2000 victim payments, totaling over one million dollars.

DEFENDANTS' PARTICIPATION IN OTHER MAIL FRAUD SCHEMES

- 28. Both Marotta and Clutter previously operated other fraudulent mailing schemes. Both also currently facilitate other mass mailing schemes similar to the one described here.
- 29. Marotta previously operated at least one other mass mailing fraud scheme. From approximately 2009 to 2016, Marotta operated 3 Rivers Services, LLC, which also mailed fraudulent solicitations. One such solicitation purported to come from psychic "Evelyn Welsh" and promised recipients at least \$1,056,877.25 in wealth if they mailed "Evelyn Welsh" a fee of \$20. Although the solicitations stated they were sent due to Ms. Welsh having personal visions about the recipients, in reality the solicitations were sent to particular individuals because their names were included on rented lead lists.
- 30. Clutter previously owned and operated Creative Data Management LLC, which did business as Sentry Armored Dispatch and Sentry Armored Dispatch Company, from approximately June 2012 until May 2014. Using those company names, Clutter mailed solicitations giving the impression that recipients had won an \$898,899 prize, but needed to pay \$20 to receive the winnings. In 2014, these solicitations gave rise to an investigation by the Florida Office of the Attorney General. As a result of that investigation, on May 20, 2014, Clutter, acting for himself and as an officer of Creative Data Management, signed an Assurance of Voluntary Compliance with the Florida Attorney General, agreeing to, among other things, "[c]ease making any representation that consumers have won a prize."

- 31. Clutter also owned and operated Celestial Happenings, LLC, which from approximately 2015 to 2016 mass mailed psychic solicitations requesting a \$20 fee. These solicitations purported to come from Ruby Corazon, who—according to the mass-mailed solicitations—had a "glimpse" into the recipients' futures. Although the solicitations stated that Ruby Corazon "first came across" the recipients' names "a short time ago," in fact, solicitations were mailed to particular individuals not because of Corazon's "wonderful vision[s] of wealth and happiness," but because their names were included on rented lead lists.
- 32. Marotta and Clutter also assist other mass-mailing schemes, including a mailer sending solicitations under names that include Prize Claim Information Center. They previously facilitated mailings for other mass mailing fraud schemes, including psychic solicitations mailed by Ocean Sun Corp.

DEFENDANTS' KNOWLEDGE OF FRAUD

- 33. Defendants have operated this mail fraud scheme for eighteen months and been involved in other fraudulent mass mailing operations for at least six years. Defendants know that the solicitations they send through the U.S. Mail are fraudulent.
- 34. Defendants know that the solicitations contain false and misleading statements designed to convince recipients that they have won a substantial prize and that they need to send money to claim that prize.
- 35. Defendants know that they do not provide the promised prize package to victims who send payments.
- 36. Defendants know that, contrary to the solicitations' representations, PBLG is not a robust corporation with multiple divisions and employees.

- 37. Defendants know that, contrary to the solicitations' representations, the solicitations are in no way personal, and recipients receive solicitations only because they were identified by a list broker or data analytics firm as likely to respond to Defendants' fraudulent solicitations. Defendants know that recipients are no more qualified or likely to win one of the sweepstakes listed in Defendants' report than the general populous.
- 38. Marotta and Clutter know that victims send in payments expecting a prize in returns.
- 39. Marotta receives voicemails and emails from victims asking why, even though they paid the fee and returned the shipping authorization, they have not received their prize. At times, victims also make notations on their payments to PBLG evidencing their belief that they have won a prize.
- 40. In July 2016, Marotta and Clutter were emailed a note from a victim expressing her confusion about what why she had not received a prize: "I sent a check for \$161.25. Could you tell me did I win, lose, or what happened. I never heard no more [] am I still in the running. Please let me know if possible what I really paid for."
- 41. Clutter also knows such solicitations are fraudulent because of the prior Florida Attorney General investigation for similar solicitations and the Assurance of Voluntary Compliance to which he and his company agreed.

HARM TO VICTIMS

42. Victims, especially elderly and vulnerable victims, suffer financial losses from the mail fraud schemes that Defendants perpetrate. Defendants have received approximately 6,200 victim responses to solicitations containing the representations

discussed above. Since June 2016, Defendants have grossed more than one million dollars.

43. Defendants' fraudulent scheme is ongoing. Absent injunctive relief by this Court, Defendants will continue to cause injury to recipients of these solicitations.

COUNT I (18 U.S.C. § 1345 – Injunctive Relief)

- 44. The United States realleges and incorporates by reference Paragraphs 1 through 43 of this Complaint as though fully set forth herein.
- 45. By reason of the conduct described herein, Defendants violated, are violating, and are about to violate 18 U.S.C. §§ 1341 and 1349 by executing schemes and artifices to defraud for obtaining money or property by means of false or fraudulent representations with the intent to defraud, and, in so doing, use the United States Mail.
- 46. Upon a showing that Defendants are committing or about to commit mail fraud, the United States is entitled, under 18 U.S.C. § 1345, to a temporary restraining order, a preliminary injunction, and a permanent injunction restraining all future fraudulent conduct and any other action that this Court deems just in order to prevent a continuing and substantial injury to the victims of fraud.
- 47. As a result of the foregoing, Defendants' conduct should be enjoined pursuant to 18 U.S.C. § 1345.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff United States of America requests of the Court the following relief:

A. That the Court issue an order, pursuant to 18 U.S.C. § 1345, pending a hearing and determination of the United States' application for a

preliminary injunction, that Defendants, their agents, officers and employees, and all other persons or entities in active concert or participation with them, are temporarily restrained from:

- i. committing mail fraud, as defined by 18 U.S.C. §§ 1341 and 1349;
- ii. using the United States mail, or causing others to use the United States mail, to distribute any advertisements, solicitations, or promotional materials:
 - (a) that represent, directly or indirectly, expressly or impliedly that the recipient has won, will win, or will receive cash, prizes or awards;
 - (b) that offer for sale of information regarding sweepstakes or lotteries;
 - (c) that represent, directly or indirectly, expressly or impliedly, that the recipient of the solicitation was specifically selected to receive the mailing based on a reason other than the fact that the recipient's name appears on a mailing list; or
- (d) that contain any other false or misleading representations;
 iii. receiving, handling, opening, or forwarding any mail that responds,
 by sending payment or otherwise, to materials described in subparagraph (ii)(a)-(d), supra;
- iv. selling, offering for sale, leasing, or offering for lease any lists of U.S. residents or mailing lists of any type compiled from U.S. residents

- who have responded to any of the materials described in subparagraph (ii)(a)-(d), *supra*, thereby causing such materials to be sent to U.S. residents;
- v. performing "caging services" on mail received from U.S. residents in response to any of the materials described in subparagraph (ii)(a)-(d), *supra*, including opening mail received from U.S. residents; entering or inputting data about U.S. residents into a database or forwarding such data; handling, forwarding, or depositing payments received from U.S. residents, including currency, bank checks, certified checks, money orders, or credit card charge authorizations; or handling or forwarding any mail received from U.S. residents;
- vi. destroying, deleting, removing or transferring any and all business, financial, accounting, and other records concerning Defendants' operations and the operations of any other corporate entity owned or controlled, in whole or in part, by Defendants.
- B. That the Court further order that, pursuant to 18 U.S.C. § 1345, within 2 days from Defendants' receipt of this Temporary Restraining Order and Order to Show Cause, Defendants shall provide copies of this Temporary Restraining Order and Order to Show Cause to all direct mailers, graphic artists/copyrighters, list brokers, printer/distributors, mailing houses, data managers, and/or caging services with which they do business regarding the materials described in subparagraph (ii)(a)-(d), supra, informing them that they are subject to the Temporary

Restraining Order as an entity in active concert or participation with Defendants, and within 7 days from Defendants' receipt of this Temporary Restraining Order and Order to Show Cause, Defendants shall provide proof of such notice to the Court and the United States, including the name and addresses of the entities and/or individuals to whom the notice was sent, how the notice was sent, and when the notice was sent.

- C. That the Court further order that, pursuant to 18 U.S.C. § 1345, the United States Postal Service is authorized to detain:
 - i. all of Defendants' mail, addressed to any Post Office Box, which is responsive to any of the materials described in subparagraph (ii)(a)-(d), supra;
 - ii. any of the materials described in subparagraph (ii)(a)-(d), *supra*, and any substantially similar advertisements, solicitations, and promotional materials that are deposited into the United States mail by Defendants, their agents, officers, or employees, or any other persons or entities in active concert or participation with them.
- D. That the Court issue a preliminary injunction on the same basis and to the same effect.
- E. That the Court issues a permanent injunction on the same basis and to the same effect.
- F. That the Court order such other and further relief as the Court shall deem just and proper.




