INDICTMENT

THE GRAND JURY CHARGES THAT:

COUNT ONE

(Possession of Controlled Substance with Intent to Distribute)

Between on or about April 25, 2015, and June 10, 2015, in the Western District of Missouri,

the defendant, JOSEF CUNNINGHAM, JR., a/k/a Carl Thomas, did knowingly and intentionally

possess with intent to distribute a mixture or substance containing a detectable amount of Oxycodone,

a Schedule II controlled substance, contrary to the provisions of Title 21, United States Code, Sections

841(a)(1) and (b)(1)(C).

(Obtaining a Controlled Substance by Fraud)

On or about April 25, 2015, at or near Smithville, Clay County, Missouri, within the Western District of Missouri, the defendant, JOSEF CUNNINGHAM, JR., a/k/a Carl Thomas, did knowingly and intentionally acquire and obtain possession of a controlled substance, that is, Oxycodone, by misrepresentation, fraud, forgery, deception and subterfuge, contrary to the provisions of Title 21, United States Code, Sections 843(a)(3) and (d)(1).

(Obtaining a Controlled Substance by Fraud)

On or about May 8, 2015, at or near Kansas City, Clay County, Missouri, within the Western District of Missouri, the defendant, JOSEF CUNNINGHAM, JR., a/k/a Carl Thomas, did knowingly and intentionally acquire and obtain possession of a controlled substance, that is, Codeine, by misrepresentation, fraud, forgery, deception and subterfuge, contrary to the provisions of Title 21, United States Code, Sections 843(a)(3) and (d)(1).

<u>COUNT FOUR</u> (Obtaining a Controlled Substance by Fraud)

On or about May 9, 2015, at or near Kansas City, Clay County, Missouri, within the Western District of Missouri, the defendant, JOSEF CUNNINGHAM, JR., a/k/a Carl Thomas, did knowingly and intentionally acquire and obtain possession of a controlled substance, that is, Oxycodone, by misrepresentation, fraud, forgery, deception and subterfuge, contrary to the provisions of Title 21, United States Code, Sections 843(a)(3) and (d)(1).

<u>COUNT FIVE</u> (Obtaining a Controlled Substance by Fraud)

On or about May 12, 2015, at or near Smithville, Clay County, Missouri, within the Western District of Missouri, the defendant, JOSEF CUNNINGHAM, JR., a/k/a Carl Thomas, did

knowingly and intentionally acquire and obtain possession of a controlled substance, that is, Oxycodone, by misrepresentation, fraud, forgery, deception and subterfuge, contrary to the provisions of Title 21, United States Code, Sections 843(a)(3) and (d)(1).

<u>COUNT SIX</u> (Obtaining a Controlled Substance by Fraud)

On or about May 20, 2015, at or near Kansas City, Clay County, Missouri, within the Western District of Missouri, the defendant, JOSEF CUNNINGHAM, JR., a/k/a Carl Thomas, did knowingly and intentionally acquire and obtain possession of a controlled substance, that is, Oxycodone, by misrepresentation, fraud, forgery, deception and subterfuge, contrary to the provisions of Title 21, United States Code, Sections 843(a)(3) and (d)(1).
