Dana 02. 10. 1993. godine oko 08,00 sati prilikom smjene na položajima na brdu Kvanj, grupa brigadnih izvidnika muslimanske nacionalnosti, koji su prethodne noći bili na položajima, ubili su dvojicu pripadnika 1. brigade HVO "Knez Domagoj". To su Martin Marković i Ivica Bunoza, a Nedjeljka Pehara, pomoćnika za obavještajne poslove II bojne su zarobili i odveli, dok su Roberta Repca zapovjednika voda brigadnih izvidnika pustili.

U svezi navedenog obavljen je razgovor sa Repcem, koji nam je tom prilikom rekao da je pomenutog jutro zajedno s Markovićem, Bunovcem i Preharom otišao na Kvanj kako bi zamijenili na položajima grupu koja je prethodne večeri držala stražu i koju su sačinjavali:

1. Mirzo Kudra
2. Jasmin Turajlić "zv." "Vipača"
3. Džemal Turajlić "zv." "Džeki"
- 4. Amer Kudra "zv." "Štronci"
5. Samir Tucaković "zv." "Sadat"
6. Esad Razić "zv." "Brico"
7. Edin Sakač.

Rebac dalje kaže da je Bunoza čim je došao upitao: "da li ima što za jesti" da bi potom on i Marković Prešli iz Repčeva u Eminov auto, dok je Pehar ostao u autu gdje je i zaspao. Neposredno iza toga iz Esina auta izašli su Muslimani i krenuli putem prema grudobranu bunkera, a poslije 5-6 minuta vraća se Mirzo do Bunoze i Markovića, nešto razgovaraju, ~~poslije oni izlaze iz auta i idu ispred Mirza~~ poslije oni izlaze iz auta i idu ispred Mirza zalaze iza vrh brda prema grudobranu od tenka. Nakon 10-tak minuta čuju se pucnji iz 3-4 puške u isto vrijeme, tada "Kobac" ustaje iz auta oblači jaknu i kreće prema mjestu odakle su se čuli pucnji. Tada mu prilazi Mirzo s riječima: "odi da vidiš nešto" i tada je primjetio Bunozu kako leži na putu glavom savijenom u blatu nakon čega se okrenuo Mirzi koji je istovremeno rekao "ne pokušavaj ništa - ubit ću te, stavi ruke na potiljak i hajde ispred mene" a tada je primjetio i drugog mrtvog tj. Markovića da bi silazeći kraj njih dvojice vidio "Sadata" na zemlji kako se drži za ruku i previja. Sjeli su Repca na zemlju, prišao je Eso sa već pripremljenom žicom i svezali su mu ruke na leđa. Pri molbi da popusti malo žicu Eso je odgovorio: "neka te tako", da bi zatim "Štronci" kroz šumu otišao i zarobio Pehara na spavanju. Poslije njega prema Peharu je otišao i Mirzo, a kada se vratio nakon 10-tak minuta rekao je: "šta si se prepao, zar si mislio da ću te ubiti, bolje da se ovako završilo nego da sam =popušio= rađal s leđa." U Blagaju će me možda ubiti a možda i neće, ustaj se i hajde ispred mene." Kod auta ga je odvezao i pušao s tim da je rekao: "kada prebace naše familije u Blagaj, Pehar će biti pušten uz molbu da pričeka pola sata dok se oni ne spuste u Malo Polje. Pošto je bio pušten, Rebac je upalio auto okrenuo se i otišao na Rotimlju bez zaustavljanja. Posljednje je vidio Mirzu, Amera, Samira i Esu.

Nakon Repčeva odlaska odvezli su 2 auta (Fiata) oko 300 m naniže a zastavu 128 su minirali.



Osobe koje su učestvovala u zločinu:

1. Mirzo Kudra sin Mithada, rođen 21.02.1968 godine u Čapljini. Od izbijanja rata učestvovao u HV a od 01.07.1992. godine stupio u brigadu, na početku bio u izvidničko-diverzantskom vođu a poslije u izvidnicima učestvovao u svim akcijama prema četnicima i MOS-u da bi 02.08.1992. bio ranjen. Isticao se u ubijanju, paljenju i rušenju srpskih i muslimanskih objekata. Ubio je Zorana Nikolića iz Čapljine i bacio ga u Neretvu. Zajedno sa Samirom ubio Mirka Ijačića, također sa Samirom iskasapili Miloša Muratovića, ubio Dušanku i Nikolu Kuzman, ubio Slavojku Elezović. Od Muslimana ubio na Pijescima brata Izvršio je 4 silovanja nad Muslimankama.
2. Amer Kudra, sin Envera rođen 02.11.1971. godine u Tasovčićima. Od prvog dana u postrojbama HVO. Pljačkao je muslimanske i srpske objekte.
3. Esad Razić, sin Vejsila, rođen 02.11.1966. godine u Tasovčićima. Od prvog dana je u postrojbama HVO. Pljačkao....
4. Samir Tucaković zv. "Sadat" sin Ahmeta, rođen 14.10.1973. godine u Mostaru. Najprije je bio u HOS-u u Dretelju a od 01.07.1992. godine u HVO. Najposposobniji je od svih. Ubio je vojake Markovića i Bunoza. Njegova je obitelj bila u Tasovčićima za vrijeme četnika. Učestvovao je u silovanju SINANE ? Učestvovao je u ubistvu Dušanke i Nikole Kuzman, sa Mirzom učestvovao u ubistvu Zorana Nikolića, Mirka Ijačića i Milpša Muratovića.
5. Jasmin Turajlić zv. "Vipača" sin Adema, rođen 10.05.1974. godine u Čapljini. Bio je u HOS-u u Dretelju a od 02.07.1992. godine u HVO-u. Ubio Muslimanku na B.Brdu i zapalio tako da se nije mogao utvrditi identitet. Ubio Ramiza Đonku i još jednog nepoznatog Muslimana i teško ranio Đonku zv. "maca" koji je trenutno u zatvoru u Gabeli. Ubio dvije Hasića cure a jednu teško ranio....
6. Dževad Turajlić zv. "Džeki" sin Adema, rođen 24.03.1971. godine u Čapljini. Od prvog dana u HVO-u. Istupio 06.07.1993. godine. Pljačkao.
7. Edo Sakoč sin Mehe, rođen 07.03.1959. godine u Stocu. Od prvog dana u HVO-u. Ubio Omera Turajlića. Učestvovao u ubistvu 2 babe (muslimanke) Čučak u Hotnju i zapalio ih.....

Pomenuta grupa izvršavala je sve postavljene zadatke i onda kada nitko drugi nije htio da ih prihvati. Po našem mišljenju nisu bili u vezi s "armijašima" iz Blagaja, jer su 2 sata prije izvršenja zločina poslali prethodnicu u Blagaj ("Vipača" i "Džeki") kako bi najavili dolazak ostalih.

Po našim operativnim saznanjima na ovaj čin su se odlučili iz razloga nesigurnosti opstanka na našim prostorima, svakodnevnim prijetnjama zatvorom pojedinaca, kao i ubistvima, a iznad svega hapšenjem preostalih Muslimana koje je ovih dana privodila civilna policija i pri tome ne uvažavajući potvrde koje su im garantirale opstanak i sigurnost na našim prostorima, a koje su dobili od za to nadležnih organa.

Presudni momenat za ovakvu odluku bio je dolazak Amera Kudre na položaj u večernjim satima kada im je saopćio da su im obitelji zatočene. Također, po našim saznanjima planirali su zarobiti veći broj naših vojaka kako bi ih mijenjali za svoje obitelji, te su imali namjeru zarobiti tenk T-55, koji je igrom slučaja prethodno veče bio povučen s položaja.

Tenk im je trebao poslužiti za oprost grijeha kod MOS-a zbog zločina koje su počinili prema "svojima".



Zagonetni popis večer prije ???!

Operativni djelatnik u svom obilasku i istraživanju počinjenog zlodjela došao je i do nekih drugih saznanja, kao:

- Podatak da je večer prije ovih događaja, u kasnim satima od strane civilne policije vršen popis obitelji ovih vojaka koji su počinili zločin.

Napomena: Mirza Kudra je dva puta ponovio ove riječi: "Bolje da idem dolje, možda me i he ubiju, a ovamo me čeka rafal u leđa", Zašto?

Rebac je dalje naveo u iskazu da je taj isti Mirza svo vrijeme poslije toga događaja plakao i sve to govorio kroz plač.

Navodimo da bojna NEUM nije htjela davati ljude za položaje na Kvanju -pet (5) puta zaredom, kao i to da poginuli pripadnici nisu trebali biti na Kvanju, kao niti pomoćnik zapovjednika II bojne Nedjeljko Pehar.

OFFICIAL NOTE

On 02 October 1993 around 0800 hours, during the rotation on the Kvanj hill, a group of the brigade scouts of the Muslim nationality, who were on the position last night, killed two members of the HVO /Croatian Defence Council/ 1st brigade "Knez Domagoj". Those are Martin MARKOVIĆ and Ivica BUNOZA, they captured and took away Nedjeljko PEHAR, assistant for the intelligence work of the 2nd battalion and they released Robert REBAC, commander of the brigade scouts platoon.

In regard to the aforesaid, the interview was conducted with REBAC, who told us on that occasion that in the aforesaid morning he went to Kvanj with MARKOVIĆ, BUNOZA and PEHAR in order to replace the group that was keeping guards last night, whose members are:

1. Mirzo KUDRA
2. Jasmin TURAJLIĆ aka "Vipača"
3. Džemal TURAJLIĆ aka "Džeki"
4. Amer KUDRA aka "Štronci"
5. Samir TUCAKOVIĆ aka "Sadat"
6. Esad RAZIĆ aka "Brico"
7. Edin SAKAČ

Furthermore, REBAC says that as soon as they got there, BUNOZA asked: "Is there something to eat?" and after that MARKOVIĆ and him went from REBAC's car to Emin's car, and PEHAR stayed in the car where he fell asleep. Soon after that, the Muslims got out of Eso's car and they headed toward the parapet of the bunker, after 5-6 minutes Mirzo came to BUNOZA and MARKOVIĆ, they talked about something, later on they came out of the car and walked in front of Mirzo, they went behind the hill toward the parapet of the tank. After ten minutes shoots from 3-4 rifles were heard at the same time, then "Kobac" got out of the car, he put on his jacket and headed toward the place where the shoots came from. Then Mirzo approached him and said: "Come to see something" and then he noticed BUNOZA lying on the road with his head in the mud, after that he turned toward Mirzo, who said at the same time: "Don't try to do anything- I'll kill you, put your hands on your head and walk in front of me", he noticed the other one, i.e. MARKOVIĆ dead and "Sadat" on the ground holding his arm and writhing. They sat REBAC down to the ground, Eso came to him with already prepared wire and they tied his hands to his back. When he asked them to release the wire a little, Eso said: "Forget it" and then "Štronci" went through the woods and captured PEHAR while he was sleeping. After him, Mirzo also went toward PEHAR and when he came back after ten minutes he said: "What are you afraid of, did you think I was going to kill you, it's better for this to end up this way than to get a bullet in my back. Maybe they'll kill me in Blagaj, maybe they won't,

get up and walk in front of me.” He took him to the car and released him saying:” When they transfer our families to Blagaj, PEHAR will be released, with the request to wait for half an hour until they come down to Malo Polje.” After he got released, REBAC started the car, he turned around and went to Rotimlja without stopping. The last ones he saw were Mirzo, Amer, Samir and Eso.

After REBAC’s departure they drove two cars (Fiat) 300 meters down and they mined Zastava 128.

Persons who participated in the crime:

1. Mirzo KUDRA, son of Mithad, born on 21 February 1968 in Čapljina. Since the war broke out, he participated in the HV /Croatian Army/ and he joined the brigade on 01 July 1992, in the beginning he was in the reconnaissance- sabotage platoon and afterwards in the reconnaissance /as stated/, he participated in all the actions toward Chetniks and the MOS /Muslim Defence Forces/, on 02 August 1992 he was injured. He distinguished himself in killing, burning down and demolishing Serbian and Muslim facilities.
2. Amer KUDRA, son of Enver, born on 02 November 1971 in Tasovčići. In the HVO since the first day. He looted Muslim and Serbian facilities.
3. Esad RAZIĆ, son of Vejsil, born on 02 November 1966 in Tasovčići. In the HVO since the first day. He looted...
4. Samir TUCAKOVIĆ aka “Sadat”, son of Ahmet, born on 14 October 1973 in Mostar. At first he was in the HOS /Croatian Defence Forces/ in Dretelj and since 01 July 1992 he is in the HVO. He killed the soldiers MARKOVIĆ and BUNOZA. His family was in Tasovčići during the Chetnik /occupation?/. He participated in the rape of Sinana ?. He participated in the murder of Dušanka and Nikola KUZMAN, him and Mirzo participated in the murder of Zoran NIKOLIĆ, Mirko IJAČIĆ and Miloš MURATOVIĆ.
5. Jasmin TURAJLIĆ aka “Vipača”, son of Adem, born on 10 May 1974 in Čapljina. He was in the HOS in Dretelj and since 02 July 1992 he is in the HVO. He killed a Muslim woman in B. Brdo and he burned her /body?/ so that her identity could not be established. He killed Ramiz ĐONKO and another unknown Muslim and he severely injured ĐONKO aka “Maca”, who is currently in prison in Gabela. He killed two HASIĆ girls and he severely injured one...
6. Dževad TURAJLIĆ aka “Džeki”, son of Adem, born on 24 March 1971 in Čapljina. In the HVO since the first day. He left on 06 July 1992. He looted.
7. Edo SAKOČ, son of Meho, born on 07 March 1959 in Stolac. In the HVO since the first day. He killed Omer TURAJLIĆ. He participated in the murder of two old women (Muslims) ČUČAK in Hotonj and he burned them...

The aforementioned group had carried out all the assigned duties when no one else wanted to carry them out. In our opinion they were not related to the “army men” from Blagaj, because two hours before the crime was committed, they sent the advance guard in Blagaj (“Vipača” and Džeki”) in order to announce the arrival of the others.

According to our intelligence information, they decided to do this due to the insecure existence on our territories, daily threatening with imprisonment as well as with murder, and above all with the apprehension of the remaining Muslims, who were apprehended by the civil police these days and they did not take into consideration the certificates, which they got them from the authorities in charge, which grant them the existence and the safety on our territories.

The crucial moment for this decision was Amer KUDRA’s arrival to the position in the evening, when he informed them their families were captured. Also,

according to our information, they planned to capture a large number of our soldiers in order to exchange them for their families and they intended to capture the tank T-55, which was accidentally withdrawn from the position the evening before.

They were going to use the tank in order to get the forgiveness from the MOS for the crimes they committed against “their own men”.

Informer N.N.

The mysterious list the evening before???

During his inspection and investigation of the committed crime, the intelligence officer got a hold of other interesting information:

-The information that the night before these events, late in the night, the civil police listed the families of the soldiers who committed the crime.

Note: Mirza KUDRA repeated these words twice: “It’s better for me to go down there, maybe they won’t kill me and here I’ll get a burst in the back”, why?

Furthermore, in his statement REBAC said that Mirza cried all the time after this event and he said all this crying.

We mention that the battalion Neum did not want to send the men to the position on Kvanj five (5) times in a row and that the killed members and the assistant commander of the 2nd battalion Nedjeljko PEHAR were not supposed to be on Kvanj.
